# Six residents have applied to fill the "general public" seat, which carries a threeyear term.

The CPC is made up of Somerville residents who set the priorities for approximately \$2 million in Community Preservation Act (CPA) funds each year and recommend which projects should be funded to the City Council. A general public seat was opened on January 1, 2021 and Somerville residents are invited to share feedback on the applicants' qualifications. The successful candidate will have a three-year term running from March 1, 2021, through February 29, 2024, and will have the option to renew for a second three-year term. State law designates that committee members shall be appointed by the Mayor and approved by the City Council. To engage the community in selecting the most qualified applicant Mayor Joseph A. Curtatone has formed a review committee of community members and residents with expertise in related areas to review applicants, conduct interviews, and consider public feedback on candidates. The review committee considers both professional and lived experience and seeks to nominate a candidate that has experience in the construction industry/housing development and contributes to the diversity of background and perspectives of the CPC. From the group of applicants, the review committee will nominate a candidate for appointment for the Mayor to review, and the Mayor will submit the finalist candidate to the City Council for approval.

Thanks to all applicants for their interest and dedication to Somerville. Below are summaries of the applicants describing why they are qualified candidates for the CPC.

#### **Ellie Botshon**
