I. CALL TO ORDER

Chairman Mary Jo Rossetti called a Regular Meeting of the School Committee to order in the aldermanic chambers at 8:06 p.m., with a moment of silence and a salute to the flag of the United States of America.

II. ROLL CALL

Present were Ms. Cardoso, Ms. Harris, Ms. Bauer, Mr. Sullivan, Ms. Taylor, Mr. Murray, Ms. Rossetti, Mayor Gay and Alderman O'Donovan.

No one was absent.

III. AWARDS AND CITATIONS

V. STUDENT ADVISORY COUNCIL

Student representative Kim Carvalho reported on the following items this evening:

With only thirty two days left in their high school career, Ms. Carvalho reported the Seniors are now planning for their last Prom, Class Day, and Graduation.

Senior Class *Hat Day* will be on May 2, 2003 and *College T-Shirt Day*, where the Seniors wear T-Shirts displaying which College they will be attending next year, will be held on May 8th.

On Wednesday, April 30th, the National Honor Society Induction Ceremony will be held in the Auditorium at Somerville High School. Ms. Carvalho stated this is a special day for many members of the senior class and they are all looking forward to it.

Ms. Carvalho informed everyone that an exciting part of senior year is taking Psychology with Mrs. Kenney. This is when students receive an egg, which they carry around and cherish as their own son or daughter, for one week. Ms. Carvalho brought with her to this evening's meeting "Isabella". She talked about the project and how it teaches the students about the responsibility and development of a child.

Lastly, Ms. Carvalho congratulated the Juniors who were selected in the first drawing of the National Honor Society for the Class of 2004.

VI. REPORT OF SUPERINTENDENT

Dr. Argenziano reported on the following items:

- 1. Provided to members information from Mr. Roy Belson, Superintendent of Medford Public Schools, regarding an educational collaborative formed by five school districts, Somerville, Medford, Cambridge Rindge and Latin, Waltham and Northeast Regional, called Shore Occupational Learning and Vocational Educational Division (SOLVED). Dr. Argenziano explained that some of our high school students were requesting to attend Minuteman Vocational High School because Minuteman was focusing on specific areas that we did not offer. By forming the Collaborative (SOLVED) students will be interchanged amongst these five schools rather than sending students outside the district to Minuteman Vocational. Included in the letter from Mr. Belson was a listing of the programs offered by the Collaborative.
- 2. Informed members that Somerville Public Schools was the recipient of a Massachusetts Reading First Plan (MFRP) Grant and Dr. Argenziano wanted to publicly thank Ms. Susan Collins for preparing a successful Massachusetts Reading First grant proposal. The funds will go to the Powder House Community School.
- 3. Enclosed for members is a letter, petition and response to Unidos Parents. Next week, a letter, petition and response from Bilingual Parents will follow. A concern of the Parents was the waiver process under the implementation of Question 2. Dr. Argenziano let the parents know that the Unidos Programs is a specialized program initially chosen by parents and there will be no waiver process involved in the program unless the Department of Education directs the Superintendent to do so. Lengthy discussion followed regarding waivers and Dr. Argenziano responded to the questions asked by the committee. He did inform the members that after attending a March 27th Department of Education meeting, the school department

has a plan that will be given to members at the next meeting. The plan will include not only a sequential grade breakdown, but the support services and the target languages; it will also include budget information.

- 4. Provided to members was a memorandum received from Kate Ashton and Patrick McCormick, regarding E-Rate Year 6 FY 4 Submission.
- 5. Enclosed for members is an email from Don Kennedy, NESDEC, with a parent's comment, not included in the original packet, but Mr. Kennedy wanted to share it with the committee.
- 6. Mr. Robert Snow, Assistant Superintendent for Curriculum, Instruction and Assessment, recently met with the Library Media Department and enclosed for members is a list of priorities for the 2003-04 school year.
- 7. The MCAS retest schedule, Fall 2003, Winter 2004 is enclosed for members. Dr. Argenziano did inform members of an email received this morning from the Department of Education, that due to a pending snow storm, the tests that were scheduled for Tuesday and Wednesday of this week have been changed to Thursday, April 10th.
- 8. An email from Mayor Gay regarding "Somerville says Thank You" to residents and employees who are serving in Operation Iraqi Freedom is enclosed for members.
- 9. Provided to members is the Title I Newsletter, Spring 2003.
- 10. School council minutes for the Healey, West Somerville Neighborhood, and Cummings School are provided for members.
- 11. Enclosed is the Somerville Public Schools *Calendar of Events* for April 2003.
- 12. The District Report Cards are provided for members. The District report card is posted on our Somerville Public Schools website. The individual report cards of the individual schools will go home with the students in multi languages. Dr. Argenziano thanked Mr. Robert Snow, Assistant Superintendent for Curriculum, Instruction and Assessment, Ms. Marie B. Ferrari, Assistant Superintendent for Finance and Administration, Mr. Timothy Egan, Information Systems & Data Base Administrator, and the School Principals for putting this information in place.
- 13. Dr. Argenziano mentioned that eighty six Colleges and Universities were represented at the College Fair held last Wednesday, April 2nd. The Superintendent thanked Mr. Stephen O'Leary, Supervisor of Guidance and Testing, and his staff for coordinating the Fair.
- 14. Dr. Argenziano informed the committee that this past weekend there were two students from the Unidos Program that had a large fire in their home. If anyone would like to provide assistance to the family, please contact the school adjustment counselor, Ms. Louise Tillinghast, at x6360. There were no injuries but the family has lost everything; clothing and other items of necessity would be most welcome.

A. **Ed. Programs and Instruction Subcommittee:** (Ms. Bauer) Apr. 2

Subjects discussed:

✓ Library, Reading and Technology – discussion and review of services

Library Services:

Presentation by Ms. Patricia Garrity, Somerville High School Librarian with Ms. Alice Sajdera, Healey School Librarian

A brief review was given on the five-year plan, which was developed about a year ago, submitted to the Massachusetts Library Board and accepted with commendations. The plan provides eligibility for grants. The plan officially begins in September of 2003 but implementation has already begun. Books are being inventoried, weeded, and barcoded.

Reading Services:

Presentation by Ms. Yvonne E. Gunzburger, Supervisor of Reading

Ms. Gunzberger reported there was lots of activity in reading. The new series has been very successful and teachers report students are reading better than their counterparts of a year ago. Professional development sessions have been well attended and well received. This current year professional development is by grade, next year it will be by building. Reading teachers are trying to prepare for English immersion and more rapid transition from bilingual to regular education. The reading department is working towards increased integration of reading and writing.

Technology Services:

Presentation by Mr. Joseph A. Mastrocola, Coordinator of Instructional Technology

Mr. Mastrocola reported different schools are working on different projects and there are many pilot programs in the city. District-wide activities include:

- Purchasing software for simulation and higher order thinking, not drill
- Acceptable Use Policy for staff is drafted and awaiting approval
- Evaluation of technology curriculum
- Distance Learning used for professional development by five teachers

As a final note that evening, Mr. Mastrocola reported research shows that technology is most effective in helping at-risk students and special needs students. It does not replace good teaching in raising test scores.

Ms. Bauer informed the public that the next two Education Programs and Instruction Subcommittee meetings are scheduled for:

B. Finance and Facilities Committee of the Whole: (Ms. Murray) Apr. 7

Subjects discussed:

✓ Update on School Facilities

Ms. Murray reported on the school facilities update given by Mr. Robert A. Ciampi, Facilities Personnel & Property Services Director, regarding the work orders for the 2002–2003 school year. She briefly reviewed the three lists distributed to the committee. Presently, Mr. Ciampi presents an update to the members of the school committee, and then the information is given to the Principals. Ms. Murray reported one change in procedure that will take place is the school principals will receive the work orders first and then Mr. Ciampi will report back to the committee with an update with information from the principals on items that are being done.

✓ FY04 Budget Discussion

Ms. Murray reported that discussion on the FY04 budget was very brief, as the school department still has not been informed of a bottom line figure for the budget. More information regarding cuts will be coming from the State on April 23rd or April 24th. Hopefully, there will be more news to report after the April 28, 2003 Finance and Facilities Committee meeting.

Lastly, Ms. Murray discussed information received from Commissioner Driscoll, Department of Education, notifying the Superintendent of Schools that according to the School Building Assistance (SBA) program, Somerville is one of twenty eight worthy projects (the reconstruction of the Lincoln Park Community School) on the list for projects receiving preliminary approval. The deadline for submitting the paperwork has been extended to August 29, 2003.

Ms. Murray asked Mayor Gay if she and her staff would be able to complete the necessary process in order to meet the deadline. Lengthy discussion followed. Mayor

Gay and Dr. Argenziano responded to the many questions asked by school committee members and addressed any concerns they had.

Ms. Cardoso referred to an item discussed earlier in the evening at the Finance and Facilities Committee meeting. A request was made to have the Superintendent prepare an organization for the committee to review at the next Finance and Facilities Committee meeting. This list was to include positions and staff members. Ms. Cardoso stressed she is concerned about putting out an organization too soon. Lengthy discussion followed and members gave their input concerning this issue. Following the discussion, Ms. Cardoso asked Ms. Taylor to withdraw her request to have the Superintendent prepare an organization. Ms. Taylor agreed, withdrew her request and further discussion will take place at the April 28, 2003 Finance and Facilities Committee meeting.

VIII. UNFINISHED BUSINESS

A. Somerville Public Schools Organization

Following the lengthy discussion regarding the preparation of an organization, Dr. Argenziano asked the committee for clarification on whether or not the they would like him to prepare an organization to be presented at the April 28th Finance and Facilities Committee meeting. Ms. Cardoso responded that her recommendation was to wait, and Ms. Taylor did withdraw her request. Dr. Argenziano expressed his concern about putting an organization together for April 28th based on not having a bottom line figure to work with. Doing it this way, people are going to be unnecessarily hurt. The Mayor was clear she could not give us a figure this month, so until the Superintendent receives the bottom line budget figure, he cannot give the committee a realistic organization. Ms. Murray suggested that the committee plan to have further discussion during the next two Finance and Facilities Committee meetings leading up to the May 19, 2003 meeting, at which point the Superintendent will present an organization to the committee.
