INTRODUCTION

The City of Somerville's Department of Racial and Social Justice (RSJ) reached out to the Urban Peace Institute (UPI) for technical assistance to ensure safety priorities and solutions were community driven. Urban Peace Institute provided technical assistance by reviewing relevant data, including crime data, Massachusetts Department of Transportation data, City survey data, assisting with strategy development, and co-facilitating a series of working group meetings composed of community, youth, City partners, and law enforcement. The goals of this work were to collectively develop goals to prevent violence, increase community awareness and improve communication in

the City of Somerville. Through this memo, Urban Peace Institute will provide an analysis and make recommendations to address safety priorities while leveraging local assets to ultimately increase community safety. This project was supported and partially funded by Everytown Community Safety Fund.

Background

Urban Peace Institute creates community safety and dismantles harmful systems to transform justice and ensure freedom from violence. The organization works to end injustice, violence, and oppression of people who have been historically criminalized and

marginalized. By expanding evidence and place-based community violence interventions, building power, and assisting new regions, Urban Peace Institute advances solutions that lead to urban peace across the country.

Department of Racial and Social Justice

The Department of Racial and Social Justice leads the City of Somerville's equity efforts and collaborates with City departments, constituents, and stakeholders to eliminate the institutional and structural systems that create racial inequities, social disparities, and injustices.

Everytown Community Safety Fund

The Everytown Community Safety Fund supports 501(c)3 organizations implementing community-based violence intervention (CVI) programs operating in cities nationwide as a core component of a comprehensive approach to reducing gun violence in America. They deliver resources to help community-based violence intervention organizations sustain and scale their essential, lifesaving work via direct investment through grants, capacity-building training, peer convenings and advocacy campaigns. The Everytown Community Safety Fund has granted \$11.3 million to 119 organizations in 68 cities, each delivering a community-based model in preventing and interrupting violence.

METHODOLOGY

In March of 2023, RSJ and UPI met to discuss the scope of work and the timeline of the project.

In April 2023, UPI conducted data analysis on pre-existing quantitative data and provided a snapshot of the top five safety concerns. The Department of Racial and Social Justice identified three safety priority issues to focus on for this project which included: gun and gang violence, traffic violence, and domestic violence. The Department of Racial and Social Justice then established an Anti-Violence Working Group (AVWG) with diverse stakeholders and residents with the intention to collectively discuss and develop goals to address each safety priority. On May 25th, 2023, RSJ hosted an information session to introduce the AVWG members to UPI. Thereafter, RSJ and UPI co-facilitated the AVWG meetings virtually via zoom on a monthly basis from May 2023 through March 2024. Please see timeline/work plan in the Appendix.

The Anti-Violence Working Group developed Specific, Measurable, Attainable, Relevant and Time Bound (SMART) goals from the meeting discussions to generate community-based solutions with a structured approach. SMART goals were used because this strategy has been seen to successfully implement projects while helping to ensure all involved are held accountable, efforts are time bound, and progress that has been made towards accomplishing goals is tracked.² UPI recommended the use of SMART goals to address the specific safety needs of Somerville residents. For each AVWG meeting, the UPI team gathered feedback from AVWG members on each safety priority. UPI then drafted the SMART goal(s) which were reviewed and approved by the RSJ team. The SMART goals were then presented to the AVWG members for further edits and/or approval.

SAFETY PRIORITIES

Gun and Gang Violence

The first safety priority discussed with the AVWG was gun and gang violence. The Department of Racial and Social Justice shared Somerville Police Department (SPD) crime and violence data to provide a better understanding of this safety concern. The data reviewed included the recent upward trend of violent crime, particularly from 2021 (290) to 2022 (424) with an increase of 134 incidents. Data on the total gunshots fired from 2017 to 2023 showed an uptick in 2020 and 2021 with both years having 18 confirmed shots compared to 2019 with 11 confirmed shots fired.³ Additionally, the AVWG reviewed gunshot data by ward and pointed out that Wards 1 and 4 were

most affected by gun violence.⁴
Lastly, it was noted that there was a correlation between gun and gang violence and other reported crimes in Somerville such as aggravated assault and vandalism and destruction.

UPI composed a set of questions for the AVWG to better understand gun and gang violence dynamics as well as community assets and strengths. Some of the questions asked included: What type of gun and gang violence is happening? Who is causing the violence? Who is being impacted? Has anyone experienced

gun and gang violence in their community? Are there violence trends you're aware of (demographic, time of day, areas)? Who is trusted in the community to help and/or provide services? The AVWG discussed their perception of safety and community sentiment on gun and gang violence dynamics. When asked what a safe community looks like to them, an AVWG participant shared "Freedom, free going to places without violence." Based on their feedback and input, UPI highlighted the following four important themes.

AVWG members discussed SPD crime data and uplifted the need to allocate more attention and resources to Ward 4. AVWG members also discussed the landscape of Ward 4 and identified that access to highways near a large concentration of public housing allows for a fast route in and out of town for those committing acts of violence and crime and focuses the violence on those areas of public housing. The second theme that arose from group discussion with AVWG members was that youth are more likely to be involved with gun and gang violence. Recent and ongoing gun and gang violence incidents continue to involve youth from Somerville and youth from surrounding cities like Cambridge. While public programming and youth resources are acknowledged and are available to the community through the Mayor's Office Summer Job Program, recreation department and libraries, AVWG members agreed more youth engagement is needed. For instance, an AVWG member mentioned, "there are lots of resources, but we have to get the word out to all Somerville residents."

Another theme identified was the need for more allies to advocate for community safety. In particular, AVWG members mentioned a need for parents of young children to be more informed and involved in these efforts due to shooting incidents happening near local schools.⁶ Lastly, a lack of communication/information on crime and violence was uplifted. AVWG members expressed being uninformed as one Working Group member shared, "the information we get is by word of mouth." Another mentioned, "We receive calls/messages from the colleges or the schools, but not about violent incidents from the city." The feedback shared by the AVWG stressed the need for a stronger communication infrastructure and platform where all residents and stakeholders are able to receive current and timely information and updates on crime and violence.

Based on the data and AVWG feedback collected, UPI drafted two SMART goals for gun and gang violence. The first goal seeks to coordinate a multi-layered communication system to provide updates to all Somerville community members regarding gun and gang violence. The second goal focuses on engaging and connecting youth ages 18-26 with existing community programming in areas with highest issues of gun and gang violence. Below are the two draft SMART goals and details.

Goal #1: Coordinate a multi-layer communication system to provide updates to all Somerville community members regarding oun and gang violence.

Traffic Violence

The second safety priority discussed with the AVWG was traffic violence. Traffic violence was defined as car-related collisions, particularly when a pedestrian or cyclist is injured or killed. The Department of Racial Social Justice held a data primer meeting to share Massachusetts Department of Transportation data on the number of severe vehicular crashes, fatal vehicular crashes, bicycle crashes, and pedestrian crashes in Somerville. The data provided by RSJ from the Mobility Division of the Office of Strategic Planning and Community Development (Mobility) in Somerville as well as the MassDOT Impact Crash Portal illustrated a decrease in the number of severe vehicular crashes in Somerville from 2012 to 2022, yet a consistency of 1 fatal crash per year has occurred from 2019 to 2022. Additionally, it was highlighted that vehicular crashes that involved pedestrians had significantly decreased from 2012 to 2022, but in 2019 Somerville experienced a high number of crashes, with more than 50 reported pedestrian crashes. Lastly, the data showed that on average, Somerville experienced roughly 45 bicycle crashes per year. According to Mobility and the MassDOT portal, traffic-related crashes also appeared to occur on specific streets and near highways including

Broadway Street, College Avenue, Holland Street, Elm Street, Highland Avenue, Summer Street, Washington Street, Prospect Street, Webster Street, Temple Street, and state highways like Route 28 (McGrath), Route 38 (Mystic), Route 16 (Alewife Brook), and I-93.

UPI and RSJ co-facilitated a discussion with AVWG members to get insight on the traffic violence dynamics in their community. They were asked a series of questions which included: Are you aware of traffic violence in your community? Where is traffic violence happening? Who is causing traffic violence?

What are the impacts of traffic violence? The feedback collected raised two major themes. The first theme was the concern over excessive road construction contributing to reckless driving. For instance, an AVWG member stated, "the amount of construction is absurd," and often leads to commute times excessively longer for short drives and additional detours. Another AVWG member mentioned, "there's not one day where I don't encounter some kind of construction." As a result, drivers are often confused and ultimately create their own detour/path. For instance, an AVWG member shared, "there is a huge detour sign on Main and Broadway, but the detour is no longer in effect." Unfortunately, these self-made detours lead to cars driving on bike lanes, forcing cyclists on sidewalks which affects pedestrian safety. In addition to driver confusion, increased traffic delays also lead to restless drivers who become reckless behind the wheel. One AVWG member mentioned, "there are aggressive drivers, with lots of honking, they drive extremely fast, and they show impatience with people crossing the street." It was shared that reckless driving happened.

Domestic Violence

The last safety priority discussed with the AVWG was domestic violence. Prior to the meeting, UPI shared a survey via email to gauge the level of awareness on domestic violence issues in Somerville (please see survey in Appendix). The results showed that 60% of AVWG members were unsure of domestic violence issues happening in their community. As such, RSJ hosted a panel discussion for the AVWG with key partners working directly with domestic violence victims. The panelists included Rachel Angerhofer from RESPOND, Maureen Dipaolo, SPD (Victims Advocate Department), Captain Richard Lavey, SPD, and Sergeant Devin Schneider, SPD (Family Services Unit). Panelists discussed their roles, services, and shared different types of domestic violence as well as contributing factors such as mental health and substance abuse.

The panel discussion highlighted three major themes. First, certain groups such as roommates, intimate partners, children, and undocumented individuals¹⁰ were identified as the most vulnerable to domestic violence in Somerville. One panelist shared how these victims are often most vulnerable due to, "financial and emotional stress." In addition, undocumented individuals fear immigration repercussions. Another panelist shared, "many times the person committing domestic violence often threatens withholding citizenship documentation from the victim."

The second theme identified was the high level of distrust between the community and law enforcement. For instance, panelists shared that domestic violence is "grossly underreported,"

due to fear, stereotypes, and distrust with law enforcement. Domestic violence victims often lack trust with SPD due to prior negative experiences with law enforcement. One panelist noted that it can be a struggle to repair and build relationships with domestic violence victims. He noted, "Victims of domestic violence move around a lot so it's hard to build a relationship with them."

The last theme highlighted was the hesitancy of victims to seek services. A panelist mentioned that 'victims' trauma is one of the biggest barriers for victims accessing resources." Many times, victims bring trauma from their past negative interaction with law enforcement in their home country. Additionally, the fear of being at risk of

deportation or other immigration repercussions create a barrier for undocumented individuals to report incidents of domestic violence. The SPD also mentioned the barrier present because of the community's misconception that SPD forces residents to participate in resources/services available. An example of this is the residents' perception of being required to participate in domestic violence support classes and if they fail to do so may cause law enforcement to either not respond or provide help/support, when in fact all services are voluntary.

Domestic violence data was additionally shared with the AVWG to provide a comprehensive overview of the safety priority. Somerville Police Department data showed that although the number of domestic disturbances had a decreasing trend from 2017 to 2022, there was a fluctuation of domestic violence incidents, with an increase from 2017 to 2019, a significant drop in 2020 and an uptick in 2022 with a total of 167 incidents. Additionally, the ward with the highest number of total domestic violence incidents was Ward 4 with a total of 48 incidents in 2022, followed by Ward 1 with 46 incidents.

For the last safety priority of domestic violence, there were four SMART goals drafted to create a community-based solution. These goals aim to bring awareness to the issue of domestic violence and better connect victims and stakeholders to resources and services. There are various activities that include elements of research, coordination, and collaboration. Below are the details and layouts for each goal.

Goal #1: Identify ways to proactively educate the youth about domestic violence, healthy relationships, and boundaries.

RECOMMENDATIONS AND NEXT STEPS

Advocate for increased investment in community-based gun and gang violence, traffic violence, and domestic violence service providers.

- RSJ to share recommendations with the Mayor and City Council to gain buy-in. Engage City leaders and elected officials to increase investment in public safety and publicly adopt the AVWG SMART goals.
- Implement SMART goal activities with other City partners/departments. Create subcommittees per SMART goal as needed.

Implement a Violence Response System

- With departmental liaisons, implement communication protocol to better coordinate and deploy services based on issue/incident. Somerville departments to include in these conversations are Somerville Police Department, SomerStat, Communications, and 311 Constituent Services.
- Assess current communication protocols that are in place in Somerville to better coordinate and deploy services based on issue/incident.
- Research communication systems/platforms currently used by other national cities and departments.
- Strengthen relationship and protocols with other City departments, specifically, Somerville Police Department.
- Consider external systems (i.e., Everbridge Nixle, Citizen mobile application, etc.) to notify residents and stakeholders of violence incidents, upcoming road work, etc.
- Purchase the system that will be used by Somerville.
- Conduct pilot implementation to determine effectiveness and areas of improvement to ensure residents and stakeholders receive accurate and current information and updates.
- Train City departments to use the system.

Prioritize resources and services to Ward 1 and Ward 4

- Advocate for equitable distribution of resources and services amongst all wards and in particular Wards 1 and 4 who, based on the data, are disproportionately impacted by violence.
- Ensure resources and services are culturally competent and accessible. Relevant departments
 and directors should include Racial and Social Justice Department, Somerville Office of
 Immigrant Affairs, the ADA Coordinator, the Director of Equity and Excellence for Somerville
 Public Schools, and the Youth Services Director for the City of Somerville.
- Through a public education campaign, inform residents and stakeholders of domestic violence services and other resources available to increase awareness and accessibility.

A. Glossary of Terms

- **Communication System:** a set of protocols that guide communication between entities in a specific manner to obtain a desired outcome.
- Community Asset: qualities, characteristics, services, and/or resources of a community that can improve quality of life. Examples include neighborhood leadership, community cohesion, hospitals, churches, libraries, local parks, access to public transportation, sidewalks, etc.
- **Immigration:** the movement of people who are leaving one country to enter another country.
- Mental Health: a person's condition with regard to their psychological and emotional well-being.
- Public Housing: housing provided for people with low incomes, subsidized by public funds.
- **SMART Goal:** a goal that is developed with the following parameters to ensure that your objective is attainable within a certain amount of time. The acronym stands for specific, measurable, achievable, relevant, and time sensitive.
 - ° Short term goal: a goal that can be achieved within one to three months.
 - Mid-term goal: a goal that can be achieved within three to six months.
 - ° Long term goal: a goal that can be achieved within six months to a year or more.
- Stakeholder: an individual with a vested interest in the community because of living in and/or working that in community.
- Violence: a behavior involving physical force, intended to hurt, damage, or kill someone.
- Violence Response System: a roadmap that will be used by a safety committee/group to inform City budgets and City priorities that consist of SMART goals addressing gun/gang violence, traffic violence, and domestic violence.
