






Community Listening and Support


The Board should create more opportunities for the community to share about their interactions with the Somerville Police Department. The Board should seek input from citizens.



Alternative Dispute Resolution



The Board should also look for voluntary options to solve disagreements between community members and members of the police department.




Policy and Practice Improvement

The Board should do more than look at cases. The board should look toward trends in police operations and recommend improvements when they can.

Data Access and Transparency

The Board should have access to Somerville Police Department data. The board should share the information to keep the public informed as much as possible.



Accountability Backstopping



The local Board should have the power to investigate complaints and make recommendations on discipline when the Peace Officer Standards and Training Commission (POST), the statewide entity, refers a case back to Somerville or decides to not discipline.






Acceso a los datos y transparencia

Resolución alternativa de disputas




La Junta también debe buscar opciones voluntarias para resolver los desacuerdos entre los miembros de la comunidad y los miembros del departamento de policía.








Ouvidoria e Apoio à Comunidade


Resolução Alternativa de Discórdias

Acesso aos Dados e Transparência


O Conselho deve ter acesso aos dados do Departamento de Polícia de Somerville e compartilhar as informações para manter a população atualizada, o máximo possível.
