RESIDENTIAL EXEMPTION

Each year, at the option of the Mayor and City Council, an exemption of not more than 35% of the average assessed value of all residential parcels, may be applied to residential parcels that are the principal residence of the taxpayer as of January 1st, 2025. The intent of the exemption is to promote owner occupancy. This option is put in front of the Mayor and City Council for acceptance at the end of December. Before December 2025 the status of the Residential Exemption for fiscal year 2026 is unknown.

The assessor's office will accept applications for fiscal year 2026 from July 1, 2025, on.

The Residential Exemption is in addition to any other exemption that a taxpayer may be entitled. In no event, however, may any parcel of real estate be assessed for less than ten percent of the assessed value.

This Residential Exemption credit is applied to the third quarter tax bill.

Who can apply for FY 2026?

A taxpayer who owns and occupies residential property as their principal residence as of January 1, 2025, may apply for this exemption. An individual owner may qualify for a Residential Exemption on **ONE** parcel only.

A completed and signed application for Residential Exemption must be filed with the Assessor's Office by Tuesday April 1, 2026, 4:30 PM. You can find the application at the end of this document.

Required documentation:

An application for Residential Exemption will not be accepted without proper documentation to confirm your residency as of January 1, 2025, <u>you must submit</u>:

• 2024 STATE Income Tax Return (front page only with signature), (NOT FEDERAL). Please feel free to withhold your social security number and earnings. If you file an extension, please provide us with a copy of that request.

IN ADDITION to your STATE tax return, you must submit at least ONE of the following:

- Automobile registration showing your name at the address in question with an effective date prior to or covering 01/01/25. (Not applicable if you have a leased vehicle).
- Phone bill addressed to you at the property in question covering 01/01/25.
- Other utility bill, (gas, electric, or cable television) addressed to you at the property in question covering the period that includes 01/01/25. Note that utility bills must show the mailing address, not only where the service is provided. Water and property tax bills are not acceptable.
- Checking statement, (**not mortgage**) covering 01/01/25. Feel free to withhold financial information and account numbers.

Note: If you own or partially own ANY other residential real estate, you must submit a copy of the most recent actual property tax bill for the property.

The Board of Assessors reserves the right to request additional documentation. The documentation submitted is not open to public inspection.
