Since Spring 2023, Somerville Prevention & the Cambridge Public Health Department (CPHD) interviewed 65+ individuals in partnership with Fenway's Access Drug User Health, Somerville Homeless Coalition, and Bay Cove's First Step. The goal was to prioritize people who use drugs by asking questions about how to best allocate the funds in ways that work best for people who use drugs.

OVERDOSE PREVENTION TRAININGS



31 TRAININGS, REACHING 413 PARTICIPANTS SINCE 2022!



CPHD & Somerville Prevention continued to connect with community members to host overdose prevention trainings. Since July 1, 2023, we have conducted 12 trainings and reached 152 community members. Trainings are offered in-person as well as virtually to meet the needs of community members as much as possible! Standing virtual meetings are the first Tuesday of every month from 3p-4p via Zoom.

The City of Somerville, Somerville Public Schools, & Somerville Police Department partnered with John Snow, Inc. (JSI) to administer the 2022–2023 Middle School Student Health Survey in Spring 2023. Survey results were presented to the Somerville School Committee in December 2023.

Survey administration for both middle and high school students will now be on the same year while incorporating an off-year to do more in-depth analysis. In December 2023, we met with 43 Somerville youth from Somerville Positive Forces and Teen Empowerment to identify the top two topics to analyze. JSI will complete the analysis between January and June 2024, which will include recommendations for best practices to address.

The Somerville, Everett, Arlington, & Lexington (SEAL) MassCALL3 cluster are continuing their efforts to create equitable prevention programming through our strategic planning process. The cluster has received feedback from funders on our logic model, intervening variables, and proposed strategies. With support of Institute for Community Health (ICH), the cluster has finalized their work plan and evaluation plan and have submitted for final review. SEAL is looking forward to receiving feedback and transitioning to implementing proposed strategies in each of our respective communities.

ALTERNATIVES TO SUSPENSION










Somerville Prevention partnered with Somerville Public Schools to implement an alternative to suspension program. This program was created through feedback from youth and administrators to create a more supportive response to youth substance misuse in school settings rather than punitive. The current program offers two tiers of response. The first being a two-hour educational session on Monday mornings. The second being a four week after school group on Wednesdays.

Additionally, Somerville Prevention and SPS staff were trained in iDECIDE, an evidence-informed curriculum to support a more rehabilitative process to substance misuse in schools. It is currently being implemented in the middle schools and we are looking forward to bringing this to the high school soon!

LET'S TALK WORKSHOP










Somerville Prevention partnered with the Somerville Public Schools and the Somerville Family Learning Collaborative (SFLC) to host a Let's Talk workshop at Somerville High School on 12/6. The workshop aims at increasing caregiver capacity and skill to have proactive & productive conversations with youth about substance misuse.

It was provided in four languages including English, Spanish, Portuguese, & Haitian Creole with 10 attendees.

In October, SPF hired 26 SPF youth leaders. SPF aims to empower youth to reduce substance misuse among their peers along with related issues like stress and anxiety. We had a **record** number of youth apply for the SPF100 (high school) and SPFJr. (middle school) youth development programs this school year with over **100** applications.

In November, SPF youth launched their Annual Holiday Sticker Shock campaign partnering with 5 alcohol retailers to place over 2,000 stickers on paper bags with the message "It's illegal to provide alcohol to people under 21." SPF leaders love doing this annual awareness project!





Two fun facts: I'm left handed & I love to travel. I joined SPF because I wanted to make a change in my community and help assist in providing health information to everyone.




Two fun facts: I love to play sports & video games, and I would love to go to California. I joined SPF to help my community become aware of how substances can harm you.
