

# Terms and Conditions: Alpha-1 Foundation

By virtue of registering for the Virtual Alpha-1 Education Day, you hereby agree to these Terms & Conditions:

## 1. Rules for Registration

- a. **Registration:** You must register to use the virtual platform and the services provided by the Alpha-1 Foundation. As part of the registration process, you will select a password.
