ECONOMIC UPDATE

Tariffs, tariffs, tariffs! Love them or hate them, they are the hottest topic in stock markets right now. Early this month, the Trump administration issued tariffs on Mexico and Canada that had been postponed for a month to allow for further negotiations. Some exceptions were later granted for certain goods included in the U.S.-Mexico-Canada trade Agreement signed in 2020. As for the rest of the world, there has been uncertainty about what tariff policy will look like from one nation to another.

As a result, the S&P 500 has dipped below the 10% decline mark a couple times and is now considered a market correction. Bonds have been more of a mixed bag with slight declines in some categories and slight increases in others.

The next shoe to drop will be the announcement of details surrounding reciprocal tariffs on specific goods that will vary from country to country. In the days leading up to that we have experienced stock volatility as experts try to anticipate the policies and their impact on the economy.
