This email is going to everyone who has booked cabins for this amazing trip. It is a short and very specific update about an excursion at the **Denali Princess Wilderness Lodge**.

As a part of your Alaska trip, Princess has included the Natural History Tour (BTWN9-10A) on Friday, July 4, 2025, at no additional cost. You will see this when you log into Princess.com and select the Shore Excursion for this trip.



Princess offers an alternative excursion that you can select for the same day.

This excursion is called the **Tundra Wilderness Tour (TWT)** and it **can replace the excursion above**.

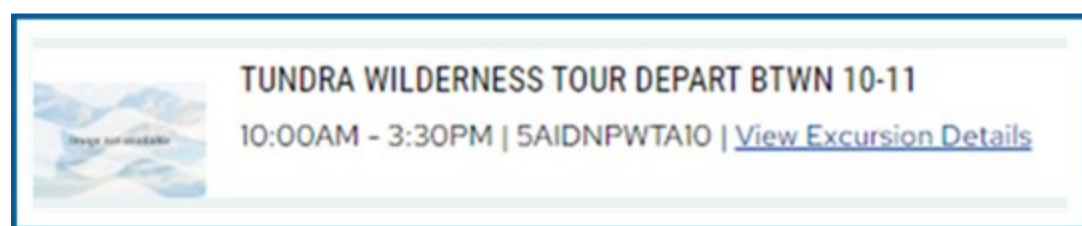

Here is what the Tundra Wilderness Tour offers:

- The Tundra Wilderness Tour goes further into Denali National Park, giving visitors the best opportunity to see the park's wildlife
- The Tundra Wilderness Tour is 30 minutes longer than the Natural History Tour, at about 5 to 5.5 hours long
- The cost to upgrade to the Tundra Wilderness Tour is \$35/person
- You can purchase box lunches at the lodge to take with you
- The Tundra Wilderness Tour has multiple morning departure times at 5, 6, 7, 8, 9, and 10 AM
- Afternoon departures leave starting at 1:30 PM, and returns around 7 PM

Many people in our group have chosen to upgrade to the Tundra Wilderness Tour. Elaine and Scott have selected this upgrade at the 10:00 AM departure time.

If you choose to upgrade, it will look like this on the Princess website:
