Options for Booking Flights

- Book on your own
 - Some people using frequent flyer miles
- Book through Princess with Princess EZair®
 - Benefit: Payment not needed until 90 days prior
 - Can book online at Princess.com or contact Jeff Rupert for help
- Beware of:
 - Overnight flights
 - Connections under 1 hour

 - Depart SJC at 7:03 am, Arrive SEA at 9:15 am
- 6/29: SEA to ANC, flight 189
 - Depart SEA at 1:49 pm, Arrive ANC at 4:25 pm
- 7/13: YVR to SEA, flight 2185
 - Depart YVR at 10:30 am, Arrive SEA at 11:37 am
- 7/13: SEA to SJC, flight 1046
 - Depart SEA at 3:08 pm, Arrive SJC at 5:17 pm

For People Arriving on June 30, 2025

- Arrive at the Anchorage airport
- Princess will provide transportation from the airport to the Captain Cook Hotel
(let Jeff know your flight info to pass on to Princess)
- No activities planned for this day as many people will be coming in late in the day

If Arriving Early, on June 29, 2025

- Arrive at the Anchorage airport
- Book your hotel. Many are staying at the Hyatt Place Anchorage Midtown.
- You need to provide your transportation from airport to the hotel, then on 6/30 from Hotel to Captain Cook
- Make your own arrangements for activities on June 30
 - Elaine and Scott are renting a car to drive an hour south to:
 - Byron Glacier (<https://www.youtube.com/watch?v=hsqKHBqsP1w>)
 - Alaska Wildlife Conservation Center
 - Alyeska Aerial Tram
 - Explore Anchorage near the hotel, ride the trolley

If Staying Until July 13, 2025

- Ship arrives at the Canada Place cruise terminal in Vancouver BC on July 12
- Princess provides transportation from cruise port to hotel
- Princess has booked many at the Westin Bayshore, Vancouver
