- Downloaded the Princess App on the mobile phone of each traveler
- Booked your flights
- Booked shore excursions at the lodges
- Booked shore excursions for Skagway, Juneau and Ketchikan
- Booked hotels if arriving early in Anchorage or staying late in Vancouver

You should have received your customized souvenir T-shirts and luggage tags for **The Ultimate Alaska Adventure**. Please make sure to try on your T-shirts to make sure they fit. - Complete the Travel Checklist on the Princess App
- Bring your passport
- Consider separate suitcases for the lodges and the ship
- Suits are optional for men
- Bring eye coverings for sleeping as there are only a few hours of darkness each night
- There are laundry facilities on the ship, so you can bring soap pods
- Bring a hat and gloves for the days when viewing glaciers
- Bring rain gear (umbrella or poncho)
- Scott and Jeff recommend travel insurance. See Jeff Ruppert if you have questions or would like to have his help purchasing it
