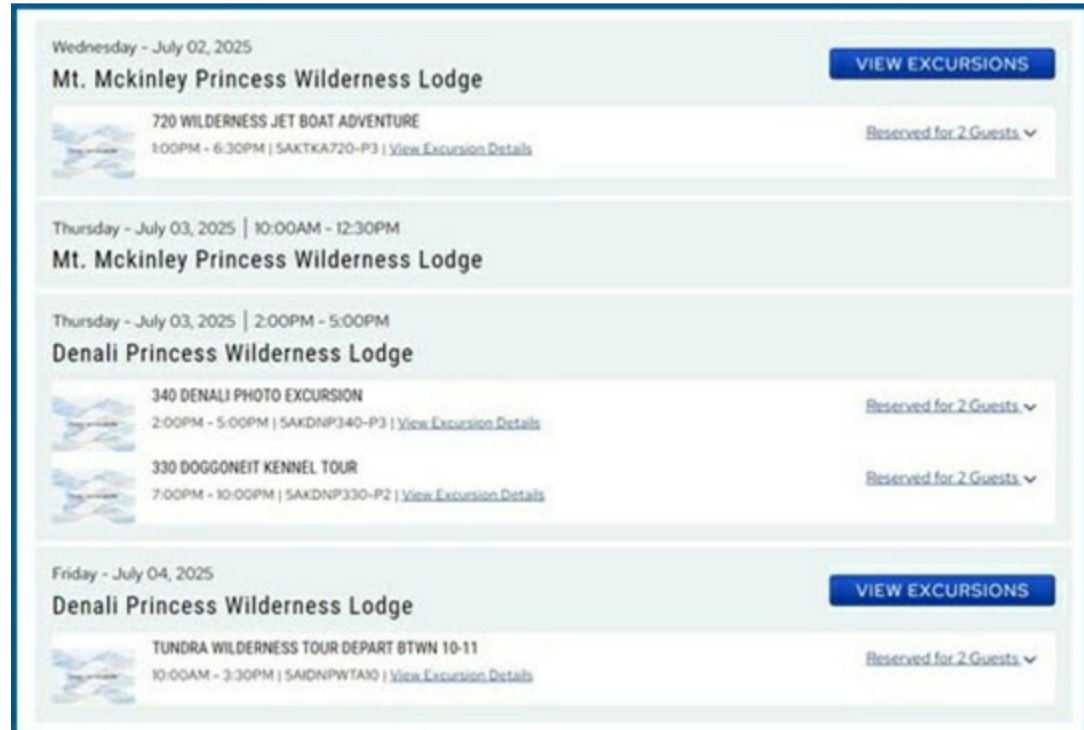
This email is being sent to all the people who booked this amazing trip. This is The Ultimate Alaska Adventure email update number 6.

The excursions for the McKinley Princess Wilderness Lodge and Denali Princess Wilderness Lodge are now available to book at Princess.com and on the Princess app. **We recommend you book your excursions ASAP**, before the popular excursions are full.

As a reminder, the schedule at the lodges is as follows:

- July 1, 2025 – 9 am to Noon, take the bus from Anchorage to the McKinley Princess Wilderness Lodge - the rest of the day is open
- July 2, 2025 – the day is open
- July 3, 2025 – 10 am to 12:30 pm, take the bus to the Denali Princess Wilderness Lodge - the remainder of the day is open
- July 4, 2025 – the day is open

There are a variety of excursions available to book at both lodges. If you are wondering what Elaine and Scott have chosen, here are our excursions.
