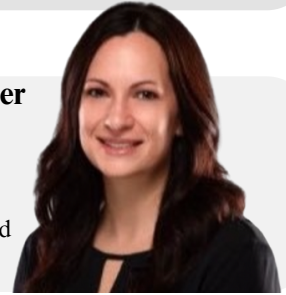


Vince Carbonaro, Licensed Assistant & Law Enforcement Liaison
