Item 2: Educational Background and Business Experience

Eduard Hamamjian, born in 1959, has an AAMS designation from the College of Financial Planning. An AAMS designation is a professional designation awarded by the College for Financial Planning to financial professionals who successfully complete a self-study program, pass an exam and agree to comply with a code of ethics. Successful applicants earn the right to use the AAMS designation with their names for two years. Every two years, AAMS professionals must complete 16 hours of continuing education and pay a fee to continue using the designation.

Since April 1996, Mr. Hamamjian has been a creator and portfolio manager of model portfolios. Since October 2009, Mr. Hamamjian has been the Portfolio Manager, Managing Member and Chief Compliance Officer of Alpha Dog Advisors, RUFF.

Prior to founding Alpha Dog Advisors, RUFF, Mr. Hamamjian founded Global Equity Advisors LLC and was a member from October 2005 until October 2009. Mr. Hamamjian has also formally trained with IDS/American Express and completed the mentoring program to become a financial planner in 1991. Mr. Hamamjian has also run a family business that has owned several restaurants, coffee shops and three franchised tax preparation offices since 1984.

Item 3: Disciplinary Information
