## Item 4 – Other Business Activities

Mr. Bringhurst is involved in the following investment-related activities:

- Licensed Insurance agent. In such capacity, Mr. Bringhurst may offer life insurance products, disability income coverage, long-term care insurance and health insurance. Normal and customary commissions are received from any purchases made by clients. The client is under no obligation to purchase these products through Ronald Bringhurst. In addition, he may receive trailing compensation from fixed life policies. The potential for receipt of commissions and other compensation gives Ronald Bringhurst an incentive to recommend insurance products based on the compensation received, rather than on the client's needs. To address

this conflict, disclosure is made to the client at the time purchases are made, identifying the nature of the transaction or relationship, the role to be played by Ronald Bringhurst, and any compensation (e.g., commissions, trails) to be paid by the client and/or received by the insurance agent.

Mr. Bringhurst is involved in the following non-investment related outside business activities that may provide a substantial amount of income and/or require a substantial amount of time during various parts of the year:

- Mr. Bringhurst is a managing member of Bringhurst Financial Services, LLC. The firm provides tax preparation and bookkeeping services for individuals and small businesses.

#### Item 5 – Additional Compensation
