**As a reminder, below are actions you should have completed at this point:**

- Created a login on Princess.com for each traveler
- Downloaded the Princess App on the mobile phone of each traveler
- Booked your flights
- Booked shore excursions at the lodges
- Booked shore excursions for Skagway, Juneau and Ketchikan
- Booked hotels if arriving early in Anchorage or staying late in Vancouver

**Final payments are due to Princess by April 1, 2025.** Please contact Jeff as soon as you can to give him approval to make your final payment. He has over 70 people to help and it's ideal to start working on it now. The fastest way to get in touch with Jeff is via email at: [jrupert@hmbcruises.com](mailto:jrupert@hmbcruises.com) with your approval if he has a valid credit card on file. If he does not have a valid credit card on file for you, then please give him a call at **650-245-9614**. Please remember he lives in the Eastern time zone.

For dining on the ship during the cruise part of the trip, most people have reserved the option to be able to reserve their own dining time each day. Dinner reservations for each night on the ship can be made after your final payment is complete. If you are at a table with other people, then **the final payment must be complete for everyone at your table before your entire group can reserve your dinner reservation**. You can make your reservations on the Princess App or by calling Princess Dining at 833-805-3463. You will need the booking number for each cabin in your group to make the reservation for your entire group.

**The remaining activities for everyone to complete are the following:**

- Complete final payments by April 1 by contacting Jeff Rupert
- Let Jeff know if you are coming early or staying late, and if yes, what hotels you have booked
- If you want to take the Princess shuttle from the Anchorage airport on June 30th to the Captain Cook Hotel, give Jeff your flight info if your flights are not booked on Princess EZ Air
- Make dinner reservations at the lodges if you want to eat at the sit-down restaurant, rather than the cafeteria
- Reserve time for dinner on the ship. Most of the group is booking 5:40pm in the Savoy Dining Room, if you want to join us
- Complete check-in on the Princess App and on Princess.com
- Print your luggage tags for the ship, available as early as 75 days before the cruise
- Scott and Jeff recommended travel insurance. Contact Jeff Rupert if you have questions or if you would like his help to purchase it
- We will send out an electronic disclosure using DocuSign and we ask that everyone sign it to acknowledge that you are traveling at your own discretion, that FJP and Jeff Rupert are not responsible nor liable for problems such as cancelled flights, if a ship misses a port stop, etc. Thank you for understanding

Our next and final planning webinar will be on **Tuesday, June 3, 2025, at 5 pm Pacific**. We hope you can join us to get the final list of details and suggestions to help you get the most out of your trip.
