Acceptance of promotion constitutes acceptance of the 2-year service remaining requirement from the effective date of promotion for Soldiers selected on a FY11 or earlier board, or a 3-year service remaining requirement from the effective date of promotion for Soldiers selected on a FY12 or later board. Soldiers with over 12 years AFS are required to reenlist for indefinite status if they do not have sufficient time remaining to meet this requirement, or decline promotion IAW AR 600-8-19, paragraphs 1-26 and 4-8. The authority for this promotion is AR 600-8-19, paragraph 4-7. Special Instructions: Soldiers promoted to Sergeant Major who do not have USASMC credit are promoted conditionally. Those Soldiers who receive a conditional promotion will be reduced and their names removed from the centralized list if they fail to meet the NCOES requirement.
