



## Pet Resort Policies & Requirements

### VACCINATIONS

For the health and safety of our boarders, canines must have current RABIES, DISTEMPER/PARVO, BORDETELLA and CANINE INFLUENZA vaccines and felines must have current RABIES and FVRCP vaccines. We recommend having a current FECAL TEST.

\*Only vaccinations performed by a veterinarian will be honored. If no proof of current vaccinations and/or fecal testing is available an exam and the required services will be performed during the patients stay and you will be responsible for the corresponding charges at time of pick-up.\*

### BELONGINGS & TREATS

\*Advanced Pet Care of Northern Nevada is not responsible for any lost or damaged personal belongings.\*

**Belongings** - We do not recommend leaving personal belongings with your pet(s) during their stay. Personal belongings can become soiled, damaged and/or lost. If your pet's belongings become soiled during their stay we cannot guarantee it will be returned in the same condition it was brought in.

**Treats** - There are certain treats we do not recommend giving pets such as treats that can fracture teeth or cause a foreign body. While we do understand keeping pets comfortable during their stay by giving them the comforts of home, if you choose to have such treats given during their stay you are stating that you understand the risks and release Advanced Pet Care from any and all liability.

**\*We do not have employees on site during our non-business hours of 5:30pm - 7:00am. Pets do not have direct supervision during these hours and will not be left with treats or toys during this time.\***

### ADDITIONAL STATEMENTS

**Sedation** - If sedation is necessary for treatment or handling of my pet(s), Advanced Pet Care of Northern Nevada has my permission to administer such medication.

**Stress Diarrhea** - Pets may end up having bouts of diarrhea during stressful times such as boarding and may need to have their diet altered and/or medication administered. You authorize the veterinarian on staff to treat as necessary if you cannot be reached within 24 hours. Any charges incurred from treatment will be due at time of pick-up.

**Separation of Multiple Pets** – If pets who are sharing a kennel are unable to remain together due to aggression or other such reasons, an additional boarding charge will be incurred.

### IN CASE OF EMERGENCY

- Although rare, if my pet(s) sustain an injury while on the premises, **I will not hold Advance Pet Care liable and will pay for treatments costs incurred upon pick up.**

If I cannot be reached I authorize the veterinarian on staff to make medical decisions on my behalf. I give authorization to treat as necessary and agree to pay costs associated with such treatments at time of pick up.
- Advanced Pet Care of Northern Nevada has permission in the event of an emergency, if a veterinarian is not on the premises or it is after hours, to transport my pet(s) to the Animal Emergency Center or Sierra Veterinary Specialists for treatment. It is my responsibility to pay for any charges incurred with these organizations.
