**Owners Agreement:**

1. I understand all board and/or training fees must be paid monthly in advance. Failure to comply or removal of horse without payment of any accrued balance shall constitute a breach of contract and an automatic lien on the horse in favor of Royal Arabians.: Horses will not be allowed to leave Royal Arabians's premises until balances including 3rd party vendors are paid in full. Royal Arabians requires a 15 days advance notice that a horse will be leaving. No refunds will be issued, a credit will be issued for any amount already paid and not used.
2. I agree that before removing horse (s) from Royal Arabians payment must be made in full by cash, cashier's check or credit card.
3. This horse, to the best of my knowledge, has not been exposed to any contagious or infectious disease for two weeks prior to arrival at Royal Arabians.
4. I hereby consent to any medical treatment for my horse deemed advisable in any emergency.

5. I consent to any medical treatment (ie. deworming, vaccinations, coggins, etc.) deemed advisable by Royal Arabians or their veterinarian for my horse. In the event that any medical treatment is deemed advisable outside routine medical care Royal Arabians or their veterinarian I understand that every effort will be taken to contact me for permission prior to treatment. I understand I will be responsible for paying these charges.
6. Every precaution is taken to protect the horse from illness, accident, fire or theft. Royal Arabians and/or its agents and/or employees shall not be held liable for any loss or injury from illness, accident, fire, or theft, here at the farm, during hauling to or from an event (show exhibition, etc.) or at any event (show, exhibition, etc.).
7. I understand that any show fees, shoeing, veterinary service, shipping and miscellaneous expenses are additional costs and shall be billed accordingly. I agree to pay all additional costs in full upon presentation of billing and prior to the horse's departure.
8. I further agree that in the event that my account with Royal Arabians becomes delinquent and the farm deems it necessary to turn this matter over to any attorney for collection, I will be responsible for, in addition to the outstanding delinquent balance, all court costs and reasonable attorney's fees incurred in preparation of this matter for litigation.
9. 1. If horse is sold by Royal Arabians LLC, "Seller" is responsible for one email blast announcing the sale done by Royal.

**Sellers Agent Fee**

Royal Arabians will receive a 20% commission on the sale price of any horse sold by Royal Arabians, payable at the time of the sale. Royal Arabians will receive a 20% commission from any horse sold 30 days after the horse leaves the care Royal Arabians if Royal Arabians institutes the sale, or if the horse was viewed at Royal Arabians or in the arena with Royal Arabians trainers.
