- Duplicating, sharing, transferring, transmitting, renting, selling, sub-licensing, trading, leasing, loaning or giving Whistler Museum & Archives Society still images, records or documents in any format is not permitted.
- Any copies created, either physical or electronic, must be destroyed upon conclusion of the project.
- The Whistler Museum & Archives Society has the right to request one complimentary “signed” copy of each publication in which the Whistler Museum & Archives Society material appears.
- Publication/Use Fees for print/electronic publication, advertising and display purposes are for one-time only, non-exclusive use, over a 5-year period.
- Publication/Use Fees for public/commercial broadcasting purposes are for one-time only, non-exclusive use, with unlimited plays over a 5-year period.
