A BILL TO GIVE CITIZENSHIP IN EXCHANGE FOR MILITARY SERVICE

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. The U.S. will provide citizenship for immigrants who serve in the military.
- 2. SECTION 2. A citizen is a participatory member of a political community. Citizenship is gained
- 3. by meeting the legal requirements of the United States, which would be conditioned on
- 4. military service.
- 5. Military is broadly defined to include all active forces.
- 6. SECTION 3. The U.S. Citizenship and Immigration Services, in conjunction with the
- 7. Department of Defense, will enforce the bill.
- 8. SECTION 4. The bill will become law upon congressional approval and citizenship will be
- 9. granted if an individual is in active duty for 5 years with no criminal record during that time.
- 10. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A BILL TO INCREASE EDUCATIONAL PROGRAMS IN PRISONS

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. Educational programs are lacking funding and institutional support in federal
- 2. prisons. Prisoners that are not facing life sentences fail to receive opportunities to rehabilitate
- 3. emotionally and intellectually. Education programs will be funded that focus on career
- 4. pathways to develop a trade and/or skill.
- 5. SECTION 2. Education is defined as the knowledge and development resulting from
- 6. process of learning. Prisons are defined as an institution (such as one under federal
- 7. jurisdiction) for confinement of persons convicted of serious crimes.
- 8. SECTION 3. The Department of Justice will oversee in the implementation of this bill.
- 9. SECTION 4. This bill will be put into place on January 1, 2020.
- 10. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
