A Bill to Establish Penalties for "Sanctuary" Jurisdictions' Existence

1	Whereas.	Sanctuary jurisdiction establishment is defined as the establishment of
2		regulations, either formal or informal, that prevent or restrict any level of
3		enforcement from involvement or activity in or around the field of federal
4		immigration policy; and
5	Whereas.	Numerous states, cities, and counties, totalling to above one hundred and
6		seventy one jurisdictions, including but not limited to: The State of
7		California, The City of Philadelphia, and The City of New York, have all
8		implemented policies, both formal and informal, that fit the definition of a
9		sanctuary jurisdiction; and
10	Whereas.	These sanctuary jurisdictions exist to obstruct the work of law enforcement
11		officials, and exist to the detriment of all existing laws, detainers, and other
12		pending judicial decisions; therefore be it
13	Resolved.	That all jurisdictions that currently fall under the above definition of a
14		sanctuary jurisdiction will have its federal funding, from all sources within
15		the United States Federal Government, cut by ¼ (25%) each year, until
16		the Department Of Homeland Security certifies that these jurisdictions are
17		once again in compliance; and all jurisdictions that fit into the the definition
18	(of a sanctuary jurisdiction will be subject to the same punishment, until the
19]	DHS certifies compliance; noting that the Office of the President
20	1	reserves the right to temporarily override this punishment, in the case that
21	t	there is determined to have been, or have an imminent threat of, an
22	(emergency, and that all laws and regulations in conflict with this law
23	a	are declared null and void.

A Bill to Discourage the Use of Gas/Diesel Fueled Vehicles and Promote the Use of Alternative Energy Vehicles

- 1.) SECTION 1. This bill will put a 5% tax on every new gas/diesel powered car bought

A Bill to Reduce Civilian Ability to Construct IEDs

- 1 BE IT ENACTED BY THIS STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2 **Section 1**. The purchase of powdered sulfur shall require a Civilian Permit to Purchase

- 4 **Section 2**. "Civilian Permit to Purchase Sulfur" shall be defined as a new permit that must

- 13 C. Applications shall be reviewed and accepted by the Bureau of Alcohol, Tobacco,
- 14 Firearms and Explosives.
- 15 **Section 4.** This bill shall go into effect on July 1st, 2019.
- 16 **Section 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Preserve Commerce for Large-Capacity Firearms Magazines

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1. Congress shall ensure the national market for high-capacity
2	magazines is not infringed for a period of 10 years.
3	SECTION 2. When the state interests infringe upon the production and
4	sale of high-capacity firearms magazines, federal powers shall take
5	precedence and the limiting law shall yield.
6	A. "Limiting law" is defined as any state law excluding
7	possession, manufacture, loan, import, or sale of firearms
8	components on the basis of high capacity.

11.		use of governmental funds or property, or funds or property derived from a

14.		express information, ideas, and opinions free of government restrictions
15.		based on content and subject only to reasonable limitations (as the power
16.		of the government to avoid a clear and present danger) especially as
17.		guaranteed by the First and Fourteenth Amendments to the U.S.
18.		Constitution.
19.	SECTION 3:	The Department of Education will enforce this legislation.
20.	SECTION 4:	This bill will take effect at the beginning of the 2020 school year.
21.	SECTION 5:	All laws in conflict with this legislation are hereby declared null and void.

20	SECTION 4.	This piece of legislation shall go into effect after 6 months after passage.
21	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.
