

A Bill to Implement the Gold Standard

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United States Government shall return back to the gold standard and will reinforce the Dollar with gold reserves instead of “full faith and credit”.

SECTION 2. A. The gold standard is a monetary system where the value of a currency is defined in terms of gold.

B. The Dollar will now be defined in terms of a fixed weight of gold.

SECTION 3. During the 12-month period following the enactment date of this legislation, the United States Government will take the necessary steps to disclose all of its gold holdings to the market and the public.

SECTION 3. The Department of the Treasury will oversee the enforcement of the bill.

SECTION 4. This bill will be implemented at the start of FY 2020

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Reduce Conflicts of Interest Within the Executive Branch

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. A. The President and the Vice President will have to relieve themselves of all potential financial conflicts of interest.

B. The President and the Vice President will disclose their previous tax returns.

C. The bill would also apply for presidential and vice presidential spouses, children, and appointees.

SECTION 2. A full relief of financial conflicts of interest is defined as a divestment of all financial holdings and interests that could interfere with the actions of the executive branch.

SECTION 3. The Internal Revenue Service will oversee the enforcement of the bill and will enforce the clawback measure.

A. Refusal of compliance by any of the members affected by this legislation will result in a federal charge and the chance of impeachment determined by Congress.

SECTION 4. This bill will be implemented upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Provide Paid Leave for All Federal Employees

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. All Federal Full Time Employees will receive 12 weeks of paid family leave.

SECTION 2. Full Time Employee is defined as any individual that works at least 30 hours a week or 130 hours per month.

SECTION 3. The Department of Health and Human Services will oversee the enforcement of this legislation.

SECTION 4. This bill will be implemented at the beginning of FY 2020.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Sanction China for Forced Detention of Muslims

WHEREAS, International Human Rights Organizations have found China to be unlawfully arresting muslims;

WHEREAS, The conditions in these detention camps are lackluster and inhumane; and

WHEREAS, China has repeatedly denied any existence of these camps and prisons; now, therefore, be it

RESOLVED, That the Congress here assembled make the following recommendations to place economic sanctions on the People's Republic of China; and, be it

FURTHER RESOLVED, That these sanctions will only be removed once it is proven that China is taking steps to decrease the presence of these detention facilities.

A Bill to Increase College Access

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The federal government shall stipulate 50% of the funding for all community college tuition nationwide, with the states' governments providing the other 50% of the tuition.

SECTION 2. A community college is defined as a non-residential junior/secondary college offering college level, transferable courses.

SECTION 3. The Department of Education will oversee the enforcement of this legislation.

SECTION 4. This bill will be implemented at the beginning of FY 2020.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to End the Cuban Embargo

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. 22 U.S. Code § 2370(a), which establishes the trade embargo between the Republic of Cuba and the United States, is hereby repealed.

SECTION 2. The President can no longer encourage foreign countries to restrict trade and economic relationships with Cuba, in reference to the Embargo.

SECTION 3. The Department of State, Department of Commerce, and the Office of the U.S Trade Representative will oversee the enforcement of this legislation.

SECTION 4. This bill will go into effect immediately upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Grant Statehood to the District of Columbia

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. This bill will legally declare Washington, Douglass Commonwealth, as the 51st state in the United States of America.

SECTION 2. A. The District of Columbia will be granted all rights given to every state in the United States.

B. This bill keeps the District of Columbia as the capital of the country.

SECTION 3. The Department of State will oversee the enforcement of this legislation.

SECTION 4. This bill will go into effect immediately upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ban Artificial Intelligence Crime-Predicting Softwares.

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. All courts and police departments can no longer use crime-predicting artificial intelligence to justify and influence court rulings.

SECTION 2. A. Police departments are defined as all federal and state police departments, including county and district sheriffs.

B. Crime-predicting softwares are programs developed using algorithms and artificial intelligence to determine if an individual has an increased likelihood of committing a crime or the probable geographic location of certain crimes

C. Courts include federal, state, trial, circuit, district, appeals, and supreme courts.

SECTION 3. The Department of Justice will oversee the implementation of this legislation.

A. Any police or court systems found to be guilty of not complying with this legislation will be fined \$10,000 per infraction.

SECTION 4. This bill will go into effect immediately upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Have Equitable Payment Structures During Government Shutdowns

WHEREAS, Government shutdowns have become more normal and probable in the future;

WHEREAS, It is usually decided by upper White House officials and Capital Hill leaders, such as members of Congress and government executive staff; and

WHEREAS, non-essential personnel already do not get paid during a government shutdown, be it

RESOLVED, That the Congress here assembled make the following recommendations to halt all payments to White House and Capitol Hill personnel during government shutdowns that leave federal workers without pay.

A Bill to Increase Government Access to Data

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1.** All technology corporations and firms can no longer use data encryption methods that prevent the data from being retrieved if the government issues a court order.
- SECTION 2.** Data encryption is defined as translating data into another form of code that allows only a certain group of people to access it
- SECTION 3.** The Federal Communications Commissions and the Department of Homeland Security will oversee the enforcement of this legislation
- SECTION 4.** This bill will go into effect immediately upon passage.
- SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
