# A Resolution to Affirm the Importance of a Free and Unfettered Press in our Democracy

1	WHEREAS,	The president repeatedly refers to reputable journalists and multiple
2		media organizations as "fake news; and
3	WHEREAS,	He has threatened to take away the White House press credentials of
4		journalists whose coverage he does not like; and
5	WHEREAS,	The decision to bar a member of the press from the White House for the
6		questions the member asked is retaliatory in nature, violates the spirit of
7		the First Amendment to the Constitution of the United States, and is not
8		indicative of an open and free press; and
9	WHEREAS,	A free and unfettered press is the cornerstone of our democracy; now,
10		therefore, be it
11	RESOLVED,	By the Congress here assembled that we
12		(1) condemn the escalating attacks by the president on reputable
13		journalists and news organizations;
14		(2) affirm that it is necessary and appropriate for reporters to ask
15		questions of powerful government officials in order to hold them
16		accountable to those that elected them; and
17		(3) Affirm that reporters and journalists must be free to do their job,
18		providing transparency to the people's government without fear of
19		reprisal from that government.

## A Bill to Prohibit Corporal Punishment Within Public School Systems

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The United States formally forbid the infliction of corporal punishment
- 3 within American public schooling systems.
- 4 SECTION 2. Corporal punishment being defined as punishment inflicted on one's
- 5 body as an act of discipline.
- 6 SECTION 3. Implementation of the newly established law will transpire during the
- 7 fiscal year of 2020.
- 8 **SECTION 4.** The responsibilities of this agency will be managed by the U.S.
- 9 Department of Education.
- 10 **SECTION 5.** Exceptions to this bill are hereby null and void.

## A Bill to Abolish the Patenting of Health Care Products and Pharmaceuticals

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	From this point forward, patents shall not be granted to health care
3		products and pharmaceuticals.
4	SECTION 2.	Patents shall be defined as governmental authority giving an agent the
5		sole right to make, use, or sale an invention. Health care products shall be
6		defined as selected products used to diagnose, treat, or care for medical
7		patients. Pharmaceuticals are defined as drugs or medicines that are
8		prepared or dispensed through pharmacies and used in medical
9		treatment.
10	SECTION 3.	The Department of Commerce's Patent and Trademark Office will enforce
11		this legislation.
12		A. Patents already granted as of June, 2019 will be grandfathered in and
13		valid until the expiration of the patent. These patents may not be
14		renewed.
15		B. An additional \$5 billion will be delegated in the FY 2020 budget to
16		provide medical advancement grants in order to inspire innovation.
17	SECTION 4.	This bill will be implemented on June 1, 2019.

All laws in conflict with this legislation are hereby declared null and void.

### A Bill to Combat Opioid Addiction in Prisons

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The	Director of the Federal Bureau of Prisons hereby is authorized to make
2		gran	its to and enter into cooperative agreements to develop and implement
3		a pr	ogram to provide medication-assisted treatment to individuals
4		inca	rcerated who are addicted to opioids.
5	SECTION 2.	The	term "medication-assisted treatment" means the use of drugs or
6		com	binations of drugs that have by FDA, been approved for use to provide
7		an e	ffective treatment of substance abuse.
8	SECTION 3.	The	Federal Bureau of Prisons shall enforce the following provisions on all
9		fede	eral prisons under their jurisdiction:
10		A.	Ensure the implementation, reporting and enforcing that all federal
11			prisons administer medication-assisted treatment for diagnosed opioid
12			and related substance abuse addicts that are incarcerated; and
13		B.	Assurance that federal prisons have, or have access to, a sufficient
14			number of clinicians licensed to administer medication-assisted
15			treatment to program participants; and
16		C.	Provide program participants continuity of care once released from
17			incarceration including assistance to eligible participants in registering
18			for Medicaid; and
19		D.	Generate an annual report to Congress on the number of participants,
20			treatment, after incarceration care and program recidivism rates.
21	SECTION 4.	The	Federal Bureau of Prisons has 90 days to begin enforcement once this
22		legis	lation becomes law.
23	SECTION 5.	All la	aws in conflict with this legislation are hereby declared null and void.

### A Bill to Reduce Gender Pay Gap

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Private companies must provide the Treasury Department the average salary
2		of men and women in the same job role and the difference cannot be more
3		than 20%.
4	SECTION 2.	The following definitions apply to this legislation:
5		Job role - Is the part that is played within a specific work process within the
6		company.
7	SECTION 3.	The Treasury Department shall enforce the following provisions on Private
8		Companies:
9		A. All private companies must submit, along with their annual tax filings, a
10		report of job roles and average salaries for men and women; and
11		B. The Treasury Department identifies company that have a gender
12		disparity of more than 20% percent between in any job roles; and
13		C. The company has one year to reduce the disparity to 20% or below or
14		will be taxed the difference in wage over 20% multiplied by the number of
15		employees in the offending job roles.
16	SECTION 4.	The Treasury Department has until the next tax year to begin enforcement
17		once this legislation becomes law.
18	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

## A Resolution to Allow Minors to Obtain MMR and Polio Vaccinations without Parental Consent

1	WHEREAS,	many children are unvaccinated against Measles, Mumps, and Rubella (MMR)
2		and Polio due to parental decisions based on faulty pseudo-science; and
3	WHEREAS,	vaccines are crucial to immune system development and the prevention of fatal
4		diseases from returning and spreading; and
5	WHEREAS,	the efficacy of vaccines falls when the entire population is not vaccinated; and
6	WHEREAS,	vaccines are required by many educational programs; and
7	WHEREAS,	minors currently have no way of acquiring vaccinations themselves; and
8	WHEREAS,	vaccinations are a health issue that should be allowed to be decided between
9		the person who has not received them and their medical care provider; now
10		therefore be it,
11	RESOLVED,	By the Congress here assembled that:
12		Minors should be allowed to request, without parental consent, MMR and/or
13		polio vaccinations from any appropriate medical provider and be covered under
14		health insurance programs as preventative care.
