# Federal Highway Administration funding to adequately address the needs of our crumbling infrastructure

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. The United States Federal government should add 40 billion dollars in spending per year continuing for the next 25 years.
- **SECTION 2.** The Federal Highway Administration would be the administrator of the plan.
  - A. The Federal Highway Administration would oversee all progress on infrastructure.
  - B. The Federal Highway Administration will create a list prioritizing projects based on public safety and efficiency.
  - C. The United States federal government would supply the additional funding.
- **SECTION 3.** The plan would take course over 25 years, giving 40 billion dollars each year.
- **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.

### **Bill #2** A Bill to Establish a Voting Holiday and Voter Rights

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:		
2	SECTION 1.	The 2 <sup>nd</sup> Tuesday in November will be established at a National Voting		
3		Holiday on years that have National Elections. Automatic voter		
4		registration at the age of 18 and mail in ballots for all National elections		
5		will occur automatically.		
6	SECTION 2.	A national holiday is a day when people do not go to work or school and		
7		government offices and banks are closed.		
8	SECTION 3.	The State Department will oversee the enforcement of the bill.		
9		A. The national voting holiday information to the public.		
10		B. The mailing of voter registration information to all 18 year old		
11		citizens.		
12		C. The mailing of mail in ballots to all Citizens.		
13	SECTION 4.	Implementation will be effective July 1 <sup>st</sup> 2019.		
14	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.		

## Bill #3 A Bill to Decriminalize Marijuana and Non-Violent Marijuana Related Crime

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. The United States federal government will remove marijuana from the Controlled Substances Act of 1970. Though states will retain their rights to make local laws, marijuana will be decriminalized for all U.S. citizens and resident immigrants.
- **SECTION 2**. Decriminalization will be defined as no longer enforcing illegal status and refusal to utilize law enforcement resources on non-violent marijuana related crimes.
- **SECTION 3.** Enforcement will be through the U.S. Department of Justice.
  - A. Upon passage of this bill, individuals currently incarcerated for non-violent marijuana related crimes will be release; those crimes will be expunged from criminal records.
  - B. Any non-violent marijuana related felons will immediately regain their voting rights without a wait period.
- **SECTION 4.** Passage will be immediate, with a 12-month grace period for detention facilities to process and release eligible individuals.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# Bill #4 A Bill to Establish an Office of Drug Manufacturing to Increase Access to Generic Drug

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. The federal government will establish the "Office of Drug Manufacturing," within the Department of Health and Human Services.
- **SECTION 2**. This office will have the following duty(s):
  - A. Determine what generic drugs are not being sold at a fair price or not available to the public despite being eligible for generic manufacturing.
  - B. Enter into a contract with a company to produce generic drugs at a fair price; or
  - C. manufacture generic drugs to sell at a fair price.
- **SECTION 3.** The Department of Health and Human Services will oversee this office with the following provisions;
  - C. No former registered drug manufacturer lobbyist may be appointed to the be director of the office.
  - D. Former drug manufacturer lobbyists may work for the office once they have been out of this job for 6 years.
- **SECTION 4.** This office will be created immediately upon passage of the bill and the first drugs produced within 2 years of passage.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Allow Individuals to Own Their Own Personal Data

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. Individuals will own their own personal data:

- A. Individuals will have the right to view all data a company has on
  them, and remove any such data. The company does not have the
  right to affect any agreements between the client and the company.
  - B. Companies may not discriminate against individuals who refuse to give personal information.
  - C. Companies may not require personal data and must remain transparent about which personal data is collected.
- 10 **SECTION 2.** This bill will be enforced and overseen by the Federal Communications
  11 Commission. Any infractions will result in a \$100,000 fine per infraction,
  12 and the companies will not be shielded from lawsuits by the victims.
- SECTION 3. This bill will go into effect one year after being enacted.
- 14 **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void

### A bill to increase border security at the Canadian border

#### BE IT ENACTED THAT BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 That there be an increase in border funding and security for out border shared with the country of Canada.
- 2 Border Funding means an increase and spending for the protection of this border. Security means more personnel and/or better infrastructure (i.e. a wall).
- 3 The United States Customs and Border Protection will oversee this bill. The enforcement of this will be that congress will check every year for an increase of personnel and infrastructure.
- 4 This bill will be implemented immediately upon passing.
- 5 All laws in conflict with this legislation are hereby declared null and void.

#### A Bill Requiring High School Mental Health Evaluations

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

SECTION 1. A mental health evaluation will be administered in all public schools within the United States.

**SECTION 2**. All US public schools will be required to administer mental health evaluations to all students.

- (1) This bill would remove all students that failed the test and put them in new schooling institutions so they can get the help they need while maintaining the educational opportunities they have a right to.
- (2) To pay for the enactment of this bill this congress will increase the personal income tax rate to 42% on incomes over \$300,000.

**SECTION 3.** The bill for mental health will be enforced by the US Department for Education, the US Department of Health and Human Services, and the Internal Revenue Service (IRS).

- A. The US Department of Health and Human Services will be in charge of administering all mental health evaluations.
- B. The US Department for Education and the US Department of Health and Human Services will then be in charge of establishing and running the new schooling institutions.
- C. The IRS will update the US tax code and enforce the new change.

**SECTION 4.** This bill will be implemented within six months of the passage.

SECTION 5. All other current tax codes and bills in conflict with this legislation are hereby declared null and void.

# A Bill to Limit Domestic Surveillance in Section 702 of the Foreign Intelligence Surveillance Act

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. The FISA (Foreign Intelligence Surveillance Act) Amendments Reauthorization Act of 2017 (S.139) will be repealed.
- Section 702 of the FISA Amendments Act will be changed to make its sole authority for domestic surveillance of information that is in the custody of an American company requiring a warrant based on probable cause believing that a United States person is planning or is engaged in acts of terrorism to search gathered information.
- initiate a cooperative and complete audit of protocols and norms within FISA to ensure protection of domestic privacy rights. Their findings and recommendations will be presented before Congress to make further changes to FISA, if they are found to be necessary.
- SECTION 4. Implementation of this legislation and oversight will be performed by the Department of Justice.
- **SECTION 4.** This bill will be implemented immediately upon its passage.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

#### A Bill To End Government Shutdowns

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1.** The United States Federal Government may no longer be permitted to enter a government shutdown caused by a failure to implement a federal budget.
- **SECTION 2.** In the event that the Congress of the United States and/or the President of the United States fail(s) to approve a federal budget by the start of any future fiscal year:
- (1) This bill will serve as a perpetual Continuing Resolution that does not need Congressional or Presidential approval.
- (2) The federal budget from the fiscal year directly preceding the current fiscal year will automatically be approved as the budget that the United State Federal Government will operate on.
- (3) If Congress and/or the President failed to approve a federal budget in the previous fiscal year, the most recently approved budget will be approved as the new federal budget.
- (4) Any Appropriations Bills, Omnibus Bills, Continuing Resolutions, or other unspecified bills or resolutions that establish a federal budget that are approved by Congress and the President after a previous federal budget is re-implemented will void the previous budget and become the new federal budget.
- **SECTION 3.** This bill will be enforced by the US Department of the Treasury and the Internal Revenue Service (IRS).
- **SECTION 4.** A government shutdown will be defined as a cease in operations of the federal departments, agencies, and bureaus caused by a lack of approved funding by Congress and/or the President.
- **SECTION 5.** A fiscal year will be defined as beginning on October 1 and ending on September 30.
- **SECTION 6.** This bill will be implemented implemented immediately upon passage.

**SECTION 7.** All other current tax codes and bills in conflict with this legislation are hereby declared null and void.

# A Bill to Expedite the Fulfillment of the 2018 National Defense Authorization Act requirement to increase the Size of Naval Forces to 355 Ships

- 2. **SECTION 1**. The Congress shall authorize funding for construction, refitting, and
- 3. employment extension of ships necessary to meet the 2018 National Defense

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 4. Authorization Act
- 5. **SECTION 2**. "Refitting" shall refer to updating older/retired ships to operational
- 6. status. "Deployment extension" shall refer to postponing the planned
- 7. retirement of certain ships determined to be eligible.
- 8. **SECTION 3.** Enforcement shall be through the Department of Defense.
- 9. A. One (1) new carrier shall be constructed, to bring total carrier forces to
- 10. twelve (12).
- 11. B. Further recommendations for specific ships to be constructed, refitted
- 12. or for deployment extension shall be given by the Department
- 13. of the Navy.
- 14. **SECTION 4.** The law's enactment shall be post dated to January 1, 2019. The target
- 15. number of 355 shall be reached by December 31, 2025.

**SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# Bill #11 A bill to limit the Terms that any member of congress can

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 That a limit be placed upon all members of congress on how many terms they can serve.

# A Bill to Build a Wall between the United States and Mexico to Stop Illegal Immigration

1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:		
2	SECTION 1.	Congress will authorize appropriate funding of a minimum of \$5.7 billion	
3		dollars to build a wall between Mexico and the southern border of the	
4		United States, to protect the American people, our way of life, and our	
5		children;	
6	SECTION 2.	The wall will be built along the places where there are large border cities	
7		currently without walls and most illegals enter the United States from	
8		Mexico. The funding will be taken from the annual appropriations given	
9		to Mexico (around \$350 million) and used to begin building the wall;	
0	SECTION 3.	The project will be overseen by Homeland Security and I.C.E. and they	
1		will have adequate funding from Congress to enforce anyone who	
2		trespasses;	
3		A. Border patrol will be adequately funded and staffed.	
4		B. Violators will be prosecuted by the Federal Government	
5	SECTION 4.	This will take effect within 60 days after Congress passes the Bill.	
6	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.	

### A Bill to Ban the use of Solitary Confinement within the United States of America

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. The use of solitary confinement shall be banned in all prisons across the United States.
- **SECTION 2**. The ban would affect all federal and private prisons, as well as all local and state correctional facilities.
- **SECTION 3.** The Federal Bureau of Prisons would oversee the plan.
  - A. In the instance that a prison fails to cooperate, federal funding would be cut until cooperation has been established.
  - B. The Federal Bureau of Prisons would oversee enforcement in prisons and report any institutions utilizing solitary confinement.
- **SECTION 4.** Once passed, there would be a thirty day grace period in order to adapt to the new policies before enforcement begins.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
