Beginning in the 1980s, the organization began to sponsor the Florida Blue Key Speech and Debate Tournament. Every year, the Speech and Debate Tournament student staff has been delighted to welcome the speech and debate community to our campus. With the help of our "Gator Guard" coaches and an incredible team of students, the 2019 Florida Blue Key Speech & Debate Tournament will certainly not be one to miss.

Our tournament will feature **varsity** competition in *Lincoln Douglas Debate*, *Public Forum Debate*, *Congressional Debate*, *Dramatic Interpretation*, *Humorous Interpretation*, *Mixed Extemporaneous Speaking*, *Program Oral Interpretation*, and *Original Oratory* and **novice** competition in *Lincoln Douglas Debate and Public Forum Debate*.

Registration is set to open this year on August 30, 2019 on Tabroom.com

Students <u>may double enter or triple enter</u> in speech events only. If a student would like to triple enter he or she may **NOT** choose three events in one pattern. Students may not double or triple event in any debate events. Speech events will be divided into the following two patterns:

Pattern A- Mixed Extemporaneous Speaking, Dramatic Interpretation, Informative Speaking, and Duo Interpretation

Pattern B- Humorous Interpretation, Original Oratory, Impromptu Speaking and Program Oral Interpretation.

We are excited to announce that Public Forum and Lincoln Douglas debaters will debate their respective *November-December 2019 NSDA Debate topics*.

Florida Blue Key is thrilled to announce that we have retained our status as a qualifying competition for the National High School Tournament of Champions (TOC) in Public Forum (octafinalists), Congressional Debate (semi-finalists), and Lincoln Douglas (quarterfinalists). Florida Blue Key is also a bid tournament for the TOC in speech events.

JUDGE REQUIREMENTS & ACCOUNTS: All schools should provide 1 judge for every 2 Lincoln Douglas Debate and/or Public Forum Debater entries and 2 judges for every 5 Speech and/or Congress entries. Hired judges will be available upon request and approved by tournament administrators. Hired judges are \$200.00 per judge. All judge (Speech, Congress and Debate) must have a valid Tabroom account established for online ballots. All events will use online ballots at the tournament.

TOURNAMENT EVENTS: Our tournament will feature **varsity** competition in *Lincoln Douglas Debate*, *Public Forum Debate*, *Congressional Debate*, *Dramatic Interpretation*, *Humorous Interpretation*, *Duo Interpretation*, *Informative Speaking*, *Impromptu Speaking*, *Mixed Extemporaneous Speaking*, *Informative Speaking*, *Program Oral Interpretation*, and *Original Oratory* and **novice** competition in *Lincoln Douglas Debate*, and *Public Forum Debate*. All events follow the NSDA (National Speech and Debate Association) rules and regulations.

ENTRY CAPS: Schools will have a *8 entry cap* in each Speech/Congress events. In Public Forum Debate and Lincoln Douglas Debate schools will have a *7 entry cap* per division.

WAIT LIST: Any excess entries will be automatically placed on a waitlist. We highly encourage you to register early as we anticipate capacity to fill quickly.

No checks will be accepted by mail after **October 23, 2019 at 5:00 pm**. All schools will be responsible for payment of invoices at live registration that will take place on Friday, November 1, 2019 from 10:00 a.m.-2:00 p.m. in the Rion Ballroom at the J. Wayne Reitz Union.
