8. intervention since 2018 and

15. energy sectors until 65 percent of Russian military presence are
16. eliminated from each nation mentioned.

A BILL TO BAN SOLITARY CONFINEMENT IN PRISONS

BE IT ENACTED BY THIS CONGRESS THAT:

SECTION 1. The use of solitary confinement as punishment will be banned in all 50 states and territories in the United States of America.

SECTION 2. Solitary confinement is the isolation of a prisoner in a separate cell. Prisoners use solitary confinement as a form of punishment.

A BILL TO MANDATE PRISON EDUCATION

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
