A Bill to Mandate Sex Education in High Schools

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2. **SECTION 1.** A bill to require all high schools in the United States to add sex education
3. in the students curriculum in the 10th grade.
4. **SECTION 2.** “Sex Education” is defined as the instruction of issues relating to human
5. sexuality, including emotional relations and responsibilities, human
6. sexual anatomy, activity, reproduction, age of consent, birth control,
7. sexual abstinence, and reproductive health/rights. “High Schools” is
8. defined a school especially in the U.S. including grades 9–10 or 10–12.
9. **SECTION 3.** The Department of Education will oversee the enforcement of the bill with
10. the specific enforcement mechanism.
11. **A.** The current budget will be increased by \$5 million to reform the current
12. program and incorporate added sex education material and information.
13. **B.** School districts in the United States teach some form of abstinence in
14. their curriculums. The creation of a new sex education program will
15. involve the additon of topics on human sexual anatomy, reproduction,
16. age of consent, birth control, reproductive health/rights, sexually
17. transmitted diseases, and sexual abstinence.
18. **SECTION 4.** This law will go into effect Fiscal Year 2021.
19. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Create Secondary Language Classes Required for Grades K-6th

BE IT ENACTED BY THE CONGRESS ASSEMBLED HERE TODAY:

SECTION 1: Secondary language classes are mostly present in secondary schooling only and even then, it's not mandatory and much more difficult to learn. There are numerous benefits to learning another language, including but not limited to - enhanced job opportunities, cross-cultural connections, and cognitive enhancements. This bill will create secondary language classes required for grades K-6th.

SECTION 2: Mandatory is defined as something that is required or compulsory and Secondary language refers to a language that is not an individual's primary language.

SECTION 3: The Mandatory Second Language Act entails that:

1. In order to fund this bill, 5 billion dollars will be reappropriated from the 598.5 billion dollars that is currently our defense budget. This year alone, the military lost 12 billion dollars, spent 4.6 million on crab and lobster, and 7.6 million on workout equipment. Ultimately, the DoD can reappropriate the necessary 5 billion dollars.
2. Individual school districts will decide on which language(s) will be taught. They will do this by holding a vote in which the teachers, administrators, and parents vote on which language they believe would be the most beneficial.
3. The secretary of education will be ensuring oversight is done to the best of its ability and the "mandatory" part of this bill is upheld.
4. In the span of 5 years, demand for bilingual workers has more than doubled.
5. Studies show that the "window of opportunity" to learn a language is from birth to the age of 8.
6. Being bilingual improves brain function, memory, and cognition.

SECTION 4: This act shall be effective for all federally funded schools on January 1, 2022.

SECTION 5: All laws in conflict with this legislation are hereby declared null and void.

A Bill to make the Speaker of the House an Electable Position by the Public

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The position of Speaker of the house will become an electable position
3 voted on every two years. The election will follow the already established
4 voting system on the federal level. Also follow presidential requirements
5 on if a candidate is eligible, and same campaign rules as a presidential
6 election.

7 **SECTION 2.** The Speaker as the House will be defined as is the political and
8 parliamentary leader of the House of Representatives. Also the term
9 electable position will be defined as a position that is voted on specifically
10 by the people.

11 **SECTION 3.** The Federal Election Commission (FEC) and the National Archives and
12 Records Administration (NARA) will oversee the election process.

13 A. \$75 million will be allocated to the FEC to cover the cost of the
14 presidential public funding program, and any other cost to oversee
15 the elections.

16 B. The \$75 million will be re-allocated from the Federal Reserve
17 overnight loan program. After the initial election cycle the \$3 tax
18 checkoff will be increased to \$6 and also pay for the Speaker of the
19 house election.

20 **SECTION 4.** This Bill will go into effect immediately after being passed, but the first
21 election will be held in the 2022 election cycle.

22 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Ratify a Peace Agreement with the Afghan Taliban

- 1 **WHEREAS,** On 7 October 2001, in response to the 9/11 terrorist attacks, The United
2 States invaded Afghanistan in order to topple the Taliban government,
3 despite the fact the Afghan Taliban had no direct involvement in 9/11
4 and only *allegedly* harbored Al-Qaeda leaders; and
- 5 **WHEREAS,** Eighteen years later, the American-led intervention against the Afghan
6 Taliban has devolved into the longest war in U.S. history; and
- 7 **WHEREAS,** This war has directly lead to the deaths of over 2,400 American
8 servicemen and the mental and physical injury of more than 20,000
9 more, the murders of over 30,000 innocent Afghan civilians, and a price
10 tag of over \$1 trillion, paid for by the American people; and
- 11 **WHEREAS,** Whereas those on both sides of the conflict, America and the Taliban,
12 actively seek a resolution to this conflict and have met for multiple peace
13 conferences where they have laid out their conditions for a lasting peace
14 known to each other; now, therefore, be it
- 15 **RESOLVED,** That the Congress here assembled withdraw the 14,000 U.S. troops
16 currently stationed within the Islamic Republic of Afghanistan from that
17 country and suspend all and any future military action within the country;
18 and, be it
- 19 **FURTHER RESOLVED,** The Taliban must firstly agree to never plot an attack against the
20 U.S. and secondly agree to never be a safe haven for America's enemies
21 before the preceding clause can take effect.

A Bill to Require All Eligible Citizens to Complete 4 Years of Military Service

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All eligible citizens will be drafted into the armed forces when or if they
3 meet the criteria for acceptance.

4 **SECTION 2.** Eligibility is defined as anyone between the ages of 18 and 35, is a citizen
5 of the United States and does not have a disqualifying medical disability.

6 **SECTION 3.** The Department of Defense will oversee the enforcement and
7 implementation of this bill.

8 A. All eligible citizens in the United States that have not completed their
9 mandatory service by the age of 35 will be required to complete 8000
10 hours of community service within 8 years.

11 **SECTION 4.** This bill will go into effect immediately for anyone turning 18 and beyond
12 in 2020.

13 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Not Require Vaccines for Children in the United States

1. **WHEREAS,** Vaccines in the United States contain many dangerous chemicals¹; and
2. **WHEREAS,** Vaccines contain chemicals such as antifreeze, phenol, formaldehyde, aluminum,
 3. glycerin and many more; and
4. **WHEREAS,** Every one of these chemicals is dangerous and hazardous to the human body¹; and
5. **WHEREAS,** Vaccines also contain fetal tissue from aborted babies²; and
6. **WHEREAS,** According to a pilot study in March 2016, “The significant association between
 7. vaccination and NDDs all support the possibility that some aspect of the current
 8. vaccination program could be contributing to risks of childhood morbidity”³; and
9. **WHEREAS,** The UN, for statistical consistency across regions, defines a youth as a person being
 10. within the ages of fifteen and twenty-four⁴, allowing a child to be defined as a
 11. person being fourteen years or younger; now, therefore, be it
12. **RESOLVED,** By this student congress here assembled, that vaccines should not be required for
 13. children in the United States.

Bill to Remove The Electoral College to Create Fair Elections

1 BE IT ENACTED BY THIS CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The electoral college will be removed as the United States method of
3 electing a president.

4 **SECTION 2.** Electoral College is a body of people representing the states of the US,
5 who formally cast votes for the election of the president and vice
6 president.

7 **SECTION 3.** The National Archives and Records Association and the Federal Election
8 Commission will administer the removal of the Electoral College and
9 replace it with the popular vote model. The popular vote model is
10 defined as electing the president by popular vote.

11 **SECTION 4.** The new model will be implemented by November 2rd, 2020

12 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A bill to Examine Government Spending to Protect the Taxpayers Dollars from Being Wasted.

Be enacted by the congress here assembled that:

- Section 1.** Seeing as the United States wastes on average one trillion dollars, we as a Congress must join together to reconstruct the budget put the gratuitous spending to rest
- Section 2.** For the budget to be properly reconstructed, the wasteful spending must be sought, adjusted, eliminated, and redistributed.
- Section 3.** The United States Treasury will oversee and lead the investigation into the United States' spending.
- A . Since the last complete overview of government spending in 2009, the funds wasted have risen ten fold.
- B . The US Treasury will have funds to do such actions as long as it equates to the ends justifying the means.
- Section 4.** This act shall be in place for the United States Treasury department on Jan 1, 2021
- Section 5.** All laws in conflict with this legislation are hereby declared null and Void.

Spring 2020 Item 26: A Resolution to Prohibit Undercover Policing

1 **WHEREAS,** Undercover, or plainclothes, policing is a common practice in police
2 precincts in the United States; and

3 **WHEREAS,** Undercover officers are subject to less oversight from the public and the
4 courts than regular police officers; and

5 **WHEREAS,** Due to a lack of oversight, investigations may commit violations of
6 Americans' privacy with no real benefit to public safety; and

7 **WHEREAS,** There is potential for law enforcement to discriminate data collection
8 based on factors such as race, sex, political positions, and personal
9 vendettas; and

10 **WHEREAS,** Law enforcement agents and police officers have even, in some cases,
11 impersonated individuals online without consent; and

12 **WHEREAS,** Attempts to monitor and limit undercover policing operations are difficult
13 because of their secretive nature; now, therefore, be it

14 **RESOLVED,** By the Congress here assembled that undercover policing shall be
15 prohibited in the United States and all its territories and jurisdictions.

Spring 2020 Item 16: A Bill to Sanction China for Human Rights Abuses

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States shall hereby impose economic sanctions against security
3 companies in China for their human rights abuses of the Uighur Muslims.

4 **SECTION 2.** Economic sanctions shall be defined by commercial and financial penalties
5 inflicted upon a state, group, or individual.

6 **SECTION 3.** The Department of State, the Department of Commerce, and the Office of Foreign
7 Asset Control shall be in charge of enforcement of this legislation.

8 **A.** Sanctions shall be subject to review if the Department of State determines that
9 China has made significant strides to decrease human rights abuses.

10 **SECTION 4.** This legislation shall go into effect immediately after passage.

11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
