# **Boston Latin School Debate Tournament**

On September 21st, 2019

The tournament will be held at Boston Latin School and will include Open divisions of Public Forum, Lincoln Douglas and Legislative Debate (Student Congress).

# **Registration Information**

Registration can be done via tabroom.com and will be open until 10PM on Wednesday, September 18th. Schools are provided 8 entries per event, with any above that placed on a wait list and hopefully admitted if we have the space.

Registration fees are \$10 per student (\$10 for a Congress or LD entry, and \$20 for a PFD entry).

We will be trying to **single-flight** LD and PF, and thus we are asking schools to bring **one judge for every two entries (or fractions thereof) in PF and LD**. We intend to run 5 prelim rounds and up to two outrounds if time permits. ALL JUDGES ARE OBLIGATED THROUGH THE END OF THE TOURNAMENT. For **Student Congress**, **schools are obligated to provide one judge per 5 competitors or fraction thereof**.

There will be a \$75 fine for each missing judge - this is not to be used in lieu of providing required judges. Judge requirements are locked at 10PM on Thursday. Any drops after that will NOT change your school's judge obligation.

We will be using electronic ballots, so all judges should be set up with a tabroom.com account before the tournament.

We are hoping to have **a few** Public Forum Debate judges available to hire for \$75 each. Requests for hired judges will be granted on a first-come first-served basis. Please email Keith West directly at <a href="west.keith.j@gmail.com">west.keith.j@gmail.com</a> if you wish to hire a judge.

**PF:** The European Union should join the Belt and Road Initiative.


**LD:** In the United States, colleges and universities ought not consider standardized tests in undergraduate admissions decisions.
