# **Judge Requirements:**

- One for every 1 or 2 Novice Policy teams entered.
- One for every 1 or 2 Varsity Policy teams entered.

(We are separating the judging pools due to expected low numbers in the policy categories)

- One for every 1 or 2 LD or PF entries entered. we'll assume judges can do both unless you specify otherwise

We will most likely not have many/any extra judges, so please make sure that you fulfill your judging obligations.

#### **Event Details:**

**VSS/NSS:** Varsity will follow the 8-minute prep time rule. Novice will have also have 8 minutes. Both divisions will have three rounds.

Topic - **Resolved**: The United States federal government should substantially reduce Direct Commercial Sales and/or Foreign Military Sales of arms from the United States.

**Public Forum:** PF will have 5 rounds and have the normal flip for sides format with 3 minutes of prep time. Remember as well that summaries are 3 minutes.
