7	<b>SECTION 1:</b> The president shall no longer have the power to grant any
8	judicial pardons or commutations as outlined in Article 2
9	Section 2 of the Constitution.

11	appropriate legislation.

# 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 2 SECTION 1. A. The National Minimum Drinking Age Act of 1984 shall be repealed.
- B. The United States federal government shall set the minimum legal drinking
- 4 age to 16.
- 5 SECTION 2. All alcoholic beverages shall now be available for consumption and purchase by
- 6 all persons ages 16 or older.
- 7 SECTION 3. Alcoholic beverages shall be defined as all beverages that are suitable for human
- 8 consumption and contain .5% or more of alcohol by volume.
- 9 SECTION 4. The Bureau of Alcohol, Tobacco, Firearms and Explosives shall oversee the
- implementation of this legislation.
- 11 SECTION 5. Upon passage, this legislation will become effective on 1/1/2020.
- 12 SECTION 6. All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Authorize Aid to the Brazilian Nuclear Energy Program

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT: 1 SECTION 1. The United States will hereby authorize aid to protect Brazilian Nuclear 2 Reactors and maximize nuclear energy production in Brazil, with consent 3 of the Brazilian Government. 4 SECTION 2. Aid will comprise of security forces, investment towards the construction 5 of new nuclear reactors, facility operators, personnel, and researchers. 6 SECTION 3. The United States Southern Command, known as SOUTHCOM, will be in 7 charge of the oversight of operations and control of aid. 8 A. SOUTHCOM will recruit nuclear facility operators, personnel, and researchers from the United States in coordination with the United 10 States Nuclear Regulatory Commission, or USNRC. 11 B. The Department of State in coordination with SOUTHCOM and the 12 USNRC will set up security measures with both US and Brazilian 13 Personnel within a 5-mile radius of the nuclear reactors. 14 C. The US Department of Defense will allocate to SOUTHCOM the 15 necessary funding that SOUTHCOM requests, not exceeding a tenth 16 of the budget appropriated to the Department of Defense. 17 D. SOUTHCOM and the Department of State will conduct joint semi-18 annual audits to ensure proper distribution and usage of funds. 19 SECTION 4. This bill will go into effect on October 1, 2019. 20

# BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. **SECTION 1**. The United States shall provide \$300 million in develop
- 2. mental aid to the Government of Djibouti and non-governmental organiza
- 3. tions working within the nation.
- 4. **SECTION 2**. 'Developmental Aid' shall be defined as financial aid to
- 5. support the economic, environmental, social, and political development of
- 6. developing countries. 'Non governmental organizations' shall be defined as
- 7. private, non-profit companies who provide humanitarian services to the Dji
- 8. boutian people.
- 9. **SECTION 3.** The United States Agency for International Development 10.(USAID) shall oversee the enforcement of this legislation.
- 11.\$120 million shall be allocated to the pre-existing pilot WASH project in
- 12. Djibouti and the Djibouti Department of Rural Hydraulics
- 13.\$90 million shall be allocated to the Power Africa, Workforce Development14.and the UN World Food Programme project
- 15. The remaining \$90 million shall be allocated with the discretion of USAID.
- 16. The Office of Inspector General shall conduct a yearly review on the
- 17.progress of such aid. If funds have been found to be misused, such funds
- 18. shall be allocated to another NGO with the discretion of USAID.
- 19.**SECTION 4.** This legislation shall take effect at the beginning of FY 20.2020.
- 21.**SECTION 5.** All laws in conflict with this legislation are hereby declared 22.null and void.

- 11. and void.

### A BILL TO IMPLEMENT A UNIVERSAL BASIC INCOME

### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. The United States shall provide \$1000 a month to all citizens over the age of 18, regardless of income or employment status.
- **SECTION 2**. Recipients do not include a) non-citizens, b) felons, and c) unbanked citizens.
  - **A.** For current welfare and social program beneficiaries, the choice between their current benefits or \$1,000 cash unconditionally shall be voluntary and optional.
  - **B.** For citizens abroad, the cash transfers will stop after a 60-day period outside of the United States. At this point, the \$1000 per month will accrue and is attainable upon return to the United States.
  - **C.** The legislation will be funded through a 10% VAT (value-added tax) and the consolidation of current social welfare programs.
- **SECTION 3.** The Department of Health & Human Services and the Internal Revenue Service shall be responsible for the implementation of this legislation.
  - **A.** The Department of Health & Human Services shall be responsible for the consolidation of current social welfare programs and distribution of the \$1000 a month to recipients.
  - **B.** The Internal Revenue Service shall be responsible for the collection and enforcement of the VAT.
- **SECTION 4.** This bill will go into effect one year from the date of passage.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# A BILL TO ESTABLISH A UNIVERSAL BASIC INCOME TO ADDRESS THE PROBLEMS OF POVERTY AND AUTOMATION

1	BE IT ENAC'	TED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	Every viable American not otherwise receiving direct assistance from the
3		Federal Government shall receive 1,000 U.S. dollars per month from the
4		Federal Government. The Federal Government shall implement a Value
5		Added Tax of 12.75% to all sales (other than non-prepared food items).
6	SECTION 2.	A viable American shall be any person having full U.S. citizenship
7		residing in one of the 50 United States or a territory or protectorate of the
8		United States and is above 18 years of age, and not currently incarcerated.
9	SECTION 3.	This Bill shall be enacted and enforced by the Internal Revenue Service,
10		Interstate Commerce Commission, Federal Communication Commission,
11		Food and Drug Administration, and the Department of Homeland
12		Security.
13	SECTION 4.	This legislation shall go into effect 6 months after enactment.
14	<b>SECTION 5.</b>	All laws in conflict with this legislation are hereby declared null and void.

# A BILL TO REQUIRE MORE SPECIFIC NUTRITION FACT LABELS

1	BE IT ENACT	TED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The terms "artificial flavor(ing)", "spices" and "natural flavor(ing)" may
3		no longer be used on the ingredient list for a Nutrition Facts label.
4	SECTION 2.	"Nutrition Facts label" shall be defined as the labeling used to clarify
5		quantities of nutrients and ingredients on a food/drink.
6	SECTION 3.	The Department of Health and Human Services shall work in tandem with
7		the Food and Drug Administration to enforce this legislation.
8		A. The term "natural flavor(ing)" must be replaced with terms that clarify
9		its source at least according to the component of the animal or plant.
10		Any "natural flavor" that is artificially synthesized must be specified
11		that it was artificially synthesized.
12		B. The term "spices" must be replaced with terms that clarify its source at
13		least according to the component of the plant.
14	SECTION 4.	This bill shall be put into effect on March 1st, 2020.
15	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

2 SECTION 1.	A. The United Nations Participation Act of 1945 shall be repealed.
3	B. The president shall terminate all membership by the United States in the
4	United Nations and/or any other affiliated body of the United Nations.
5	C. The United States Mission to the United Nations shall be closed, all remaining
6	functions of such office shall not be carried out.
7	D. All other Acts pertaining to the United States involvement in the United
8	Nations shall be repealed.
9 SECTION 2.	A. The United Nations Headquarters Agreement Act shall be repealed, which is
10	in reference to the United Nations headquarters located in New
11	York.
12	B. The United Nations may not use and or occupy any property or facility of the
13	United States government.
14 SECTION 3.	A. The United States shall terminate its participation in United Nations
15	peacekeeping operations.
16	B. All funding to such peace operations shall be terminated, and no future
17	transactions to the United Nations or any affiliated body shall be authorized.
18 SECTION 4.	Upon passage, this legislation will become effective on 1/1/2020.

11		the Democratic Republic of the Congo.
12	SECTION 4.	This legislation will go into effect immediately after passage.

# A RESOLUTION TO BAN THE USE OF ENHANCED INTERROGATION TECHNIQUES

- **RESOLVED,** That the Student Congress here assembled make the following recommendation to ban the employment of enhanced interrogation techniques on detainees in offshore detention centers.
