Judging quotas are as follows:

**Speech: 1 judge for every 5 contestants or fraction thereof;

**Congress: One (1) capable scorekeeper or trained parliamentarian for every 10 students entered (or fraction thereof). If you have only one congress entry, please bring an adult who can serve in either role.

**Debates: 1 judge for every 2 contestants or fraction thereof (this includes Policy Debate, Lincoln-Douglas, and Public Forum.

A training workshop for new Speech judges will be held, if needed, during Round 1. Remember that you must bring the required number of qualified judges in addition to the new ones to be trained. Please indicate on your registration those adults who will need the training.

Mercer will conduct online balloting (and those who know me well understand that I will allow two of my technologically capable assistants to do so with continuing trepidation!). Please make sure your judges have tabroom.com accounts as well as access to a smart phone (which is OK, but not great), a tablet (a much better option), or a laptop (which is best).
