A Bill to Transition to a "Day Fine" System

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT

- **Section 1.** The passage of this legislation would adjust criminal fines to be on a sliding scale, where the citizen's payment is determined by their taxable income.
- **Section 2**. This would replace the current "baseline" fee system.
- **Section 3**. The sliding scale would consist of fines that are between 2 (two) and 8 (eight) percent of the citizen's total income.
- **Section 5.** A criminal fee is defined as a punishment for a parking ticket, criminal mischief, or any other crime currently settled by a fine.
- **Section 6.** The Department of Justice will regulate the enforcement of the legislation.
- **Section 7.** This Legislation will take effect at the beginning of the 2021 fiscal year.
- **Section 8.** All other laws and regulations that violate this bill are declared null and void.

SECTION 4: This bill's implementation shall begin immediately after passage.

declared null and void.

A Resolution to Amend the Constitution to Overturn Citizens United v. FEC

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

RESOLVED,

By two-thirds of the Congress here assembled that the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution when ratified by the legislatures of three-fourths of the several states within seven years from the date of its submission by the Congress:

ARTICLE XXVIII

SECTION 1.

To advance democratic self-government and political equality, and to protect the integrity of government and the electoral process, Congress and the States may regulate and set reasonable limits on the raising and spending of money by candidates and others to influence elections.

SECTION 2.

Congress and the States shall have power to enforce this article by appropriate legislation, and may distinguish between natural persons and corporations or other artificial entities created by law, including by prohibiting such entities from spending money to influence elections.

A Bill To Have A Universal DNA Database

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1.** All US citizens are required to submit a sample of their DNA to be stored in the DNA database.
- **SECTION 2.** DNA sample: DNA sample taken by an official government worker to be processed by qualified personnel for addition to the Universal DNA Database.

Universal DNA Database: Database that stores the DNA of all US citizens.

- **SECTION 3.** This bill will be enforced and enacted by The Department of Defense.
- **SECTION 4.** This bill will be funded by raising the Defense Department's funding by raising the taxes as recommended by the Department of Defense's cost estimates.
- **SECTION 5.** This bill will go into effect immediately upon passage.
- **SECTION 6.** All other laws and/or passages of Congress that conflict with this bill will be considered null and void.

A Bill to Implement Same-Day Voting Registration

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1.** The United States will require the option of same-day voting registration for all elections free of charge.
- **SECTION 2.** Same-Day Voting Registration (SDR): The process of allowing voters to register and vote on the same day, including early voting, currently permitted in some form in 21 states and the District of Columbia.
- **SECTION 3.** The Election Assistance Commission will provide the necessary resources to polling locations and facilitate the implementation of SDR nationwide.
- **SECTION 4.** As modeled by existing methods of SDR, there is no cost associated with this bill.
- **SECTION 5.** This legislation will go into effect immediately and the first official effect of this bill will be seen in the 2020 election.
- **SECTION 6.** All other laws and/or passages of Congress that conflict with this bill will be considered null and void.

A Resolution to Encourage States to Classify Social Work as a Hazardous Duty Job

1	WHEREAS, Social Workers help people who struggle to care for
2	themselves (e.g., minors and the elderly) or those providing support to these
3	individuals (e.g., parents and caregivers). At times, this includes finding
4	alternative placement for people faced with dangerous situations;
5	
6	WHEREAS, There are approximately 680,000 social workers that work in
7	the United States of America and who provide support to an estimated 150
8	million Americans;
9	
10	WHEREAS, Social Workers cover many versatile environments (e.g.,
11	hospitals, long-term care facilities, private homes, etc.) the circumstances of
12	which are unpredictable, with the risk of being exposed to violence or
13	otherwise toxic environments that vary from day to day;
14	
15	WHEREAS, These risks also include, but are not limited to, the following:
16	harm to clients, workers, the agency; negative impacts physically,
17	psychologically, socially, ethically, legally, and financially; and
18	
19	WHEREAS, "Hazardous Duty jobs" include employment duties
20	performed under circumstances in which an accident could result in serious
21	injury or death. The classification provides additional incentives and
22	assurances to professionals choosing careers in these fields and their
23	families.

25	RESOLVED, We urge the legislatures of the various States to classify
26	social workers employed by state and local governments as occupying
27	hazardous duty jobs entitled to the incentives and benefits of other state
28	positions possessing the same classification.
