#### **B1.** A Bill to Make Voting Compulsory

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** Voting on Election Day shall be compulsory for all citizens over the age of 18
- 3 **SECTION 2.** Voting shall be defined as casting a ballot. The citizen may vote for
- 4 no candidate in a specific race, but the citizen must cast a ballot.
- 5 **SECTION 3.** Patients in hospitals shall be exempt.
- 6 **SECTION 4.** Failure to vote will result in a \$500 fee for the first failure to vote. Fines
- 7 will be increased by \$500 for each subsequent failure.
- 8 **SECTION 5.** This law shall be enforced by the Department of Justice.
- 9 **SECTION 6.** This law shall take effect on January 1, 2020.

## B2. A Bill to Ban Animal Testing for Commerical and Scientific Use

1	BE IT ENACTE	D BY THIS STUDENT CONGRESS HERE ASSEMBLED THAT:		
2	SECTION 1.	SECTION 1. All animal testing will cease immediately and test animals will be		
3		relocated to nature institutes.		
4	SECTION 2.	Animal Testing may be defined as any scientific experiment or test in		
5		which a live animal is forced to undergo something that can cause them		
6		pain, suffering, distress, or lasting harm.		
7	SECTION 3.	The Public Health Service will oversee the implementation of this bill.		
8		A. The FDA and CDC operate underneath the Public Health Service.		
9	SECTION 4. T	his bill shall be enacted and carried out by the end of 2020.		
10	SECTION 5. A	All laws in conflict with this legislation are hereby declared null and void.

## **B3. A Bill to Phase Out the Federal Use of Private Prisons**

1	BE IT ENACTED BY THIS STUDENT CONGRESS THAT:		
2	SECTION 1.	The United States federal government will phase out the use of private	
3		prisons and/or for-profit prisons.	
4	SECTION 2.	A private prison or for-profit prison shall be defined as a place in	
5		which individuals are physically confined or incarcerated by a third	
6		party that is contracted by a government agency. Phase out shall be	
7		defined as the act of discontinuing a process or project.	
8	SECTION 3.	Immediately from passage, every year the United States will reduce	
9		the number of prisoners in private prisons by 20% from the number	
10		at the time of passage. Therefore in five years, the use of private	
11		prisons shall be completely phased out	
12		A. All contracts with private prison corporations shall be	
13		terminated and no new contracts shall be implemented.	
14	SECTION 4.	This legislation will go into effect immediately.	
15	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

## B4. A Bill to Prevent the Banning of Books in Public Libraries

1	BE IT ENACTED BY THIS STUDENT CONGRESS THAT:			
2	SECTION 1.	All books that are currently banned in public libraries will become		
3		available to the public.		
4	SECTION 2.	Banned books shall be defined as any books that have been placed on		
5		the banned book list by the American Library Association.		
6	SECTION 3.	The Department of Education will be responsible for identifying the		
7		public libraries not in compliance with this bill.		
8		A. The Office of Finance and Operations will oversee punishments		
9		for any public libraries violating this bill.		
10	SECTION 4.	This bill will go into effect immediately of passage and all books must be		
11		taken off the list within six months of this bill's passage.		
12	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

## B5. A Bill to Release All Individuals Detained at the U.S.-Mexico Border

1	BE IT ENACTED	RY THE	CONGRESS HERE	ASSEMBLED THAT:
		, , , , , , , ,	CONUNESSILENE	ASSEMBLED HIAL.

2 <b>SECTION 1.</b>	The United States must release all non-threatening individuals who are	
3	currently detained at the U.SMexico border.	
4 SECTION 2.	Non-threatening individuals refers to any individual not held at the	
5	border for violent or drug related reasons.	
6 SECTION 3.	The Homeland Security Department and the Department of Defense will	
7	oversee the enforcement of the bill.	
8	A. All released individuals shall be sent back to their country of	
9	origin within 30 days of the passing of this legislation.	
10 <b>SECTION 4</b> .	This policy shall go into effect immediately upon passage.	
11 <b>SECTION 5.</b>	All laws in conflict with this legislation are hereby declared null and void.	



#### B6. A Bill to Require Mental Health Training for Government Employees

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** All current and future government employees must complete a
- 3 government approved mental health first aid program every three years.
- 4 **SECTION 2.** Mental Health First Aid is an 8-hour course that teaches you how to help
- 5 someone who is developing a mental health problem or experiencing
- 6 a mental health crisis.
- 7 **SECTION 3**. The United States Department of Health will oversee the enforcement of
- 8 the bill.
- 9 A. This covers all governmental employees in the public sector.
- 10 B. Any company violating this bill will be fined \$250,000 per violation.
- 11 **SECTION 4**. This policy will go into effect at the start of the 2021 fiscal year.
- 12 **SECTION 5**. All laws in conflict with this legislation are hereby declared null and void.



### B7. A Bill to Forgive All Student Loan Debt after Five Years

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1	I. All current and future student loan debt held by individuals after five
3	years of qualifying payments shall be forgiven.
4 SECTION 2	2. Student loan debt refers to debt from loans for higher education,
5	qualifying payments refer to timely payments made toward paying off
6	student loans, forgiven means that the remaining money owed will be
7	the burden of the lender to cover.
8 SECTION	<b>3.</b> The United States Department of Education and the United States
9	Treasury will oversee the enforcement of the bill to ensure no violations
10	occur by lenders and that all qualifying payments are processed.
11	A. Any lenders found to still be collecting payments after the five years
12	of qualifying payments will be fined \$1 million per incidence.
13	B. All money collected from fines will be used to fund materials for
14	public schools in the United States.

- 15 **SECTION 4**. This policy will go into effect at the start of the 2021 fiscal year.
- 16 **SECTION 5**. All laws in conflict with this legislation are hereby declared null and void.

### B8. A Bill to Prohibit Discriminatory Data Practices to Protect Americans

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 <b>SECTION</b> 1	The United States government shall prohibit platforms, including but not limited to
3	Facebook and Google, from serving targeted ads that discriminate against groups
4.	by race, gender, and/or income.
5 SECTION 2	2. Discrimination shall be defined as the prejudicial treatment of different categories of
6	people. Platforms shall be defined as web-based technology that enables the
7	development, deployment and management of services including social media
8	solutions.
9 SECTION 3	3. The Federal Trade Commission (FTC) shall implement regulations prohibiting platforms
10.	from discriminating against consumers and the Internal Revenue Service (IRS) shall
11.	levy a tax on companies that do not follow regulations.
12.	A. The FTC will ensure that platforms comply with regulations by requiring
13.	platforms to disclose their data-sharing practices to the FTC for evaluation.
14.	B. The FTC shall work with the IRS to report platforms that continue to engage
15.	in discrimination. A tax of 13% shall be levied on companies that fail to comply

17 **SECTION 4**. This bill will be implemented by January 1, 2020.

18 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.



## B9: A Bill to Limit Vaccine Exemptions to Reinforce Herd Immunity

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 <b>SECTION 1.</b>	The USFG shall hereby require that for a child to be exempt from the CDC vaccination
3 based	schedule, the child's parents must provide written authorization from a doctor,
4	on health risks posed to the child.
5 <b>SECTION 2.</b>	The mandated vaccines are HepB, DTaP, HiB, PCV, IPV, MMR, Varicella, and HepA.
6	Parents failing to have their child vaccinated for any reason other than medical
7	exemption, will not be allowed to attend public school at any level. Herd immunity is
8	defined as a communal resistance to the spread of a contagious disease within a
9	population that results from 90% to 95% of individuals being vaccinated.
10 <b>SECTION</b> 3	3. The Department of Health & Human Services and the Department of Education will
11	work in conjunction to prevent unvaccinated children from attending school.
12	A. The Department of Education will share all vaccine information with the
13	Department of Health & Human Services.
14	B. Schools failing to meet the previously mentioned criteria, will be denied
15.	Federal education funding.
16 <b>SECTION</b>	<b>4</b> . This bill shall go into effect by August 2020.
17 SECTION	5 All laws in conflict with this legislation are bereby declared null and void

#### **B10:** A Bill to Ban Solitary Confinement

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **SECTION 1.** Solitary confinement shall be prohibited at all Federal Prisons across the United
- 3. States.
- 4 **SECTION 2**. Solitary confinement is defined as a prisoner who is kept away from other prisoners as
- 5. a form of punishment.
- 6 SECTION 3. The Federal Bureau of Prisons (BOP) shall oversee the enforcement of this bill.
- 7. A. The Federal Bureau of Prisons shall receive \$1 billion to overhaul the system.
- 8. B. Yearly audits shall be mandated across all businesses to ensure this bill is
- 9. being implemented properly.
- 10 **SECTION 4**. This bill will be enacted immediately upon passage.
- 11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.



#### B11: A Bill to Terminate the Environmental Protection Agency

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **SECTION 1.** The Environmental Protection Agency (EPA) shall be terminated and all of its
- 3. duties shall be distributed among agencies that hold jurisdiction over said duties.
- 4 **SECTION 2**. "Environmental Protection Agency" is defined as an agency of the Federal government
- 5. of the United States which was created for the purpose of protecting human health
- 6. and the environment
- 7. **SECTION 3.** The United States Congress shall oversee implementation of this bill and the
- 8. redistribution of the EPA's former duties.
- 9. **SECTION 4**. The bill shall be implemented on January 1<sup>st</sup>, 2020.
- 10 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## B12: A Bill to Withdraw Federal Funding from Cities that Violate Federal Laws and Regulations

#### 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **SECTION 1.** All cities in the United States that fail to abide by federal laws and regulations
- 3. shall lose all federal funding to that city from the United States Federal Government.
- 4 **SECTION 2**. "Federal funding" shall be defined as any monetary gains provided from the
- 5. federal government to actors outside of the federal government.
- 6. SECTION 3. The Office of Management and Budget shall oversee the implementation of this bill
- 7. **SECTION 4**. Implementation of this bill is immediate upon passage.
- 8 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

#### B13: A Bill to Audit the Federal Reserve

#### 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 3. Board and Federal Reserve banks within twelve months. This shall be an audit of
- 4 international financial transactions, actions on monetary policy matters, and
- 5. discussions or communications among Federal Reserve officers and employees
- 6. regarding these matters.
- 7. **SECTION 2**. "Audit" is defined as an official examination and verification of accounts and
- 8 records, especially of financial accounts.
- 9 **SECTION 3.** The Government Accountability Office shall be charged with overseeing and
- 10 executing the audit.
- 11 **SECTION 4**. Implementation of this bill is immediate upon passage.
- 12 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void

### B14: A Bill to Reopen the DACA Program

#### 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 <b>SECTION 1.</b>	DACA applications and the DACA program will be reopened to current or former		
3.	undocumented minors and those who were previously enrolled in DACA fitting the		
4	following criteria:		
5.	1. Were under the age of 31 as of June 15, 2012,		
6.	2. Came to the United States before reaching their 18th birthday,		
7.	3. Have continuously resided in the United States since June 15, 2007,		
8	4. Were physically present in the United States at the time of making their		
9	request for consideration of deferred action,		
10	5. Are currently in school, have graduated or obtained a certificate of completion		
11	from high school, have obtained a general education development (GED)		
12	certificate, or are an honorably discharged veteran of the Coast Guard or		
13	Armed Forces of the United States; and		
14	6. Have not been convicted of a felony significant misdemeanor, or three or more		
15	other misdemeanors, and do not otherwise pose a threat to national security or		
16	public safety.		
17 <b>SECTION 2.</b> A	A minor shall be defined as a person under the age of 18. Proof can include but is not		
18	limited to school enrollment papers, medical documentation, or lease or purchase of an		
19	apartment or house. Tax records of legal guardians may also be used.		
20 SECTION 3	This bill will be enforced by the Department of Homeland Security and the U.S.		
21	Citizenship and Immigration Service.		
22 <b>SECTION 4.</b>	This legalization will take effect at the beginning of the 2021 fiscal year.		
23. <b>SECTION 5.</b> All laws in conflict with this legislation are hereby declared null and void.

#### **B15: A Bill to Increase Cash Assistance for Needy Families**

#### 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **SECTION 1.** States will spend a minimum of 50% of federal funding received
- 3. through Temporary Assistance for Needy Families (TANF) block grants on cash
- 4 assistance for needy families.
- 5. **SECTION 2**. TANF block grants refers to states' fixed funding through the federal
- 6. assistance program established by the Personal Responsibility and Work
- 7. Opportunity Reconciliation Act of 1996. Cash assistance refers to monthly cash
- 8. benefits. Needy families refers to families who meet a given state's eligibility
- 9. standards for benefits.
- 10. **SECTION 3**. The Department of Health and Human Services is responsible for the enforcement of
- 11. this legislation
- 12. **SECTION 4**. This bill will be implemented at the start of the 2021 fiscal year.
- 13. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void

#### B16: A Bill to Eliminate Foreign Military Financing to Enemies of a Free Press

- 5. Borders and "is a snapshot of the media freedom situation based on an
- 6. evaluation of pluralism, independence of the media, quality of legislative

- 8. **B**. US Foreign Military Aid includes all aid labeled as "Foreign Military
- 9. Financing" (FMF) in the Congressional Budget Justification.
- 10. **SECTION 3. A.** The State Department will modify all aid budget requests to comply with
- 11. this legislation
- 12. **B.** Congress may not authorize budget allocation for Foreign Military Aid
- 13. to any country which has scored a 50 or higher on the WPFI in the year
- 14. preceding the budgetary allocation
- 15. **C.** Any existing deals for Military Financing for countries scoring higher
- 16. than 50 on the WPFI will be immediately nullified.
- 17. **SECTION 4.** This legislation will go into effect for the budget in Fiscal Year 2022.
- 18. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.



#### B17: A Bill to Prohibit Non-Biodegradable Products

#### 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **SECTION 1.** The sale of non-biodegradable products that have a known
- 3 biodegradable alternative is hereby prohibited in the United States.
- 4 **SECTION 2**. This legislation shall be implemented by the Environmental Protection
- 5 Agency (EPA).
- 6 A. The EPA shall independently define the terms "Biodegradable" and
- 7 "Non-biodegradable" as it relates to this legislation.
- 8 B. The EPA shall independently determine which products have a
- 9 biodegradable alternative.
- 10 **SECTION 3.** Companies or individuals found in violation of this legislation shall be
- issued a penalty of \$20,000 for the first offense, \$100,000 for the second
- offense, and \$500,000 for each offense thereafter.
- 13 **SECTION 4**. This legislation shall go into effect on January 1, 2023.
- 14 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.



#### B18: A Bill to Increase Political Transparency

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** All public corporations shall be required to publicly disclose all financial
- 3 contributions to political causes.
- 4 **SECTION 2.** "Public corporations" are defined as any issuers of securities registered
- 5 on national securities exchanges.
- 6 **SECTION 3.** This legislation shall be implemented by the Securities Exchange
- 7 Commission.
- 8 **SECTION 4**. This legislation shall go into effect on October 1, 2020.
- 9 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

- 2 **SECTION 1**. No-Cause Evictions are hereby prohibited in the United States.
- 3 **SECTION 2.** A "No-Cause Eviction" is defined as when a property owner orders a
- 4 tenant to vacate the rental unit prior to the conclusion of the rental
- 5 agreement without evidence that the tenant has violated the terms of
- 6 the rental agreement.
- 7 **SECTION 3.** Property owners shall retain the right to evict tenants with cause as
- 8 defined by their state.
- 9 **SECTION 4.** Property owners shall retain the right, without cause, to not renew rental
- 10 agreements at their conclusion.
- 11 **SECTION 5.** This legislation shall be enforced by the Department of Housing and
- 12 Urban Development.
- 13 **SECTION 6.** This legislation shall go into effect immediately upon passage.

## R1. A Resolution to Allow Me to Protect Myself

1	WHEREAS,	Many criminal offenses are committed on college campuses; and
2	WHEREAS,	There is little or no security in many areas of campuses; and
3	WHEREAS,	People on college campuses have no way to protect themselves from
4		constant reoccurring crimes such as: sex offenses, robbery, aggravated
5		assault, burglary, and motor vehicle theft; now, therefore, be it
6	RESOLVED,	By the Congress here assembled that anyone who has a concealed
7		handgun license (CHL) for the state in which they will be attending
8		college will be allowed to carry a handgun for protective purposes while
9		on the campus.

## R2. A Resolution to Promote Thorium Nuclear Power Plants

1	WHEREAS,	The EPA has stated that energy production accounts for 25% of global
2		greenhouse gas emissions; and
3	WHEREAS,	The UN has expressed concern for greenhouse gas emissions in terms of
4		global climate change; and
5	WHEREAS,	Nuclear energy production has no gas emissive byproducts; and
6	WHEREAS,	Nuclear energy is more cost effective than alternative fossil fuel energy
7		sources; and
8	WHEREAS,	Thorium is more useful for nuclear power generation in its naturally
9		occurring form than Uranium; and
10	WHEREAS,	Thorium is more naturally abundant than Uranium; and
11	WHEREAS,	Thorium requires less energy input to produce electrical power than
12		Uranium; and

4		competes with other wild species for land upon release; and

7	WHEREAS,	50% of Native Midwestern bee species have disappeared due to
8		other invasive species of bee in the past 100 years; and
9	WHEREAS,	four of the main American native bumblebee species have decreased by
10		96% due to loss of habitat taken by invasive species; and
11	WHEREAS,	bumblebees and other wild species are generalist pollinators that can
12		pollinate any type of flower; and
13	WHEREAS,	most wild species of bee are more effective pollinators than honeybees; and
14	WHEREAS,	the natural American ecosystem relies more heavily on the Native wild species
15		of bee rather than invasive species such as the honeybee; and
16	WHEREAS,	honeybees circulate less pollen back into the ecosystem, thus degrading the
17		growth of natural plants; therefore be it
18	RESOLVED,	By the Congress here assembled that the US ought to remove protections for
19.		honeybees and focus protections on wild bee species.

## R5. A Resolution to Raise the Poverty Line

12	and Alaska. They ignore the wide difference in the cost of living between
13	states; and
14 WHEREAS,	As a result, benefits buy more in rural areas, but the opportunities to find
15	a good job and escape poverty are in more urban areas; now, therefore, be it
16 <b>RESOLVE</b>	, By the Congress here assembled that the current poverty line rates be
17	increased by 25% (5% each year) by July 1st 18 , 2024.
