- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The United States Federal Government shall provide grants to all states
- for the implementation of a Universal Preschool program.
- 4 **SECTION 2.** States will be responsible for the distribution of grants and the
- implementation of the Universal Preschool programs.
- 6 SECTION 3. States shall retain the right to refuse the grant funding in Section 1 of this
- 7 legislation and the right to not establish a Universal Preschool program.
- 8 **SECTION 4.** Funding for the grants mandated by Section 1 of this legislation shall be
- derived from the Department of Education's Fiscal Year 2021 budget.
- 10 **SECTION 5**. This legislation shall be implemented by the Department of Education.
- 11 **SECTION 6.** This legislation shall go into effect on October 1st, 2021.
- 12 **SECTION 7.** All laws in conflict with this legislation are hereby declared null and void.

12	c. Lepor	nis macrochirus aka the common blue gill
13	d. Caras	sius auratus aka the common goldfish
14	SECTION 5.	Oversight will be held by the State Department of Game Fish and Parks.
15	SECTION 6.	This bill will be implemented on July 1, 2020

The Refugee Placement Act of 2019

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 SECTION 1. The Executive Branch of the United States shall have the authority to
- place accepted refugees in any location under the jurisdiction of the
- 4 United States.
- 5 **SECTION 2.** No state or local government shall have the authority to reject or protest
- refugees placed within their jurisdictions as a result of this Act.
- 7 SECTION 3. The Department of Homeland Security shall be tasked with ensuring that
- all accepted refugees are properly vetted.
- 9 SECTION 4. This Act shall be enforced by the Department of Justice, which shall have
- the authority to determine and assign penalties for violations.
- 11 **SECTION 5.** This Act will take effect immediately upon passage.
- section 6. All laws and executive acts in conflict with this legislation are hereby
- declared null and void.

The Tenant Protection Act of 2019

- BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. No-Cause Evictions are hereby prohibited in the United States.
- 3 SECTION 2. A "No-Cause Eviction" is defined as when a property owner orders a
- tenant to vacate the rental unit prior to the conclusion of the rental
- agreement without evidence that the tenant has violated the terms of
- 6 the rental agreement.
- 7 **SECTION 3.** Property owners shall retain the right to evict tenants with cause as
- 8 defined by their state.
- 9 **SECTION 4.** Property owners shall retain the right, without cause, to not renew rental
- agreements at their conclusion.
- 11 SECTION 5. This legislation shall be enforced by the Department of Housing and
- 12 Urban Development.
- 13 **SECTION 6.** This legislation shall go into effect immediately upon passage.
- SECTION 7. All laws in conflict with this legislation are hereby declared null and void.



A Bill to Reduce Gun Violence in America

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	Gun owners must register all guns built before 1950 to a national
3		database that will be controlled by the FBI.
4	SECTION 2.	A. Police may seize possession of all firearms of a person that is deemed
5		to be a threat to themselves or others by the court.
6		B. Anyone convicted of a violent crime may have their guns removed by
7		the police with a court order.
8	SECTION 3.	No gun magazine may be sold to the public that holds more than 15
9		rounds of ammunition at one time.
10	SECTION 4.	A. Anyone that owns or sells a weapon that is required to be registered
11		without proper registration can be held in a federal prison for up to 1
12		year and/or \$25,000 per count.
13		B. Anyone that owns or sells a gun magazine that holds more than 15
14		rounds of ammunition at one time can be held in a federal prison for up
15		to 1 year and/or \$25,000 per count.
16	SECTION 5.	This law will be implanted by the US Department of Justice
17	SECTION 6.	This law will go into effect on January 1, 2022.
18	SECTION 7.	All laws in conflict with this legislation are hereby declared null and void.



A Bill to Reinstate the Fairness Doctrine

- **SECTION 1.** The Fairness Doctrine will be re-implemented by the FCC as a governing policy.
- SECTION 2. The Fairness Doctrine shall be defined as the policy abolished by the FCC in 1987 that was primarily concerned with the news media providing a variety of viewpoints on any given topic.

The Agricultural Free Trade Act of 2020

- SECTION 1. The United States Federal Government shall cease providing monetary
- 3 subsidies to agricultural producers within the United States.
- 4 SECTION 2. The United States shall cease engaging in any and all trade activities with
- any foreign countries who provide monetary subsidies to agricultural
- 6 producers within their borders.
- 5 SECTION 3. This legislation shall go into effect on April 8th, 2025.
- 8 SECTION 4. All laws in conflict with this legislation are hereby declared null and void.

The Volunteer Army Act of 2019

A Bill to Legalize Medical Marijuana to Improve Public Health

3		marijuana and marijuana-derived products for medical use will become

6		doctor in the treatment of a medical condition.
7	SECTION 3.	The Federal Drug Enforcement Administration will be responsible for
8		overseeing the enforcement of this bill, which will include the
9		reclassification of marijuana.
10		A. The DEA will remove marijuana from the Schedule I list and move it to
11		a list that acknowledges its potential for medical use.
12	SECTION 4.	This bill shall become law immediately upon passage.
13	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

- 7 A. States will be responsible for distributing the appropriate grant funds
- 8 in Section 2 to their respective school districts.
- 9 SECTION 3. Funding for this legislation will be derived from the U.S. Department of
- Education's budget for the Fiscal Year 2021.
- SECTION 4. This legislation will go into effect starting in the Fiscal Year 2021.
- 12 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to repeal Loss of affection laws in South Dakota

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. Repeal all laws in South Dakota that allow a person to sue for civil damages under loss of affection from his or her spouse, that caused him or her to divorce.

SECTION 2. Loss of affection can be caused by another human(s) or other entity like a job.

SECTION 3. Enforcement will be through normal means.

SECTION 4. Law is in effect on July 1, 2020

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

The Biodegradable Materials Act of 2019

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The sale of non-biodegradable products that have a known

- 4 SECTION 2. This legislation shall be implemented by the Environmental Protection
- 5 Agency (EPA).
- A. The EPA shall independently define the terms "Biodegradable" and
- 7 "Non-biodegradable" as it relates to this legislation.
- 8 B. The EPA shall independently determine which products have a
- 9 biodegradable alternative.
- section 3. Companies or individuals found in violation of this legislation shall be
- issued a penalty of \$20,000 for the first offense, \$100,000 for the second
- offense, and \$500,000 for each offense thereafter.
- 13 **SECTION 4.** This legislation shall go into effect on January 1, 2022.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

- 7 c. All cameras at stoplights will be used for monitoring traffic, not ticketing.
- d. Federal inspectors inspect every 6 months to ensure operation of said cameras.
- e. Funding used for infrastructure, installation, and operation.
- 10 f. Any and all funding acquired via deficit spending.
- 11 Section 2. Federal oversight by the Federal Department of Transportation, and local
- oversight by State Department of Transportation
- 13 **SECTION 3.** This bill will be implemented on July 1, 2020

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2	RESOLVED,	By two-thirds of the Congress here assembled, that the following article
3		is proposed as an amendment to the Constitution of the United States,
4		which shall be valid to all intents and purposes as part of the Constitution
5		when ratified by the legislatures of three-fourths of the several states
6	A ·	within seven years from the date of its submission by the Congress:

ARTICLE 28

7

- SECTION 1. No inmate in any prison or jail within the jurisdiction of the United States
 shall be confined alone in a cell without the opportunity to see or speak
 to other persons for more than fourteen (14) hours in one day.
- SECTION 2. Any violation of Section 1 of this article shall be considered an act of

 Cruel and Unusual Punishment under the 8th article of amendment to the

 United States Constitution.
- SECTION 3. The Congress shall have power to enforce this article by appropriate legislation.

The Healthcare Security Act of 2020

- BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- SECTION 1. No employer, public or private, may require a waiting period after the beginning of employment for any health insurance benefits to become
- 4 effective.
- 5 **SECTION 2.** For the purposes of this legislation, "health insurance benefits" shall be
 6 defined as any employee compensation benefits consisting of medical
 7 care (provided directly, through insurance or reimbursement, or
 8 otherwise and including items and services paid for as medical care)
 9 under any hospital or medical service policy or certificate, hospital or
 10 medical service plan contract, or health maintenance organization
 11 contract offered by a health insurance issuer.
- SECTION 3. This legislation shall go into effect on July 3rd, 2021.
- SECTION 4. All laws in conflict with this legislation are hereby declared null and void.

A Bill to create Daycare Reimbursment

4		care for their own kids are not eligible for reimbursement.
5	SECTION 2.	All costs for daycare will be paid for by the United States federal
6		government.
7	SECTION 3.	Only children at daycares licensed by the state or city will be eligible for
8		reimbursement. Funding for this bill will be provided by a .1% increase in
9		the federal income tax.
10	SECTION 4.	This bill will be implemented beginning August 1, 2020.
11	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.
