Maximum entries: Six students per school in varsity (open); and four students per school in novice. Novice is defined as a student never having competed in speech, debate, or congressional debate before the current year.

Spring Coaches Meeting:

Provide these award nominations to Jose by February 5th. There is no official nomination form. Nominations have tended to take the form of a short statement or short essay about the coach/student, usually a page or less.

James Akin Award:

In memorial of James Akin, an award in his name will be given out to one 12th grade student demonstrating excellence in forensics.

Speech Coach of the Year, Debate Coach of the Year:

Each NMSDA member school shall be allowed to nominate one member coach for Coach of the Year in both Speech and Debate. The criteria for nominating a coach: the coach must be a coach at a New Mexico school, this person should be an exemplary coach. An assistant coach may be nominated. An exemplary coach exhibits these qualities:

- Dedication to speech & debate
- Helpfulness to other coaches and students
- Involvement in Speech & Debate Activities
- Sportsmanship
- Have a successful speech & debate program
