

## **A BILL TO BAN WASTE DUMPING INTO THE PUBLIC WATERS**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States will move toward a sustainable recycling equilibrium whereby  
3 waste that is not organic, and organically degradable shall not be allowed to fall  
4 into the public waters.

5 **SECTION 2.** For the purposes of this "waste" shall be defined as post-consumption materials  
6 that are discarded. "Organically degradable" shall be defined as materials  
7 without significant molecular alteration that cannot return to a humus state  
8 within a few years. "Public waters" are defined as rivers, lakes, ponds, and  
9 beaches under the jurisdiction of the United States.

10 **SECTION 3.** The United States National Oceanic and Atmospheric Administration and the  
11 Environmental Protection Agency shall be tasked with implementing a measure  
12 to enforce this legislation.

13 **SECTION 4.** This bill will provide for a long and short term path to full compliance by the year  
14 2028.

15 **SECTION 5.** All laws in conflict with this legislation are hereby superseded.

## **A BILL TO UNIONIZE THE AMERICAN WORKFORCE**

1     BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2     **SECTION 1.** Any person seeking to join the United States workforce must become a member  
3                     of a labor union, except for managers and business owners.

4     **SECTION 2.** A labor union is defined as an organized group of workers who unite to make  
5                     decisions about conditions affecting their work as well as bring economic justice  
6                     to the workplace and social justice to our nation.

7     **SECTION 3.** The U.S. Department of Labor Relations shall oversee the implementation of this  
8                     bill.

- 9             **A.**     If a worker is not in a union, the business they work for will be fined  
10                    \$2,000 per non-union worker, and will be inspected monthly. This fine  
11                    will be adjusted each year according to inflation.
- 12            **B.**     Each time a company fails to have their workers unionized, the fine will be  
13                    increased by 10%.
- 14            **C.**     If a business outsources more than 500 jobs, all Federal contracts will be  
15                    canceled with said business.
- 16            **D.**     All employers are required to inform their employees of the new law. If a  
17                    business fails to comply with that requirement, said business will be fined  
18                    \$500.

19    **SECTION 4.** This law will go into effect one month after its passage.

20    **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## **A BILL TO PROHIBIT ILLEGAL IMMIGRANTS FROM OBTAINING A DRIVER'S LICENSE**

1     BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2     **SECTION 1.** It will now be illegal for any undocumented immigrant to obtain a driver's license  
3                     and any undocumented immigrant who currently holds a driver's license will be  
4                     able to keep it until its expiration date. Once the license expires, the immigrant  
5                     may either leave the country, not drive, or try to become a citizen.

6     **SECTION 2.** "Illegal Immigrant" is defined as any foreigner who enters the U.S. without an  
7                     entry or immigrant visa, especially a person who crosses the border by avoiding  
8                     inspection or who overstays the period of time allowed as a visitor, tourist, or  
9                     businessperson. "Driver's License" is defined as a document that permits a  
10                    person to drive a motor vehicle.

11    **SECTION 3.** The Department of Motor Vehicles and the Department of Homeland Security  
12                    will enforce this bill.

13    **SECTION 4.** This bill shall be implemented on July 1, 2020.

14    **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A BILL TO REQUIRE PEOPLE IN APPOINTED OR ELECTED OFFICES  
IN PUBLIC EDUCATION POSITIONS TO HAVE A BACKGROUND IN EDUCATION**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** This bill would require people running for positions dealing with education,  
3 superintendents, for example, to have a background in education This would  
4 cut down on problems in our education system because people with  
5 backgrounds in education would determine the future of education for the years  
6 to come.

7 **SECTION 2.** Superintendents: In the United States, a superintendent or superintendent of  
8 schools is an administrator or manager in charge of several public schools or a  
9 school district, a local government body overseeing public schools.

10 **SECTION 3.** The Department of Education will oversee this bill.

11 **SECTION 4.** This law will go into effect on January 2021.

12 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## A BILL TO BAN THE USE OF SOLITARY CONFINEMENT

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The use of Solitary Confinement as a means of punishment for prisoners is  
3 hereby banned in all fifty states and the territories of the United States of  
4 America.

5 SECTION 2. Solitary Confinement shall be defined as the isolation of a prisoner in a  
6 separate cell for long periods of time as a punishment.

7 SECTION 3. The Federal Bureau of Prisons shall oversee the implementation of this  
8 legislation and The Department of Justice has the authority to enforce this  
9 legislation.

10 A. This legislation shall extend to privately owned prisons.

11 SECTION 4. This legislation will go into effect 6 months after passage to allow ample  
12 time for prisons, The Department of Justice, and the Federal Bureau of  
13 Prisons to make necessary changes and create new rules.

14 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A BILL TO IMPROVE ACCESSIBILITY TO AFFORDABLE PRESCRIPTION DRUGS

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1.

3 A. The Secretary of Health and Human Services shall, within 80 days of  
4 enactment of this bill, issue regulations allowing wholesalers, licensed U.S.  
5 Pharmacies, and individuals to import qualifying prescription drugs manufactured  
6 at FDA-inspected facilities from certified Canadian sellers. After two years, the  
7 Secretary shall have the authority to permit importation from certified foreign  
8 sellers in countries in the Organization for Economic Co-operation and  
9 Development (OECD) that meet specified statutory or regulatory standards that  
10 are comparable to U.S. standards.

11 B. The Secretary of Health and Human Services shall now have the appropriate  
12 authority to negotiate pharmaceutical prices on behalf of Medicare Part D.

13 SECTION 2.

14 A. Certified foreign sellers are defined as firms that (1) have been in  
15 existence for at least five years and has a purpose for existing other than for this  
16 program; (2) if selling to an individual, does so only after receiving a valid  
17 prescription; (3) can certify that the physical premises and data reporting  
18 procedures and licenses are in compliance with all applicable laws and regulations  
19 in Canada, and has implemented policies to monitor compliance; (4) conduct  
20 ongoing and comprehensive quality assurance programs, including blind testing;  
21 (5) agree that laboratories approved by the Secretary shall be used to test product  
22 samples; (6) receive a certification from the Secretary of Health and Human  
23 Services that they meet the above criteria, including any new regulations  
24 determined by the Secretary of Health and Human Services, and renew their  
25 certification every two years.

26 B. Qualifying prescription drugs must have the same active ingredient(s), route  
27 of administration, strength as drugs approved in the U.S, and exclude controlled  
28 substances, anesthetic drugs inhaled during surgery, or compounded drugs.

29 SECTION 3. The Department of Health and Human Services shall oversee  
30 implementation of this law.

31 A. Funds necessary to administer Section 1A shall come from an annual fee  
32 paid by certified foreign sellers set by the Secretary of Health and Human  
33 Services.

34 SECTION 4. This bill shall take effect immediately upon passage.

35 SECTION 5. All laws in conflict with this legislation are hereby amended to comply  
36 with it.



# A Bill to Encourage Mexico to Secure the U.S. Southern Border by Ending All Foreign Aid to Mexico

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. Until the United Mexican States proscribes security measures that will  
3 secure their northern border with the United States of America, including  
4 an effective barrier, border patrols, and other preventative measures,  
5 The United States of America will end all foreign aid to the United  
6 Mexican States.

7 SECTION 2. Foreign aid will be defined as any assistance given by the United States to  
8 Mexico. The aid has traditionally been given through the U.S. Agency for  
9 International and Peace Corps.

10 SECTION 3. The State Department will oversee the implementation of this legislation.

11 SECTION 4. This legislation will go into effect immediately after its passage.

12 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
