

2020 OCSL Spring Invite Legislation

A Resolution to Reverse the Military Withdrawal in Afghanistan to Ensure Peace

1 **WHEREAS,** The Afghan Government and the Taliban have had recurrent peace talks
2 yet no progress has been made; and
3 **WHEREAS,** The Taliban have continued to launch attacks against innocent civilians
4 and government institutions in spite of the peace accords; and
5 **WHEREAS,** Afghanistan doesn't have the military power to hold off the Taliban on its
6 own; and
7 **WHEREAS,** A lack of American presence would mean a potential civil war between
8 rival militias and factions could break out; now, therefore, be it
9 **RESOLVED,** That the Congress here assembled make the following
10 recommendation for reversing the withdrawal from Afghanistan.

A Bill to Restore Voting Rights to Convicted Felons

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States will restore federal voting rights to all individuals
3 previously convicted of a felony upon the completion of their sentence.

4 **SECTION 2.** Completion of sentence will be defined as having served out the
5 completion of their incarceration, parole or probationary period and paid
6 all fines and restitutions.

7 **SECTION 3.** This law shall be enacted immediately. Individuals who have had their
8 voting rights restored will be eligible to vote in the 2020 Presidential election
9 cycle.

10 **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Protect Journalists Across the World to Ensure Freedom of the Press

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** A tariff on any and all produced or shipped raw materials shall be placed on
2 countries whose governments have executed or allowed the murder of a
3 journalist within the past year.
- 4 **SECTION 2.** A. Tariff shall be defined as an import tax of 15%.
5 B. Raw materials shall be defined as any basic resource used to make
6 products
- 7 **SECTION 3.** The Department of State, the Central Intelligence Agency, and the
8 Department of Commerce shall oversee implementation of this bill.
9 A. The Department of State and Central Intelligence Agency in conjunction
10 shall create a Bureau Journalism Committee that shall review
11 executions in countries that report raw materials to the U.S. every year
12 to determine if tariffs need to be lifted or imposed.
13 B. The Department of Commerce shall oversee implementation of tariffs.
- 14 **SECTION 4.** This bill will take into effect immediately after passage.
- 15 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Expand the War on Drugs

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** 100 million dollars should be allocated to JIATF-W for the purpose of interdicting
3 the trafficking of fentanyl.

4 **SECTION 2.** Joint Interagency Task Force West (JIATF-W) shall be defined as an executive
5 agency under US Pacific Command (USPACOM) which specializes in counter-
6 narcotics operations. Fentanyl shall be defined as a synthetic opioid 50 times
7 more potent than heroin.

8 **SECTION 3.** USPACOM will oversee the allocation of funds to JIATF-W.

9 **SECTION 4.** The bill will be implemented immediately upon passage.

10 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

Finals Legislation

A Bill to Bust Digital Trusts

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** A. Alphabet, the parent company of Google, shall be required to relinquish
3 AdMob and Doubleclick. Facebook shall be required to relinquish Instagram and
4 WhatsApp. Amazon shall be required to relinquish Whole Foods.

5 B. The Department of Justice shall investigate Alphabet, Facebook, and Amazon
6 for violation of antitrust laws. The DOJ shall be given the authority to mandate
7 the relinquishment of further subsidiaries or impose other necessary penalties in
8 order to prevent monopolistic behavior.

9 **SECTION 2.** Monopolistic behavior shall be defined as actions that a firm with significant and
10 durable market power takes to raise prices or exclude competitors.

11 **SECTION 3.** The Department of Justice and the Federal Trade Commission shall oversee the
12 implementation of this bill.

13 **SECTION 4.** This bill shall go into effect on Jan 1, 2021

14 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

1 **WHEREAS**, There have been multiple mass shootings with the use of assault weapons, making
2 it evident that reform is needed; and,
3 **WHEREAS**, Assault weapons are defined as a weapon that can fire off more than one round at
4 a time; and,
5 **WHEREAS**, 1,719 Americans have been killed and 6,510 have been injured in mass shootings
6 since 2013; and,
7 **WHEREAS**, In mass shootings between 2009 and 2015, incidents where assault weapons or
8 large capacity ammunition magazines were used resulted in 155% more people
9 shot and 47% more people killed compared to other incidents; now, therefore, be
10 it
11 **RESOLVED**, By the Congress here assembled that assault weapons no longer be available to
12 civilians.
