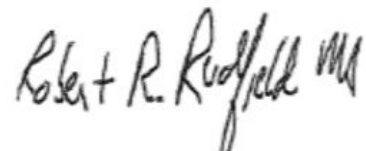
To the Speaker of the House,

On October 26, 2020, the Federal Elections Commission announced that it had uncovered a significant number of cases of voter suppression and electoral fraud in the 2020 presidential election, and sought a response to these concerns from Congress as it deemed appropriate. In response to said concerns, Congress passed A Bill to Safeguard Democracy, which delayed the 2020 election day until January 5, 2021, and mandated that said elections be held entirely in person. In response to the delaying of the election, riots broke out across the country.

This letter presents the significant findings and recommendations of the CDC, which are the product of numerous discussions and a thorough review of case reports. As a result of the riots, we have determined that 15 million people in all 50 states and the District of Columbia have now been infected with the outbreak strain of COVID-19. This number will inevitably increase in the coming weeks. Nearly all hospitals have been overrun to maximum capacity with an influx of COVID-19 patients, and 800,000 new deaths have already been reported thus far, also in all 50 states and the District of Columbia.

The CDC will provide more information as it becomes available. However, we have concluded that a strong Congressional response is required. We highly recommend that said response include - but not be limited to - lockdowns, curfews, quarantines, and any similar type of restrictions as deemed necessary; mask-wearing mandates; enhancement of the nation's public health infrastructure, including public health campaigns as well as our COVID-19 testing, contact tracing, and personal protective equipment (PPE) procurement capabilities; and the immediate facilitation and acceleration of the development, manufacturing, and distribution of COVID-19 vaccines, therapeutics, and diagnostics.

We urge this Congress to act on the gravity of this public health crisis. With the lives of millions of Americans at stake, it is imperative to put politics aside in order to make coordinated efforts to address this COVID-19 outbreak. It is our belief that the incorporation of these recommendations into our nation's public health policy will help the nation better recover from the full impact and the long-term consequences of this COVID-19 outbreak.

FBK News Update

In response to the CDC's report regarding the COVID outbreak across all 50 states, Congress has called an emergency session to discuss the United States'. The following provisions have been introduced:

Responsive:

- Federal Emergency Management Agency (FEMA) funding shall be reallocated as necessary in order to provide debt relief for small businesses and hospitals and medical debt relief for the general population.
- A national mask mandate along with a 6-week lockdown and border closing shall be enforced
- A global partnership shall be established between China and the United States on joint research and vaccine development
- The United States Congress shall exercise its authority to invoke martial law in all 50 states and Washington D.C., which shall be enacted via the National Guard and mobilization of the United States Armed Forces.

Prevention:

- The United States shall stay a part of the World Health Organization (WHO) and allocate \$500 million towards WHO yearly
- CDC funding shall be increased by 50%, funding for the production and procurement of personal protective equipment (PPE) for healthcare professionals shall be doubled, and funding shall be allocated to emergency clinics to lessen hospital burdens.
- Public health campaigns such as health literacy plans and advertisements on preventative measures will be implemented.
- Non-compliance with CDC guidelines on mask-wearing and social distancing shall be classified as a misdemeanor in the United States penal code, punishable by a \$300 fine. Multiple citations shall result in imprisonment

Using the provisions above, your job as United States Senators is to craft a coherent plan to combat the current crisis. There are no restrictions in crafting your plan.
