Judges & Fees

Judges supplied by a school are obligated one round beyond their team's elimination in that event. Failure to meet this obligation will result in the school being charged for a hired judge to cover that round. We require teams to provide:

- 1 judge per 2 Policy teams
- 1 judge per 2 Lincoln-Douglas entries
- 1 judge per 2 Public Forum teams
- 1 judge per 6 Congressional Debate entries

A limited number of judges will be available for hire through the tournament. If you wish to hire a judge through the tournament, it will be necessary to know this by January 14th, 2021. After that date, please contact us to see if we can make arrangements.

Fees associated with hiring tournament judges are:

- \$250.00 per Policy debate judge (to cover two entries or portion thereof)
- \$250.00 per LD debate judge (to cover three entries or portion thereof)
- \$250.00 per Public Forum judge (to cover two entries or portion thereof)
- \$15.00 per Congress judge per entry

Additional Issues and Information

For events which are designed to be team events (Policy and Public Forum debate), registration must be done as a team. Registration for team events as a single participant will not be allowed. If unforeseen circumstances such as illness or injury creates a need for a partner to drop out, the other partner may compete solo; but we will not advance solo or "maverick" team(s) to elimination rounds. We will not accept Independent entries to the tournament. All competing students must be entered with the approval of the school they are representing. Each Individual entered in a novice division event must be a competitor in their first year of debate competition. This means if the student has earned any NSDA points prior to August of this year, they are not a novice. If they had 1 competition last year, but was for a different event we will not accept their entry at the novice level. If you believe an exception should be made, contact me or Laurie to submit a request.

Issues may arise prior to or during the tournament that have not been addressed in this invitation. These issues need to be brought to the attention of the tournament director who will work to resolve the issue and/or make a final decision.

Policy Debate

Both divisions of Policy debate will use the 2020-2021 National Speech and Debate Coaches Association Policy Debate resolution: Resolved: The United States federal government should enact substantial criminal justice reform in the United States in one or more of the following: forensic science, policing, sentencing".

Only teams with a winning record will break. We will be offering strikes in the Varsity division. The strike list will be released the Tuesday before the start of the tournament.
