

A Bill to Join the Belt and Road Initiative

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** In order to circumvent Chinese domination in global affairs, the United
3 States shall hereby join the Belt and Road Initiative.

4 **SECTION 2.** The Belt and Road Initiative shall be defined as a transcontinental long-
5 term policy and investment program which aims at infrastructure
6 development and acceleration of the economic integration of countries
7 along the route of the historic Silk Road.

8 **SECTION 3.** The Bureau of International Organization Affairs and the Department of
9 State, in conjunction, will oversee the implementation of this bill.

10 **SECTION 4.** This legislation will go into effect on October 1st, 2021.

11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to End the Oppression of the Uyghur Muslims

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States shall impose agricultural tariffs on China to end the
3 oppression of the Uyghur Muslims and cease the use of re-education
4 camps.

5 **SECTION 2.** A. Re-education camps shall be defined as internment camps for people
6 accused of religious extremism under the Xinjiang government in China.

7 B. Agricultural tariffs shall be defined as a tax or duty imposed on
8 imported Chinese goods including but not limited to soybeans, cotton,
9 and animal products.

10 **SECTION 3.** The Department of Commerce will work in conjunction with the
11 Department of State to implement this legislation.

12 A. The Department of State shall monitor China's actions against the
13 Uyghur Muslims until a significant decrease is seen in ending their
14 oppression.

15 **SECTION 4.** This bill shall be implemented on January 1, 2021.

16 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Send Aid to the Northern Triangle

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** A. The United States government shall increase foreign assistance by
3 giving 1 billion dollars of foreign aid, through local NGOs, to the countries
4 of Honduras, Guatemala, and El Salvador.

5 B. The United States shall reinstate counternarcotic operations in all
6 three countries with 25% of the aid.

7 **SECTION 2.** A. Foreign aid shall be defined as economic, developmental, and
8 medicinal aid.

9 B. Counternarcotic operations shall be defined as measures or activities
10 designed to prevent the use or distribution of illegal narcotic drugs in the
11 Northern Triangle.

12 **SECTION 3.** United States Agency for International Development (USAID) shall work
13 in conjunction with the United States Drug Enforcement Agency (DEA) to
14 distribute aid to local NGOs and establish counternarcotic programs.

15 A. If found to be abused in the Northern Triangle, aid will be revoked
16 and counternarcotic programs will be shut down.

17 **SECTION 4.** This bill will be implemented on January 1, 2021.

18 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
