- Waivers for Each Student Competing

Impromptu and Extemp are Live. Students will speak in the order they are listed on Tabroom. Rounds will occur on NSDA Campus. Students can only compete in Extemp or Impromptu (NOT BOTH) If students are registered in both, there will be no refund after the deadline and one of the entries will need to be dropped.

Debate is live. Rounds will occur on NSDA Campus

Other IEs are recorded. These will be listed as 'link sharing only' on youtube and links will be posted on specific entries. These are due on September 28th at 4pm.

IE piece information needs to be uploaded to Tabroom by September 28th at 4pm. Failure to upload piece information will result in an inability to compete with no refund.
