A Resolution to Establish a National High-Speed Rail System

WHEREAS, Our countries' public transportation system consistently lags behind other countries despite plentiful tax funding; now, therefore be it
RESOLVED, By the Congress here assembled that grants shall be set aside to establish a national high-speed rail system.

The Insulin for All Act of 2020

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. The United States shall place price caps on all insulin products to only \$25 dollars per vial.
- **SECTION 2**. A. Insulin products shall be defined as any pharmaceutical drug that contains the protein insulin
 - **B**. A vial shall be defined as 10ml of the insulin product
- SECTION 3. The Food and Drug Administration as well as The U.S. Department of Health and Human Serviced shall oversee the legislation.
 - A. For every insulin vial sold at a price exceeding \$25, the corresponding pharmaceutical company shall be fined \$1,000 per vial until the price cap is upheld
- **SECTION 4.** The bill shall be implemented by October 2020.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to End U.S. Colonial Rule of Puerto Rico

BE IT HERE ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. Puerto Rico became a colony of the United States after the Spanish-American War in 1898, forcing the people on the island to live under U.S. rule.
- SECTION 2. The Commonwealth of Puerto Rico shall be released from the jurisdiction of the United States of America, ending U.S. colonial rule and granting the Commonwealth independence.
- SECTION 3. The United States will assist Puerto Rico in the drafting of their constitution, recognizing Puerto Rico as a sovereign nation upon completion of the processes needed to ensure self-governance and financial stability.
- SECTION 4. The Governor of Puerto Rico, the U.S. Department of State, the U.S. Department of the Interior, as well as any other needed bodies, including Congress, will oversee the the implementation of this bill as needed, including providing material support yet to be determined.
- SECTION 5. This legislation will take effect gradually between the passage of this bill and January 1, 2025.
- SECTION 6. All laws in conflict with the legislation are hereby declared null and void.

- **B.** Only two of the new justices may identify as male.
- **C.** The filibuster on judicial nominations shall be restored after the four openings have been filled.
- **SECTION 3.** The Senate Judiciary Committee shall be responsible for the implementation of this bill.
- **SECTION 4.** This bill shall be implemented upon passage.

- SECTION 1. Section 1979 of the Revised Statutes (42 U.S.C. 1983) is amended by 2 adding at the end the following: "It shall not be a defense or immunity to 3 any action brought under this section that the defendant was acting in 4 good faith, or that the defendant believed, reasonably or otherwise, that 5 his or her conduct was lawful at the time when it was committed. Nor 6 shall it be a defense or immunity that the rights, privileges, or immunities 7 secured by the Constitution or laws were not clearly established at the 8 time of their deprivation by the defendant, or that the state of the law 9 was otherwise such that the defendant could not reasonably have been 10 expected to know whether his or her conduct was lawful." 11 The judicial branch of the United States Federal Government will be SECTION 2.
- SECTION 2. The judicial branch of the United States Federal Government will be tasked with ensuring prior immunities are no longer applied following the passage of this bill.
- 15 **SECTION 3.** This bill will go into effect immediately upon passage.

A Resolution to Fund the Offshore Wind Industry to Create Clean Energy

WHEREAS, The United States has a large offshore wind energy resource that is ready to be utilized; and

WHEREAS, US shores currently possess a power potential of over 2,000 gigawatts or nearly double the nation's current electricity usage and will be able to generate electricity for more than 115 million US households; and

WHEREAS, Offshore Wind Energy has the potential to deliver large amounts of clean reliable energy and reduce pollution oil spills; and

WHEREAS, Funding this industry will result in more than 200,000 jobs being created which is about twice the number of jobs being created by other sources of energy such as offshore drilling; and

WHEREAS, Offshore Wind Energy will also help create more jobs in the shipbuilding and manufacturing industry further fueling the US economy; and

WHEREAS, Wildlife and marine ecosystems are positively impacted by offshore wind farms due to the fact that they act as effective marine reserves; and

WHEREAS, Wind farms can act as artificial reefs and protection from fishing pressures creating extremely positive effects; and

RESOLVED, By the Congress here assembled that the United States shall fund the Offshore Wind Industry to Create Clean Energy.

A Bill to Eliminate the Department of Defense's Hand-Me-Downs

A Bill to Enact a National Mask Mandate

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. Everyone in the United States is required to wear a mask in public spaces..
- **SECTION 2.** "Public spaces" shall be defined as places in which a person could come into contact with people who aren't family members or others who share the same home.
- SECTION 3. The U.S. Department of Health and Human Services shall work with state governments to enforce this mandate. Those for whom mask usage would put their life at risk are excused from this
- **SECTION 4.** This legislation will take effect immediately upon passage. All laws in conflict with this legislation are hereby declared null and void.
