

A Bill to Save Bambi

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** 1a: All teachers K-12 in any American territories and 50 states shall be
2 allowed to carry firearms on their person in order to ensure the safety of
3 themselves and their students.

4 1b: States may not require teachers to disclose their permit-permitted
5 ownership or possession of a firearm to school districts.

6 **SECTION 2.** "Teachers" shall be defined as an individual who holds a bachelor's degree
7 in any subject, be eligible to work in the United States, pass the required
8 state exams, and is employed by a public or private educational institution.

9 "Firearms" shall be defined as any weapon which will or is designed to or
10 may readily be converted to expel a projectile by the action of an
11 explosive.

12 **SECTION 3.** The Bureau of Alcohol, Tobacco, Firearms and Explosives and the
13 Department of Education shall oversee the implementation of this bill.
14 Individual states, along with their school districts, will work to
15 implement this legislation with the Federal government.

16 **SECTION 4.** This legislation will take effect on August 1, 2021.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Fill the 'Missing Middle'

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** All single-family home zoning laws shall be abolished to encourage the
2 building of multi-family housing.
- 3 **SECTION 2.** A single-family home is defined as a detached residential property under
4 the ownership of one individual or household. 'Missing Middle Housing'
5 refers to residential buildings between single-family homes and mid- or
6 high-rise apartment buildings (duplexes, townhomes, courtyard
7 apartments, etc.)
- 8 **SECTION 3.** The Department of Housing and Urban Development will oversee the
9 implementation of this bill.
- A. Any residential lot may hold a building with up to three units.
- SECTION 4.** The bill shall be implemented immediately upon passage.
- SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

Bill to Ban all Athletes who kneel for the National Anthem

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

1. **SECTION 1.** The United States Government shall ban all athletes, who kneel for the
2. National Anthem.
3. **SECTION 2.** A ban would be defined as being officially or legally prohibited from
4. playing the sport professionally.
5. **SECTION 3.** The US Department of State's Sports will oversee this bill. Any athlete that
6. will kneel for the National Anthem will be banned from playing the sport
7. professionally for 2 years.
8. **SECTION 4.** This bill will be implemented on January 3, 2021.
9. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
