An Act to Prevent Total Nuclear War

A Bill to Protect America's Youth

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- **Section 1**. To protect America's youth from further emotional damage, this bill makes it so that any convicted rapist cannot apply for custody of a child conceived through rape. The parental rights of convicted rapists are terminated at the time of conviction.
- Section 2. Convicted shall be recognized as being found guilty of a criminal offense by the verdict of a jury or decision of a judge in court of law. A rapist is recognized as someone who has committed rape, the unlawful sexual intercourse carried out forcibly, under threat, and/or injury. The legal concept of parental rights refers to a parent's right to make decisions regarding a child's education, health care, religion, etc.. If parents are separated or divorced, these rights can extend to custody and visitation. The termination of parental rights refers to the action of ending the legally recognized parent-child relationship.
- **Section 3.** The implementation of this bill will likely reduce legal costs, but any additional funding will be provided from Child Protective Services.
- Section 4. This bill will come into effect one (1) year after passage.
- Section 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Legalize Physician-Assisted Death
