### **A Resolution to Defund the Police**

1   **WHEREAS,**   the current over-funded and unchecked system of policing has roots in cruel and  
2                   inhumane slave patrolling and continues to disproportionately affect racial  
3                   minorities with warrior training, racial profiling, and a lack of accountability; and  
4   **WHEREAS,**   nationally, after calculating for inflation, funding for police has risen from \$42  
5                   billion dollars to \$115 billion dollars in 40 years while funding for important  
6                   social services has been cut 26% or \$13 billion dollars; and  
7   **WHEREAS,**   in 2019, 1,092 people were killed by the police force, with Black individuals 2.5  
8                   times more likely to be killed than White individuals, disproportionately  
9                   affecting racial minorities; and  
10  **WHEREAS,**   comprehensive law enforcement reforms have failed to improve the police force,  
11                  leading policy experts to believe decreasing contact between the police force and  
12                  civilians is the only way to decrease needless deaths, while social services have  
13                  been proven to decrease crime; and  
14  **WHEREAS,**   decreasing funding for police departments would undermine their fiscal and  
15                  political power and decrease contact between the police force and civilians while  
16                  increasing funding towards under-funded social services.  
17  **THEREFORE,** Be it resolved by this Student Congress here assembled that: the police shall be  
18                  defunded, with excess capital redistributed to programs such as education,  
19                  infrastructure, healthcare, and social services. (the resolution should be a clear  
20                  call for action).

## **A Bill to Place Sanctions on China**

10 **ARTICLE IV.** The U.S. Department of Treasury shall be responsible for the implementation of  
11 this legislation.

12 **A.** The U.S. Department of Defense will supply a quarterly report to determine  
13 whether Chinese military aggression has halted.

14 **ARTICLE V.** All laws in conflict with this legislation are hereby declared null and void.

## **A Bill to Fund Election Security**

10 against them.

A. \$25 billion dollars shall be allocated to the Centers of Diseases and Prevention (CDC) for the purpose of enhancing immunization nationwide.

B. The CDC shall distribute the vaccines and ancillary supplies to both public and private healthcare entities who have the capabilities of supplying the vaccine to the general public.
