A Bill to Outlaw Corporate Lobbying

1	BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1. All corporate lobbying that aids the campaign for or against a political candidate
3	or piece of legislation is declared illegal.
4	SECTION 2. "Corporate lobbying" is defined as financial contributions towards a political
5	party or political candidate by a corporation through a lobbyist.
6	SECTION 3. A. The Department of Justice, alongside the Secretary of the Senate and the Clerk
7	of the House, shall be responsible for enforcing the provisions of this bill.
8	B. Congresspeople found guilty of accepting lobbying money will face a fee
9	starting at \$130,500 and increasing depending on the amount of money accepted,
10	which will be determined by this bill's enforcers.
11	C. Corporations found guilty of lobbying congresspeople will face a fine starting

- 14 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

with \$5,000,000 and increasing by \$25 for every \$1 they lobby.

A Bill to Create Alternative Sentencing for First-Time Drug Offenders

1	BE IT ENACT	TED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	It shall be mandatory that when a person is arrested for a first-time drug offense
3		he or she will be offered a drug rehab program at a drug rehab clinic, instead of
4		potentially being incarcerated.
5	SECTION 2.	A. A first time, non-violent, drug offense will be defined as drug possession
6		without a previous drug possession conviction.
7		B. A drug rehab program at a drug rehab clinic will be defined as a program
8		where a person can receive medication-based and/or other forms of therapy.
9	SECTION 3.	A. The Department of Justice shall be responsible for enforcing the provisions of
10		this bill.
11		B. Funding for this bill will be generated from a 0.08% increase in federal income
12		taxes.
13	SECTION 4.	The provisions of this bill shall take effect January 1, 2021.
14	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to End Civil Asset Forfeiture

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** Civil asset forfeiture shall be banned in the United States.
- 3 **SECTION 2.** "Civil asset forfeiture" shall be defined as the act of a law enforcement agency
- 4 that takes the suspect's assets without a criminal charge.
- 5 **SECTION 3.** A. The Department of Justice shall be responsible for enforcing the provisions of
- 6 this bill.
- B. All law enforcement agencies that do not follow this legislation shall be fined
- 8 proportionately to the assets taken.
- 9 **SECTION 4.** The provisions of this bill shall take effect immediately upon passage.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
