GENERAL RULES FOR MEMBER SCHOOLS PARTICIPATING IN SPEECH AND DEBATE

- 1. The MHSAA Speech and Debate Coordinator has the responsibility for developing the annual calendar.
 - a. Established Tournaments should notify the Coordinator by March 31st to give their preferred date for the following year.
 - b. Schools wishing to add a new tournament may check available dates on April 1st and must request one of those dates by April 30th.
 - c. Out-of-State Tournaments will be added to a list beginning June 1st. Coaches will have the month of June to add tournaments to that list and it will be sent to the MHSAA Director for approval on July 1st.
 - d. **Beginning in 2020-2021**, the approved calendar will be sent out to all schools. Coaches will have until **August 1st** to turn in to the MHSAA Coordinator of Speech & Debate which eight (8) tournaments their school will attend for the MHSAA Season. **(COVID moved this to 2021-2022)**
- 2. Schools inviting or accepting entries from out-of-state schools to their invitational tournaments must Have the approval of the MHSAA Executive Director to do so.
- 3. Coaches are reminded of the importance of the eligibility lists since they determine eligibility for the Catastrophic insurance provided by the association. No coach should travel with a student that is not Approved through the eligibility list with the state office. Beginning in 2019-2020, eligibility lists Will be handled through DragonFly.
- 4. <u>SUPERVISION</u>: The adult supervisor must be the student's coach, a full-time employee of the school District approved by the principal, or the child's own parent.
 - a. The supervising adult must stay at the tournament site with his/her students for the duration of the tournament.
 - Students without an accredited supervisor will not be permitted to participate in the tournament.
 - c. In **LIMITED** situations, a principal may obtain, in advance, permission for a responsible adult to chaperone students. This permission is obtained through the filing of an official request form signed by the principal, the coach, and the Speech and Debate Coordinator who would then determine whether or not the approval is justified.
 - d. All Supervision forms must be sent to the MHSAA more than one full week before the tournament in question.
 - e. If approved, the form would be signed and returned by email to the sponsoring coach. The adult providing supervision must take a copy of the form with them ethical/safe behavior of the students.
- 5. Team coached must accept responsibility for all official communication of the entries, drops, and judge registration.
- 6. A coach and/or members of his/her team will be found in violation of the standards for good Sportsmanship established by the MHSAA if they do any of the following:
 - a. Making degrading/critical remarks about officials, other coaches or competitors during or after a contest; or
 - b. Arguing with officials or going through motions indicating dislike/disdain for a decision; or
 - c. Detaining the official following the contest to request a ruling or explanation of actions taken by the officials; or
 - d. Damaging school property or being in unauthorized locations or not abiding by the school's policies, (i.e. non-smoking campuses).
- The coach, or assigned adult, must monitor the behavior of all individuals connected to his/her school And maintain the ethical, professional behavior of all individuals involved.
 - a. Incidents brought to the attention of the coach or responsible adult, but not corrected, shall result in an official complaint to the MHSAA Executive Director who shall review the situation and assess a minimum fine of \$100 plus all damages if applicable in situations where the coach or responsible adult could have corrected the behavior.

- b. A second infraction shall result in a fine of \$250.00.
- c. A third infraction shall result in the school's suspension from all Speech and Debate competition until the Executive Director deems the correct steps have been taken to guarantee ethical, professional participation.
- 8. The coach must complete an official entry form for each tournament, identifying the school employee or approved individual who will be responsible for all official on-site business connected to the tournament.
- 9. It is the responsibility of the coach of each team to train all judges who accompany their team in the Following categories:
 - a. Event Rules
 - b. Ethical Behavior
 - c. Judge Sign-In Procedures
 - d. Procedure for ballot pickup and return
 - e. Importance for being available for all assignments in the designated areas.
 - f. Time involved in the commitment to serve as a judge, which begins fifteen minutes before the first round and concludes with the end of the final round
 - g. Schools have a responsibility to pay fines for judges not reporting to assigned rounds if they are not in a delayed round (penalty is \$15 per round). The required penalty must be paid before a school can enter another MHSAA Speech and Debate.
- 10. Each participant must follow both the Decency Clause requirement and the Royalty Responsibility Explained in the Speech and Debate State Tournament Rules.
- 11. **Novice Rules:** Novice in speech and Debate competition is defined the following ways:
 - a. **Debate Events:** Students in their first year of competition.
 - b. Platform Events: Students in their first year of competition.
 - c. Students that competed in middle school are still considered a novice competitor during their first year of high school competition if when in middle school the competitor only competed against middle school students.

MHSAA SPEECH & DEBATE INTERNET USAGE RULE CHANGES

(these are for "Tradition" Tournaments. See Virtual Tournament Manual for rules this year)

GUIDELINES for Electronic Device use in Debate Events

- A. Contestants may use electronic devices (including computers, tablets, and/or cell phones) to access the internet during debate rounds with the following conditions:
 - 1. Computers or other electronic devices may not be used to receive information for competitive advantage from non-competitors (coaches, assistant coaches, other students) inside or outside of the room in which the competition occurs, information that would be restricted would include, but not limited to, coach/nonparticipating competitor generated arguments, advice on arguments to run, questions to ask during cross-examination, and other information not generated by the participating competitors.
 - 2. Internet access may be used to retrieve files, exchange evidence and/or Arguments, research arguments, and partner to partner communication.

 These electronic device guidelines do not limit communication between debate Partners during the debate round.
- B. **Penalty:** Contestants found to have violated these provisions will be disqualified from the tournament and will forfeit all rounds and merit points in that event.
- C. Availability of Evidence: Contestants electing to use computers have the Responsibility to promptly provide a copy of any evidence read in a speech for inspections by the judge or opponent. Printers may be used. Evidence may be printed in the round or produced electronically, but must be provided in a format readable by the opposing team and the judge.
- D. Contestants electing to use computers are responsible for providing their own Computers, batteries, extension cords, and all other necessary accessories. Tournament hosts will not be responsible for providing computers, printers, software, paper, or extension cords for contestants. Host schools may provide wireless internet access, but will not guarantee that contestants will be able to gain access when needed.
- E. Contestants choosing to use laptop contestants and/or related devices accept the risk of equipment failure. Judges and/or contest directors will give not special consideration or accommodation, including no additional speech time or prep time, should equipment failure occurs.
- F. By choosing to use electronic devices in the round, debaters and other relevant parties are consenting to give tournament officials the right to search their devices in the event of a protest. The device may only be searched by tournament officials and must be restricted to files and/or electronic exchanges relevant to the protest. Failure to comply would result in upholding of the protest. Debaters and coaches should be present as their device is searched. Debaters who do not wish to consent should not use electronic devices in the round.

GUIDELINES for Electronic Device use in Congressional Debate

The use of internet enabled electronic devices is permitted. Students may not use the internet to gain help from coaches, other students, or any person, such that it would prevent the speech from being the original work of the competitor. Electronic device use must comply with the **Guidelines for Electronic Device Use in Debate Events**.

GUIDELINES for Electronic Use in Extemporaneous Speaking

- A. **Preparation:** As soon as a question is chosen, the contestant will prepare a speech without consultation and without references to prepared notes. Students may consult published books, magazines, newspapers and journals or articles, including internet enabled devices either used in the draw or those materials published from internet sources, provided:
 - 1. They are originals or copies of whole pages.
 - 2. Provided those originals or copies are uncut.
 - 3. There is no written material on that original or copy other than citation Information.
 - 4. Topical index without annotation may be present.
 - 5. Fíles stored either on a computer or electronic device hard drive or cloud storage System. All files in this format must meet the same guidelines as printed Sources.
 - 6. Active research from the internet during the round that meets the established Criteria found in the **Guidelines for Use of Internet Enabled Devices**.
- B. No other material will be allowed in the Extemp prep room other than stated above. Extemp speeches, handbooks, briefs and outlines, including those stored on cloud storage systems or published on website created for that purpose, are prohibited from the Extemp Prep Room. Students may not use the internet to gain help from coaches, other students, or any person, such that it would prevent the speech from being the original work of the competitor. Students are prohibited from accessing outlines and speeches that have been written prior to their draw time. Underlining or highlighting in Extemp will be allowed if done in only one color on each article or copy. Electronic device use must comply with the "quideline for Electronic Device use in Debate Events." Printed copies of information from online computer services may be used. Electronically retrieved evidence in any Association Extemp competition must conform to the same citation standards as evidence used in debate events as described on pg. 27 of the National Speech and Debate Association's unified Manual.

JUDGE TRAINING

PHILOSOPHY

The philosophy of speech competition in Mississippi embraces the encouragement of young people towards speech participation and subsequent refined human communication. Since assigned judges are the intended testing guide, students' future activities are determined by the decision of the judges. Contestants should be served by judges with an open mind that recognizes the high school range of ability and training. The judge is to be knowledgeable in a current perspective for the assigned category, receptive with a constructive and promotional attitude, prepared to present the student with a tactful justification for any rating given, willing to recognize that unfamiliar material may qualify as acceptable subject matter, and informed of current trends in literary writing.

JUDGING ETHICS

- 1. The general rule of ethics is to make all students feel as comfortable as possible when they are competing. The judges who attain that goal are the ones most respected by the students and their speech coaches.
- 2. The judge should set an example for all ethical behavior expected of the students, by showing respect for all participants, being patient with new or confused students who show up late for a round or forget to notify him/her that they are cross-entered, and refraining from derogatory remarks about a participant to other judges, coaches, or students after the round is over.
- 3. The judge should be knowledgeable about the rules for that specific tournament and about the procedures for picking up, filling out, and returning ballots.
- 4. The judge should be on time for the tournament and for each round and should remain in the judges' lounge in order to be available for any judge shifts that might become necessary. They should not observe rounds since they might have to judge those students later.
- 5. They should work with the students who are entered in more than one event, allowing them to participate and leave or enter between speakers. They should remain in the room to wait for the last speaker. If the student comes to the room and finds no one there and it is still in the allotted time for the round, the judge must return and hear the speaker so they are not causing a lack of opportunity for the student.
- 6. Judges should give independent decisions. In elimination rounds when there are three or more judges, each judge must react independently with no consultation.
- 7. If there is no timekeeper, the judge must also be the timekeeper. Extemp, Impromptu, and all the debate must have time prompts. Judges should be familiar with the basics of timekeeping.
- 8. Ballot checks help everyone. Judges should be patient as the Tab Room officials check for completeness and accuracy on the ballots.
- 9. Only the person assigned to judge can judge the round no exchanging of ballots. The Tab Room keeps a careful record of who has judged what event. Independent switches create serious threats to fair and equitable judging.

FILLING OUT THE BALLOT

- 1. The judge's opinions of the contestant's work are so important. The judge is the teacher at that moment. Using the critique sheet as a guide, the judge should let the participant know what the strengths and weaknesses are and why. Suggestions for improvement are also always helpful. A blank critique sheet is a great disappointment for the participant. The judge should provide constructive criticism in a positive manner, while still separating the students by rank and comment to let them know how they compare within the round.
- 2. The judge must assign quality points to all competitors and provide a unique rank for each. The points may tie, but should match the order of the ranks. **Ranks cannot tie.**
- 3. The judge must be accurate in recording comments for the student on the correct sheet and must sign the critique sheet (legibly) so that any confusion can be cleared up quickly.
- 4. Questions concerning time limits or appropriateness should be raised in the Tab Room. If a performance is more than 30 seconds over the specified time limit, the performer may not be given first in the round.

- No other punishment or deduction is specified. Students have decency clauses for interpretation and declamation material, which the Tab Room will pursue for the judge.
- 5. Debate judges have a few more challenges in addition to those already mentioned. They must flow the round, taking accurate notes so they can determine who did the better job at the end of the round. The judge must suspend his/her own opinions while they listen to how the two debaters/teams address each other. Debate topics always have strengths on both sides of the topic. Judges must be open-minded and judge how well the debaters met the assigned the assigned responsibility, and not with their own personal beliefs.
- 6. Policy debate involves a plan that can solve the problem identified. Lincoln-Douglas debate is value debate and depends heavily on a blend of philosophy and pragmatism. Public Forum Debate is generally an event that determined the truth or falseness of a statement.
- 7. Judges often have to keep their own time during debate and should ask about the specifics of timing for that event.
- 8. Other helpful hints:
 - a. Sign the ballot with your name and school code.
 - b. Circle or record the appropriate number of speaker points. You can tie the points, but low-point wins in debate are highly discourage **and only allowed in Lincoln-Douglas**. IF you do give a low-point win you must explain why, in detail, as art of your Reason for Decision.
 - c. Be sure to put the competitors' names and code in the correct place.
 - d. Be prepared to keep prep time during the debate.
 - e. Write appropriate comments that allow the debater to see the effectiveness or weakness of his/her specific arguments or style and to allow the debater to understand the reason for your decision.

MHSAA STATE TOURNAMENT QUALIFYING RULES

PLATFORM EVENTS

- 1. Students will automatically qualify in a specific event for the MHSAA State Championship Tournament by making finals in the previous year's State Tournament.
- 2. Students will automatically qualify in a specific event for the MHSAA State Championship Tournament who place first in that event at a MHSAA affiliated tournament.
- 3. Students may qualify in a specific event who place in the finals (2nd 6th place) and/or semifinals (7th 12th) in that event a combination of two (2) times at a MHSAA-affiliated tournament.
- 4. Students do not have to use the same cutting of a literary work in order to qualify for the MHSAA State Championship Tournament in Interpretation events (including Declamation). If a student changes cutting, they do not have to begin the qualifying process again when using the new piece.
- 5. In the partnered events (Duo Interpretation, Duet Acting) partners must qualify together. If a student changes partners, the new partnership must re-qualify.
- 6. If an individual student qualifies in more than two events in one flight, or more than one debate, that student must choose which 2 events he/she will enter at the MHSAA State Championship Tournament.

DEBATE EVENTS

- 1. In two-person debate events (Policy Debate, Public Forum Debate), partners must qualify as a team. If a student changes partners, the new partnership must re-qualify.
- 2. Competitors automatically qualify by placing in finals or semifinals at a MHSAA-sanctioned event.
- 3. Policy teams or Public Forum Teams, which reach or are named to quarterfinals at a MHSAA-sanctioned tournament on two different occasions, the team will qualify for the MHSAA State Championship Tournament.
- 4. Lincoln-Douglas Debaters who reach or are named quarterfinalists at a MHSAA-sanctioned tournament twice will qualify for the MHSAA State Championship Tournament.
- 5. If an individual student qualified in more than one debate event, he or she will be given the choice of which event he or she will enter.

DESIGNATED WILD CARD ENTRIES

Any MHSAA Member School may have a total of five (5) entries in the MHSAA State Championship Tournament that have not been qualified according to any of the above requirements. At the sole discretion of the school's coach(es), the five (5) entries bay be divided among as many as five (5) students or one (1) student may use four (4) entries with another student using one. These entries are designated as Wild Card Entries.

SWEEPSTAKES SCALE

The top three (3) teams at the MHSAA State Championship Tournament, as well as the top three (3) teams in Debate Events and the top three (3) teams in Speech Events, will be determined by the system of team sweepstakes points outlined below. The team accumulating the most points from their top 25 entries will be declared the MHSAA Speech and Debate State Championship Team. This rule is for the state championship only. Appropriate trophies will be awarded to the three (3) teams overall, as well as the top three (3) in Debate and the top three (3) teams in Speech.

TIES

Counting the number of First Places each team has earned will break ties; a tie will be broken in favor of the team with the greater number of First Places. If the teams have an equal number of First Places, then the number of Second Places will be counted and used as a tiebreaker. Placings through Sixth Place will be used in turn as tiebreakers. If the teams remain tied after counting all of the first through sixth places that each team has earned, the tie shall be declared unbreakable, and two trophies shall be awarded.

EVENT DESCRIPTIONS

DEBATE EVENTS

CONGRESSIONAL DEBATE

- Schools may pre-register 1-6 entries in the events. Students entering Congressional Debate may only enter one (1) Flight A Events and two (2) Flight B Events.
- No substitutions will be made in Congressional Debate. If a student does not show up or chooses not to compete, the school will lose that seat.
- Laptop computers and tablet devices may be used by delegates, but may not be used to receive information for competitive advantage from non-competitors (coaches, assistant coaches, teammates, other students, etc.) inside or outside of the room in which the competition occurs.
- Each preliminary room will have 20 or less competitors. The total number advancing to the final Super Sessions will be determined by the number of preliminary chambers established.
- Bill Books will not be supplied to delegates once they arrive on our campus. You are responsible for having your own
 copies.

LINCOLN-DOUGLAS DEBATE (VARSITY AND NOVICE DIVISIONS)

- Debates in this division will follow the standard 6-3-7-3-4-6-3 format.
- Each debater has four minutes of prep time to use as they wish.
- Five preliminary rounds will determine breaks to elimination rounds. Rounds 4 and 5 will be power-matched based on earlier preliminary record.
- Due to the truncated format of our debate rounds, we ask that NO DISCLOSURES are given during the rounds. While we appreciate the need for them, the tight schedule does not provide enough time for them.
- A novice debater is a competitor in their first year of competition in ANY event. If a student competed in middle school, but did not compete in debate events on that level, they may be considered novice during their first high school season.
- Laptop computers and tablet devices may be used by delegates, but may not be used to receive information for
 competitive advantage from non-competitors (coaches, assistant coaches, teammates, other students, etc.) inside or
 outside of the room in which the competition occurs.

POLICY DEBATE

- Four preliminary rounds will determine breaks to elimination rounds. This also depends on the number of entries and pace of the tournament.
- The debate will follow the standard 8-3-8-3-8-3-5-5-5 format with open or closed cross-examination dependent on judge preference.
- Each team will have five minutes of prep time to use as they wish.
- Due to the truncated format of our debate rounds, we ask that NO DISCLOSURES are given during the rounds. While we appreciate the need for them, the tight schedule does not provide enough time for them.
- Laptop computers and tablet devices may be used by delegates, but may not be used to receive information for
 competitive advantage from non-competitors (coaches, assistant coaches, teammates, other students, etc.) inside or
 outside of the room in which the competition occurs.

PUBLIC FORUM DEBATE (VARSITY AND NOVICE DIVISIONS)

- The debate will follow the 4-4-3-4-4-3-3-4-3-2-2 format.
- Each team will have 3 minutes of prep time to use as they wish. We will respect the NSDA pilot of 1 additional minute of prep.
- Five preliminary rounds will determine breaks to elimination rounds. Rounds 4 and 5 will be power-matched based on earlier preliminary record.
- Due to the truncated format of our debate rounds, we ask that NO DISCLOSURES are given during the rounds. While we appreciate the need for them, the tight schedule does not provide enough time for them.
- A novice debater is a competitor in their first year of competition in ANY event. If a student competed in middle school, but did not compete in debate events on that level, they may be considered novice during their first high school season. For a team to enter the novice division, both speakers must be in their novice year.

Laptop computers and tablet devices may be used by delegates, but may not be used to receive information for
competitive advantage from non-competitors (coaches, assistant coaches, teammates, other students, etc.) inside or
outside of the room in which the competition occurs.

INDIVIDUAL EVENTS

- ALL INTERPRETATION AND DECLAMATION PIECES MUST HAVE A SIGNED DECENCY CLAUSE.
- IN ALL INTERPRETATION AND DECLAMATION PIECES AN INTRODUCTION SHOULD BE GIVEN AND IS PART OF THE COMPETITOR'S TOTAL TIME.
- NOVICE RULE NOVICES ARE STUDENTS IN THEIR FIRST YEAR OF HIGH SCHOOL COMPETITION. If a former middle school competitor competed in high school divisions, they are not a novice competitor.

FLIGHT A EVENTS

ORIGINAL ORATORY

- The oration shall require no more than ten minutes. There is a 30-second grace period. Students who exceed the time limit by more than 30 seconds should not be given first in the panel. There is no official minimum time limit.
- The oration may be on any appropriate subject and must be the original work of the student with no more than 150 words of the oration used as a direct quotation from another speech or writing.
- An original copy of the Oratory must be present at the tournament for verification purposes. The copy should include a current bibliography of all sources used. The copy may be digital as long as it is easily accessible.
- The performance must be memorized.

DRAMATIC INTERPRETATION

- The selection shall require no more than ten minutes. There is a 30-second grace period. Students who exceed the time limit by more than 30 seconds should not be given first place in the panel. There is no official minimum time limit.
- The selection should be a cutting from a published work such as a novel, short story, play, or poetry. Recorded material that is not printed and published is prohibited. Monologues are acceptable. The original source of the piece must be a present and a digital copy of the cutting should be available at the tournament for verification purposes.
- The selection should be serious in tone
- The selections must be memorized. Students are free to move, but should remember that this is a contest in interpretation, and not in solo acting.

PROSE INTERPRETATION (VARSITY AND NOVICE DIVISIONS)

- The selection shall require no more than ten minutes. There is a 30-second grace period. Students who exceed the time limit by more than 30 seconds should not be given first place in the panel. There is no official time limit.
- Prose includes fiction (short stories, novels) and non-fiction (articles, essays, journals, and biographies).
- A manuscript is required. The use of the manuscript as a prop is allowed.
- Eye contact with the audience during the performance should at least be at a 50/50 ratio.
- The selection must come from a single published source. The original source of the piece must be present and a digital copy of the cutting should be available at the tournament for verification purposes.
- The performer should remain in one place with motion limited to the waist up.

DUET ACTING

- Selections shall be cuttings from a single source such as a single novel, short story, play, poem, or screenplay. No contestant may use the same literary that he or she used in previous competitive seasons.
- The material may be humorous, dramatic, or a combination of the two.
- Each performer may play one or more characters so long as the performance responsibility in the cutting remains as balanced as possible.
- The selection shall require no more than ten minutes. There is a 30-second grace period. Students who exceed the time limit by more than 30 seconds should not be given first place in the panel. There is no official time limit.
- The interpretation must be delivered from memory; no notes, prompting or scripts shall be permitted. No costumes or props shall be permitted. During the performance, on-stage focus (meaning contestants MAY look directly at each

- other) may and/or should be employed by both contestants. Contestants are encouraged to touch and make eye contact during any part of the performance.
- Two chairs will be allowed for use as props or to facilitate blocking and to create levels, atmosphere, and environment.

PROGRAM OF ORAL INTERPRETATION

- Competitors may mix selections from prose, poetry, and drama together to create one theme. The competitor must use at least 2 of the 3 literature types. The delivery of the entire program must be delivered from a manuscript.
- The selection shall require no more than ten minutes. There is a 30-second grace period. Students who exceed the time limit by more than 30 seconds should not be given first place in the panel. There is no official time limit.
- Movement during the performance is allowed. The manuscript may be used as a prop during the performance.
- The focus of the event is to develop a theme or argument through the use of narrative, story, and/or characterization.

IMPROMPTU SPEAKING

- The total time given to each speaker shall not exceed seven (7) minutes. There is a 30-second grace period. Students who exceed the time limit by more than 30 seconds should not be given first place in the panel. Participants will use this time for both preparation and delivery. The time begins immediately after the student selects his/her topic.
- Students may take notes during their preparation but may not have their notes with them during the delivery of the
 speech.
- The judge will show the student three topic choices from which the student will select one which he/she will prepare and deliver the speech within the allotted seven-minute time period.
- Once a participant sees the topic he/she must remain in the room and may not converse with any other individual until his/her presentation is completed.
- The tournament director will prepare topics which are varied. They may come from such areas as objects, holidays, aphorisms, abstract nouns, famous people, fictional people, or any other thematic group that is appropriate for high school competition. Participants are encouraged to relate to the topic by adapting it to a thesis.

EXPOSITORY SPEAKING

- The speech must be an original compositions of the contestant designed to inform, not to entertain primarily. A copy
 of the speech must be present at the tournament for verification purposes.
- The speech should describe, clarify, illustrate, or define an object, idea, concept or process. It should not be persuasive.
- A fabricated topic/subject may not be used.
- A student may not use any portion of his/her Original Oratory or Informative Speaking speeches in this event.
- The maximum time of this event is five (5) minutes. There is no minimum time limit. There is a 30-second grace period. Students who exceed the time limit by more than thirty seconds should not be given first place in the round.
- No note cards, audio aid, or visual aids are allowed. No animal or other person(s) may be used as aids or aides. Items of dress put on and removed during the course of the presentation are considered visual aids and may not be part of the contestant's presentation

FLIGHT B EVENTS

EXTEMPORANEOUS SPEAKING (VARSITY AND NOVICE DIVISIONS)

- The tournament director will prepare a list of topics on current foreign and domestic issues. The student will draw three questions and return two before he/she begins his/her preparation period.
- The student will have thirty minutes of time to prepare his/her speech. There is a 30-second grace period. Students who exceed the time limit by more than 30 seconds should not be given first place in a panel.
- The student may use one note card with a maximum of fifty words on it.
- The student is responsible for providing his/her own extemp file, which may include published books, magazines, newspapers, and journals or articles from those sources, provided they are intact originals or copies of the originals and that there is no written material on the original or the copy. The student may prepare a topical index without annotation for his/her use.
- Extemporaneous Speaking files will be inspected by tournament staff at some point before or during competition.

Laptop computers and tablet devices may be used by delegates, but may not be used to receive information for
competitive advantage from non-competitors (coaches, assistant coaches, teammates, other students, etc.) inside or
outside of the room in which the competition occurs.

DECLAMATION

- The selection has a maximum time of ten minutes. It must be memorized. There is a 30-second grace period. Students who exceed the time limit by more than 30 seconds should not be given first place in the panel.
- A selection in Declamation must have been originally delivered as a speech by its author, a person other than the present speaker.
- The event is only open to 9th and 10th grade students.
- The speaker should convey the original author's message in a sincere, honest and realistic manner. Attempts at dramatization rather than communication should be avoided.
- A copy of the Declamation must be present at the tournament for verification purposes.

DUO INTERPRETATION

- The selection shall require no more than ten (10) minutes. There is a 30-second grace period. Students who exceed the time limit by more than thirty seconds should not be given first place in the round.
- The selection shall be a cutting from a single published work of literature. Recorded material that is not published is not acceptable. Lines which are attributed to a character in the published material may not be attributed to another character in the performance. The original of the piece must be present at the tournament for verification purposes.
- Participants will establish focus for the other character, but except for during the introduction, eye contact is not allowed.
- The selection must be memorized.
- The two performers may play one or more characters as long as the performance of the two competitors remains as balanced as possible.
- Participants should react to each other's verbal and nonverbal expressions, but they may not touch each other.
 Touching during introduction is allowed, however.

POETRY INTERPRETATION (VARSITY AND NOVICE DIVISIONS)

- The selection shall require no more than ten (10) minutes. There is a 30-second grace period. Students who exceed the time limit by more than thirty seconds should not be given first place in the round.
- A performer may use single poem, or a program of multiple poems centered around a theme. Appropriate transitional material is required and is a part of the ten-minute time limit.
- A manuscript is required. Use of the manuscript as a prop is allowed.
- The poetry must come from a published source or sources which must be accessible at the tournament for verification purposes.
- Eye contact with the audience during the performance should at least be at a 50/50 ratio.
- The performer should remain in one place with motion limited to the waist up.

HUMOROUS INTERPRETATION

- The selection shall require no more than ten minutes. There is a 30-second grace period. Students who exceed the time limit by more than thirty seconds should not be given first place in the panel.
- The selection shall be a cutting from a published work such as a novel, short story, play, or poetry. Recorded material that is not printed and published is prohibited. Monologues are acceptable. The original source of the piece must be present at the tournament for verification purposes.
- The selection must be memorized. Students may move in any direction, but should remember that this is a contest in interpretation, not in solo acting.
- The performance should be funny. Otherwise, what is the point?

INFORMATIVE SPEAKING

- Speeches in informative generally have some combination of problems, causes, and implications (or what your topic means to society as a whole.
- A visual aid is allowed and preferred. It may not be digital or involve electricity.
- The speech must be an original compositions of the contestant designed to inform, not to entertain primarily. A copy
 of the speech must be present at the tournament for verification purposes.
- The speech should describe, clarify, illustrate, or define an object, idea, concept or process. It should not be persuasive.
- A fabricated topic/subject may not be used.
- A student may not use any portion of his/her Original Oratory or Expository Speaking speeches in this event.
- The maximum time of this event is ten (10) minutes. There is no minimum time limit. There is a 30-second grace period. Students who exceed the time limit by more than thirty seconds should not be given first place in the round.
- No animal or other person(s) may be used as aids or aides. Items of dress put on and removed during the course of the presentation are considered visual aids and may not be part of the contestant's presentation
- The speech should be memorized.

STORYTELLING

- A single published story, anecdote, tale, myth, or legend must be retold without notes or props. A copy of the source should be present at the tournament for verification purposes.
- The student may not tell a story used previously by him/her in any forensics tournament.
- The deliver should be extemporaneous, not read. Memorization is not required.
- •—No book or script may be used during the presentation.
- The contestant may not add original material and may not change the original intent of the story.
- The maximum time is five (5) minutes, but the story may be more brief without penalty. There is a 30-second grace period. Students who exceed the time limit by more than thirty seconds should not be given first place in the round.
- An introduction must be included within the five minute time limit.
- The 2019 Storytelling Topic is: FRIGHT NIGHT Scare me if you can!
