The Public Option Act of 2021

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 SECTION 1:	The U.S. government will hereby create a public option healthcare system.		
2 SECTION 2:	The public option healthcare system is defined as a proposal to create a government-run		
3	health insurance agency that would compete with other private health insurance		
4	companies within the United States. This healthcare plan would be subsidized by the		
5	Department of Health and Human Services based on the same income levels used by the		
6	Affordable Care Act. Any US citizen may purchase this insurance regardless of employer		
7	provided insurance.		
8 SECTION 3:	The Department of Health and Human Services in conjunction with the Department of		
9	Commerce will oversee the implementation of this legislation.		
10	A. The Centers for Medicare & Medicaid Services within the Department of Health and		
11	Human Services will work to establish and insurance plan as well as making it available to		
12	the general population of the United States.		
13	B. The Department of Health and Human Services and the Department of Commerce have		
14	the authority to work with any other agency in order to implement and enforce this		
15	legislation.		
16	C. A yearly allocation of 100 billion dollars per fiscal year from 2021 to 2030 for program		
17	funding. After 2030, the Congressional Budget Office shall issue a revised budged estimate		
18	for the public option plan. Congress will be encouraged to act with appropriate legislation		
19	at that time to amend the funding levels.		
20	D. All funding shall be provided from the Department of Health and Human Services		
21	budget.		
22 SECTION 4: his legislation will go into effect on the first day of the 2021 Fiscal Year.

A Bill Make Vasectomies More Accessible

1. **Section One:** The Affordable Care Act will cover vasectomies under Preventative Health

2. Services.

3. **Section Two:** The Affordable Care Act shall be defined as the comprehensive health care

4. reform law enacted in March 2010 (sometimes known as ACA, PPACA, or

5. "Obamacare". The law provides numerous rights and protections that make health

6. coverage more fair and easy to understand, along with subsidies (through "premium tax

7. credits" and "cost-sharing reductions") to make it more affordable. Vasectomy shall be

8. defined as a surgical procedure designed to make a man sterile by cutting or blocking

9. both the right and left vas deferens, the tubes through which sperm pass into the

10. ejaculate.

11. **Section Three:** Providing accessible vasectomies:

12. A. The Center for Consumer Information and Insurance Oversight (CCIIO) will

13. oversee the enforcement of this bill and any insurance providers who will not fully cover

14. a patient's vasectomy will be subject to a \$6000 fine.

15. B. This bill will reallocate \$100 million of the Affordable Care Act budget for the

16. insurance coverage of vasectomies.

17. **Section Four:** This bill will go into effect on October 1st, 2021

A Bill to Grant Public Safety Workers the Right to Collective Bargaining

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **SECTION 1**. Any individual who is currently employed in the public safety sector will have 3 increased access to collective bargaining. This will include the following policies:
- 4 A. The ability to both create and join labor unions.
- 5 B. The ability to use such unions to bargain over terms of employment, wages, and hours.
- 6 C. Assurance that public safety employers will recognize the labor unions and will bargain
- 7 with the organization, resulting in a written contract.
- 8 D. Should there be a dispute between the labor unions and the public safety employer, a
- 9 method of dispute resolution, either through arbitration or mediation, will be assigned
- to the case.
- 11 **SECTION 2**. A public safety employee will be defined as any law enforcement officer,
- 12 member of emergency medical personnel, or firefighter.
- 13 **SECTION 3**. The Federal Labor Relations Authority will oversee the enforcement of this 14 legislation.
- 15 A. The Federal Labor Relations Authority will determine adequate labor representation
- when supervising elections.
- B. The Authority will conduct hearings and resolve complaints of unfair labor tactics, as
- 18 reported by the labor unions.
- 18 **SECTION 4.** This legislation shall go into effect immediately upon passage.
- 19 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Institute a Sugar Tax

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** A tax will be implemented on all beverages containing 5 or more grams of sugar 3 per 100 milliliters.
- 4 **SECTION 2.** The following definitions will apply:
- 5 A. A sugar tax will be defined as \$.25 per liter of beverage containing sugar.
- B. The revenue from the tax will be allocated to address obesity, diabetes, and related
- 7 health conditions.
- 8 **SECTION 3**. The Food and Drug Administration and the Internal Revenue Service will oversee 9 the enforcement of this legislation.
- 10 **SECTION 4**. This legislation shall go into effect immediately upon passage.
- 11 **SECTION 5**. All laws in conflict with this legislation are hereby declared null and void.

The Student Loan Simplification Act of 2020

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **SECTION 1**. All student loans provided by the United States federal government after
- 3 the passage of this legislation shall have an interest rate of 0%.
- 4 (A) "Student loans" are defined as any loan designed to help students pay for
- 5 post-secondary education and the associated fees, such as tuition, books
- 6 and supplies, and living expenses.
- 7 **SECTION 2.** This legislation shall be enforced by the Department of Education.
- 8 **SECTION 3**. This legislation shall go into effect immediately upon passage.

The Animal Right to Life Act

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **SECTION 1.** No animal shelter may euthanize more than 10% of the animals that it 3 accepts into its shelter.
- 4 (A) An "Animal Shelter" is a facility that houses and disposes of homeless,
- 5 lost, or abandoned animals.
- 6 **SECTION 2.** The United States federal government shall provide subsidies to qualified 7 applicant animal shelters for the purpose of expanding physical space and 8 services for the animals they serve.
- (A) A newly-created commission will be tasked with determining
 qualifications for and recipients of these subsidies.
- 11 **SECTION 3.** This legislation shall be enforced by the Department of Agriculture.
- 12 **SECTION 4.** This legislation shall go into effect on July 1, 2021.

2 SECTION 1	1. The Department of Education shall make \$2 billion in grants available for
3	states which either currently offer or will commit to the use of bilingual
4	education programs to educate all students not currently proficient in
5	spoken English.
6 SECTION 2	2. Bilingual education programs are those which provide instruction in
7	English as well as the students' spoken languages. This method is used to
8	develop student literacy in both languages.
9 SECTION 3	3. The Department of Education shall administer the grant program. Grants
10	shall be awarded upon demonstrated proof that the state has adopted
11	bilingual education programs as a primary means of English proficiency
12	instruction. Grants may be renewed if the state is able to demonstrate
13	growth on state-based English proficiency assessments. Funding shall be
14	taken from existing Title 1 funding.
15 SECTION	4. This shall take effect on July 1, 2021.

A Resolution to Adopt a National Happiness Index

- 1 **WHEREAS**. The dichotomous nature of monetary value prevents governments from
- 2 adequately assessing both the stability and overall happiness of individuals within a country by
- 3 using Gross Domestic Product (GDP); and
- 4 WHEREAS, The depression rate for American adults in 2019 was approximately 7% and
- 5 while average income has increased dramatically since the early 1900s, levels of happiness
- 6 have remained close to static; and
- 7 WHEREAS, Without adjusting to an index that accurately portrays the status of a population,
- 8 the U.S. risks further psychological deterioration of American citizens under the veil of a
- 9 successful economy; and
- 10 WHEREAS, Surveying individuals for the Happiness Index would provide vital information
- 11 about the mental health of Americans and incentivize the prioritization of mental health-care in
- 12 the future, as it would impact a nation's international ranking, be it
- 13 **RESOLVED**, That the Congress here assembled make the following recommendation to adopt
- 14 the Happiness Index as an additional mechanism to measure national success.

A Resolution to Ban Sororities & Fraternities at Colleges & Universities

1	WHEREAS,	A lack of accountability has allowed sororities and fraternities to cause
2		significant harm to student bodies through hazing practices, while also
3		providing minimal responses to instances of sexual assault and racism; and
4	WHEREAS,	Approximately 55% of students involved in organizations report they have
5		experienced hazing and, to date, there have been over 100 hazing-related
6		deaths, and studies conclude that fraternal parties are especially
7		dangerous for women, as members of fraternities are found to be 3 times
8		more likely to commit sexual assault than a male not in a fraternity; and
9	WHEREAS,	The structure of sorority and fraternity life prevents victims from reporting
10		out of fear of retaliation from the organization, as individuals in leadership
11		positions tend to be relatively influential and have significant power on
12		college and university campuses; and
13	WHEREAS,	Private funding from donors and claims from colleges and universities
14		stating that they do not have control over the actions of individual
15		organizations prevents any level of external accountability, meaning
16		administrative reform to sororities and fraternities is nearly impossible;
17		now, therefore, be it
18	RESOLVED,	That the Congress here assembled make the following recommendation to
19		eliminate sororities and fraternities at colleges and universities.
