Hello from the inside, Class A Coaches! It doesn't feel like that long ago that I sent an invitation to all the Class A schools in Montana for a Whitefish tournament... or maybe it feels like centuries ago? For those of you who live some 50-some hours away from me, you'll be glad to know that this time no bus rides are required, as I am excited to be hosting the first Class A Virtual Tournament on December 4-5, 2020 to kickoff this unprecedented season. Please read the following carefully, as it includes some new information about the running of tournaments "in the cloud".

This year, we will be using a Tournament Manager to run the registration, tech, day-of tournament directing, and tab room management. JW McClintic will serve this role for Class A. You may forward questions regarding these issues or others to him or through me.

From Dubbz:

The inaugural tournament for Montana A Speech and Debate will be held on December 4th and 5th via NSDA Campus and Tabroom.com. The cost per student entered will be \$5 dollars which includes the room fee for NSDA Campus. All entries (including adds and drops) must be finalized by Monday, November 30th at 11:59 PM. Students cannot be added once the deadline has passed. Also, you will still be charged for any students dropped after this point because rooms for the tournament will be purchased based on your entry as of 11:59 PM on November 30th. This year, teams will be asked to provide judges in order to cover your entries. You may assign multiple people to cover one judge, but you must have a person available to cover every round that judge owes. All judge entries must be submitted via Tabroom by no later than Tuesday, December 1st at 4 PM(the registration deadline). All coaches, judges, and competitors will need a tabroom.com account.

Also, tab staff will be selected from participating schools by the Tournament Manager. If you have preference for assignments, please email Dubbz at jw.mcclintic@gmail.com. I will get assignments out a few days before so coaches know their assignments.
